- (1) To qualify for professional installation, the applicant must explain why the hardware is not readily available to average consumer.
- A: The hardware is a non-standard product, and users can only purchase it from authorized dealers.
 - (2) Marketing—Device cannot be sold via retail to the general public or by mail order; it must be sold to authorized dealers or installers only.
- A: We only sell our products to authorized dealers and do not sell them to general public through retail and mail order channels.
- (3) Filing must show that intended use is not for consumers and general public; rather device is generally for industrial/commercial use.
- A: The products are intended for installation in equipment for industrial use and are not intended for use by ordinary consumers.
- (4) Explain what is unique, sophisticated, complex, or specialized about the equipment that REQUIRES it to be installed by a professional installer?
- A: The product contains complex hardware, wiring harnesses, and calibration processes, and non professionals are unable to complete installation and calibration properly.
- iv) Other professional installation requirements.

 - A: The dealer will send professionals to the user to install and debug the equipment.
 - (2) Installed by licensed professionals (e.g., device sold to dealer who hire installers).
