Leaped up to 133 MH2 (MX1290) / 62.5 MH2 (MX1290V2), while the SoC integration with internal 256 KB SRAM, 512 KB ROM, it also contains UART, I2C, PWM, SPI and abundant peripheral interface, only need to provide the DC voltage of 3.3 V, a 40 MHZ crystals and Flash can work outside. FCC Certification Requirements.
