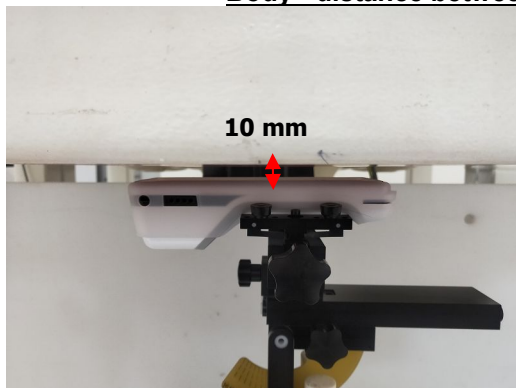

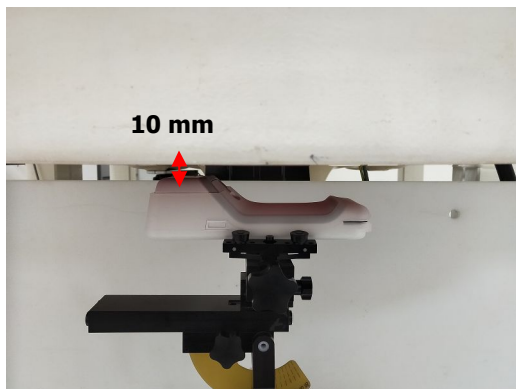

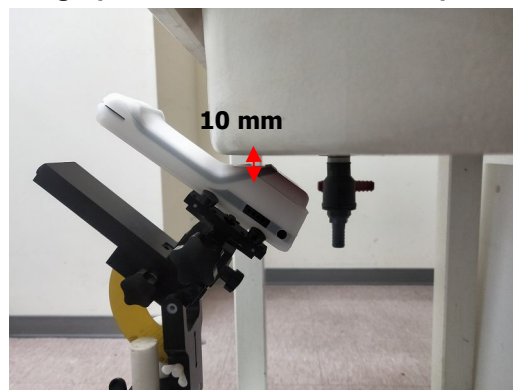
Photograph 3. EUT Back side to flat phantom

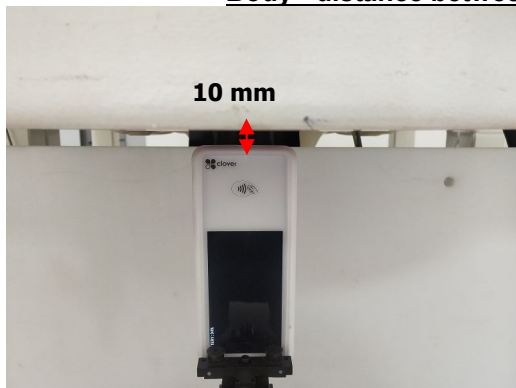


Photograph 6. EUT Back (curve) side to flat phantom

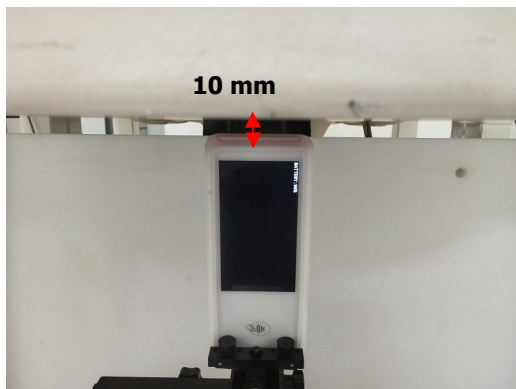

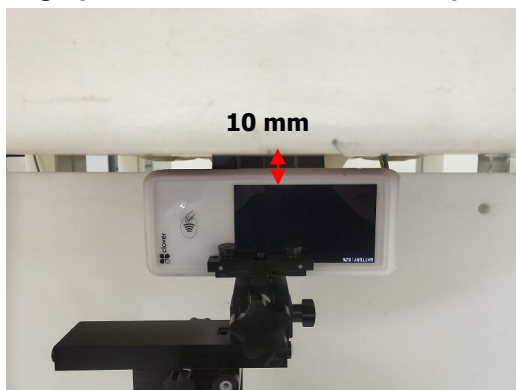

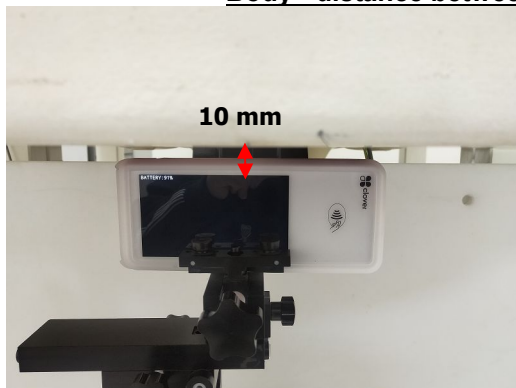


Photograph 12. EUT Right side to flat phantom

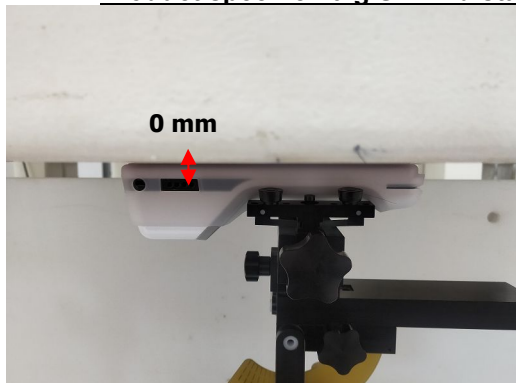

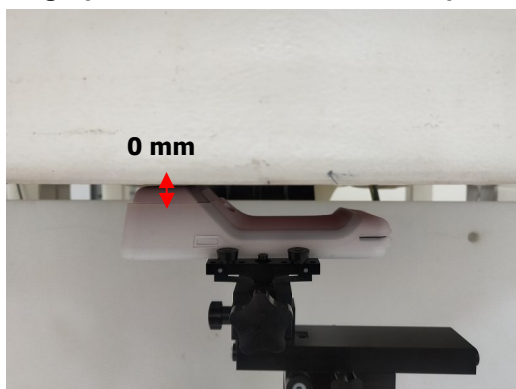

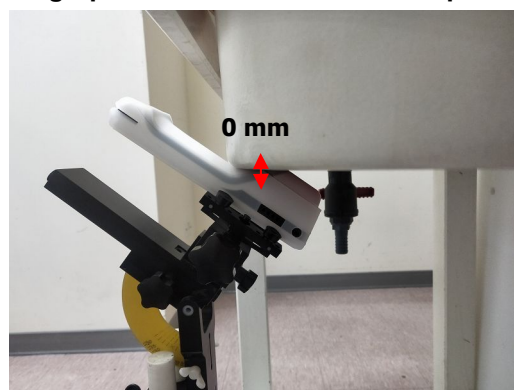
Photograph 17. EUT Back side to flat phantom

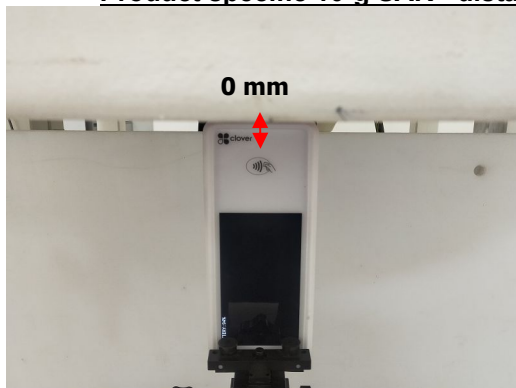


Photograph 20. EUT Back (curve) side to flat phantom

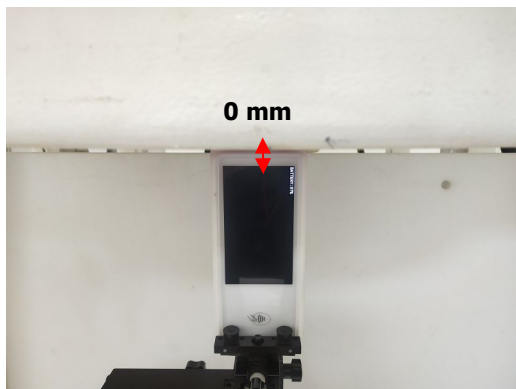

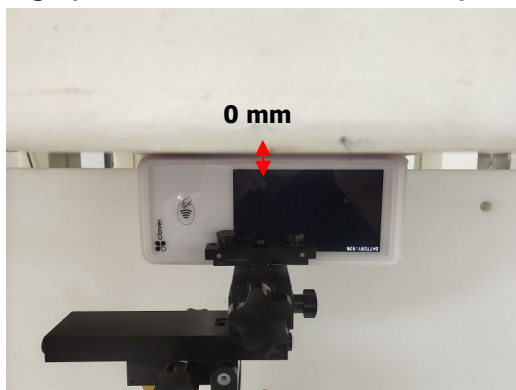

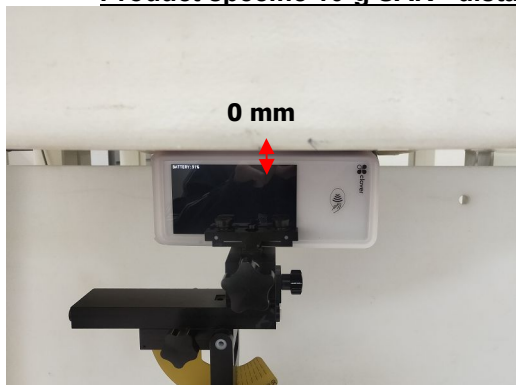


Photograph 26. EUT Right side to flat phantom

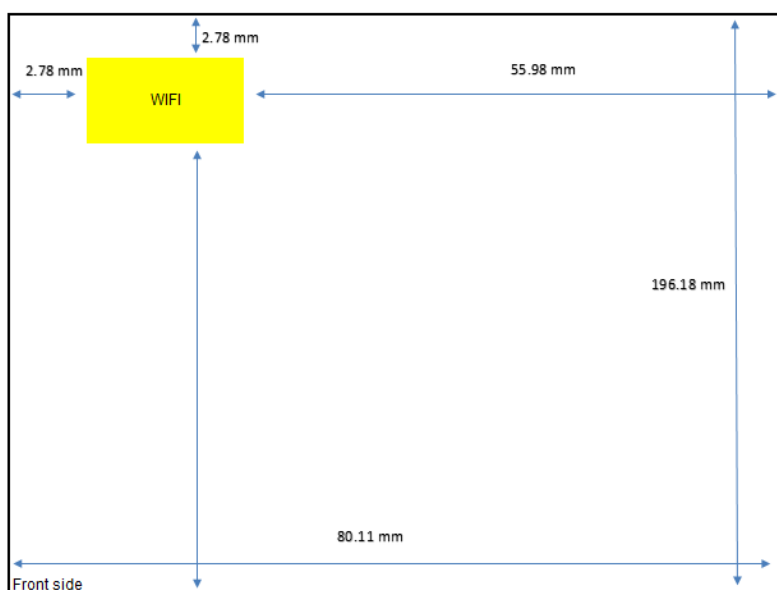
