1 MPE EVALUATION OF MOBILE DEVICES

MPE Evaluation of Simultaneous Transmission

2.4 and 5GHz can transmit at the same time, MPE evaluation is as below formula

PD1 / Limit1 + PD2 / Limit 2 + < 1, PD = Power density

Non-beamforming mode

MPE Evaluation = Maximum MPE of 2.4GHz + Maximum MPE of 5 GHz = 0.194 / 1 + 0.087 / 1 = 0.281 < 1

Beamforming mode

MPE Evaluation = Maximum MPE of 2.4GHz + Maximum MPE of 5 GHz = 0.194 / 1 + 0.295 / 1 = 0.489 < 1

MPE evaluations of single and simultaneous transmission meet the requirement of standard.
