



## 4. TEST CONDITIONS AND RESULTS

#### 4.1. AC Power Conducted Emission

## **TEST CONFIGURATION**



#### **TEST PROCEDURE**

- 1 The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. The EUT is a tabletop system, a wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.10-2020.
- 2 Support equipment, if needed, was placed as per ANSI C63.10-2020
- 3 All I/O cables were positioned to simulate typical actual usage as per ANSI C63.10-2020
- 4 All support equipments received AC power from a second LISN, if any.
- 5 The EUT test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.
- 6 Analyzer / Receiver scanned from 150 KHz to 30MHz for emissions in each of the test modes.
- 7 During the above scans, the emissions were maximized by cable manipulation.






Frequency range 9 KHz - 30MHz

#### **TEST PROCEDURE**

- 1. The EUT was placed on a turn table which is 0.8m above ground plane when testing frequency range 9 KHz –1GHz;the EUT was placed on a turn table which is 1.5m above ground plane when testing frequency range 1GHz 25GHz.
- 2. Maximum procedure was performed by raising the receiving antenna from 1m to 4m and rotating the turn table from 0°C to 360°C to acquire the highest emissions from EUT.
- 3. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
- 4. Repeat above procedures until all frequency measurements have been completed.
- 5. Radiated emission test frequency band from 30MHz to 25GHz.
- 6. The distance between test antenna and EUT as following table states:

The field strength is calculated by adding the Antenna Factor and Cable Factor and subtracting the Amplifier Gain and Duty Cycle Correction Factor(if any) from the measured reading. The basic equation with a sample calculation is as follows:

#### **RADIATION LIMIT**

For intentional device, according to § 15.209(a), the general requirement of field strength of radiated emission from intentional radiators at a distance of 3 meters shall not exceed the following table. According to § 15.247(d), in any 100kHz bandwidth outside the frequency band in which the EUT is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the100kHz bandwidth within the band that contains the highest level of desired power.

However, the peak field strength of any emission shall not exceed the maximum permitted average limits specified above by more than 20 dB under any condition of modulation. For point-to-point operation under paragraph (b) of this section, the peak field strength shall not exceed 2500 millivolts/meter at 3 meters along the antenna azimuth

The field strength limits shall be measured using an average detector, except for the fundamental emission in the frequency band 902-928 MHz, which is based on measurements using an International Special Committee on Radio Interference (CISPR) quasi-peak detector.







- 2). Radiated emissions measured in frequency range from 9 KHz~10<sup>th</sup> harmonic or 26.5GHz (which is less) were made with an instrument using Peak detector mode.

Detector function = peak

Trace = max hold






## 4.4. Band Edge Compliance of RF Emission

#### **TEST REQUIREMENT**

Emissions radiated outside of the specified frequency bands, except for harmonics, shall be attenuated by at least 50 dB below the level of the fundamental or to the general radiated emission limits in Section 15.209, whichever is the lesser attenuation.

#### **TEST CONFIGURATION**



#### **TEST PROCEDURE**

The EUT is placed on a turntable, which is 0.8m above the ground plane. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.

EUT is set 3m away from the receiving antenna, which is varied from 1m to 4m to find out the highest emission. Set the spectrum analyzer in the following setting in order to capture the lower and upper bandedges of the emission:

Peak: RBW=120MHz, RBW=300MHz / Sweep=AUTO

Repeat the procedures until the peak versus polarization are measured.

#### **LIMIT**

Below -20dB of the highest emission level in operating band.

Radiated emissions which fall in the restricted bands, as defined in § 15.205(a), must also comply with the radiated emission limits specified in § 15.209(a)


