
Operation manual

1. Three are four buttons on the controller. Please see below diagram:



- 2. Push the forward button to drive the vehicle forward. Release to stop.
- 3. Push the Backward to drive the vehicle backward. Release to stop.
- 4. Push the Left and Forward buttons to drive the vehicle turns left forward.
- 5. Push the Right and Forward buttons to drive the vehicle turns right forward.
- 6. Push the Left and Backward buttons to drive the vehicle turns left backward.
- 7. Push the Right and Backward buttons to drive the vehicle turns right backward.
- 8. Release to stop the vehicle.
