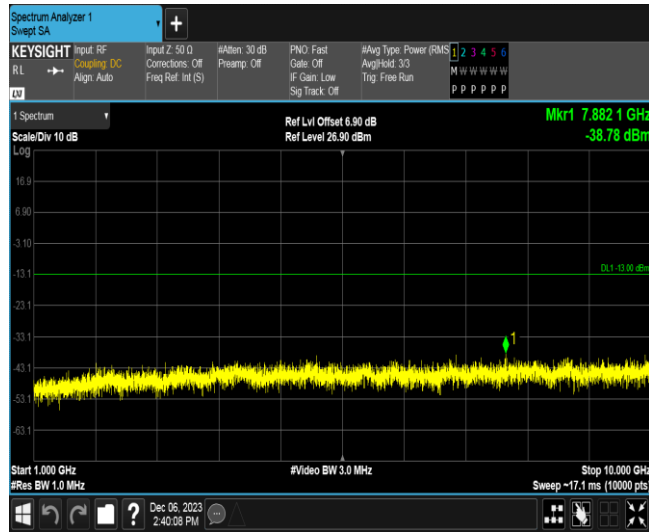

Band26-1.4MHz-16QAM-26797-1RB#0-Range1:30~1000MHz

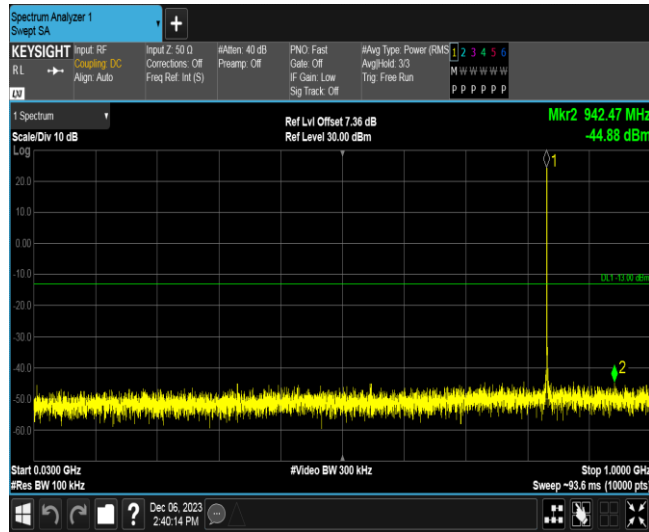


Band26-1.4MHz-16QAM-26797-1RB#0-Range2:1000~10000MHz

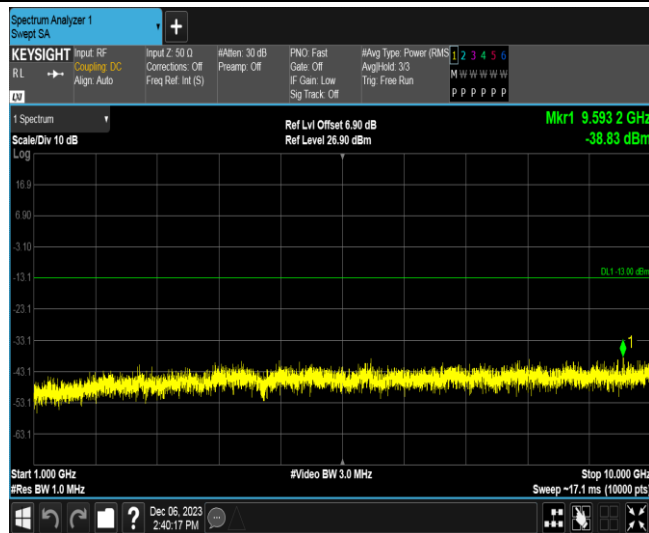
