

Charging the built-in rechargeable battery for the RC boat: (Refer to 1).

- Open the charging port cover on the boat.
- 2. Locate a USB certified port from any of the devices shows below.
- Plug in the USB charging plug to boat and USB certified port.
- 4. The LED indicator will start lighting in red to show it is charging.
- 5. Once the LED indicator turns off, the boat is fully charged.
- 6. Take out the USB plug from boat and USB certified port, then install the charging port cover on the boat.

Battery installation for the controller: (Refer to Diagram 2)

- Switch the power OFF.
- 2. Use screwdriver to loosen the screw on the battery cover and to open the battery cover. (Screwdriver is not included)
- 3. Install 2 new 1.5V "AA" LR6/R6 battery with correct polarity (+/-) as shown inside the battery compartment.
- 4. Install the battery cover and then tighten the screw on the battery cover.

How to play: (Refer to 3, 4 & 5)

- 1. Place the boat on water. The propeller only works when the boat is on water.
- 2. Set the "Power Switch" on the controller to ON position, the "Power LED" on both the controller and boat will flash less than 3 seconds then stay on, meaning the automatic frequency matching between the controller and the boat is completed.
- 3. If the "Power LED" of the controller or the "Power LED" of the boat flash more than 3 seconds, take up the boat from water and put it back again, then switch off the controller and turn it on again.
- 4. Pull the trigger in the transmitter half way to drive the boat forward. Pull the trigger full way to obtain extra speed.
- 5. When the boat is driving forward, turn the steering knob in the transmitter to steer the boat to right or left.
- 6. If the boat does not run in a straight line, adjust the alignment on the boat. 7. The "Power LED" on the boat will not flash nor stay on if the rechargeable battery has run out power.
- 8. Do not drive the boat onto the shore that will damage the propeller.
- 9. Take up the boat from water and switch off the controller when not in play.

Performance Tips:

- Do not drive the boat in windy or rainy weather.
- Keep fingers, hair and loose clothing away from the propeller. (Refer to Diagram 5)
- The operating range can be affected by a variety of factors: a) Weak transmitter or boat batteries.
- b) Interference from other items that emit radio frequency signals such as another Diagram 4 R/C item on the same frequency, CB radios, cordless phones, high voltage transformers, etc.
- Do not operate the boat in salt water, it is designed for use in fresh water only.
- 5. Be sure to bring the boat back to shore (out of water) before the battery runs out.
- 6. Outdoor usage is recommended in order to get optimal control range.
- 7. Remove the package, take out all accessories and assemble the product before giving it to children to play.
- 3. The boat is to be operated in water only when fully assembled in accordance with instruction.

Cautions:

- The Built-in rechargeable battery must be charged before use.
- 2. Do not overcharge the Battery. Do not charge for more than 1.5 hours except for the initial two charges.
- 3. Do not charge the Battery if it shows leakage, corrosion, or has loose or exposed wires or other damage.
- 4. Do not cover the boat with any sort of material while charging.
- 5. Do not touch the boat when it is hot. Wait until the boat cools before recharging.
- Do not dispose of the Battery in fire.
- 8. The transformer used with the toy shall be regularly examined for damage to the cord, plug, enclosure and other parts, and in the event of such damage, they must not be used until the damage has been repaired.

7. Do not dismantle the Battery or USB, and do not cut the Battery or USB cables.

- . Rechargeable batteries are to be removed from the toy before being charged (for transmitter).
- 10. The Battery will be warm after charging, and hot after use in a boat.
- 11. The supply terminals are not to be short-circuited.
- 12.Rechargeable batteries are only to be charged by an adult!
- 13.Rechargeable batteries are only to be charged by adults or by children at least 8 years old.




R6/LR6 Batteries


Diagram 5
