Upper Emission Mask(763 MHz ~775MHz)-QPSK-25RB#0

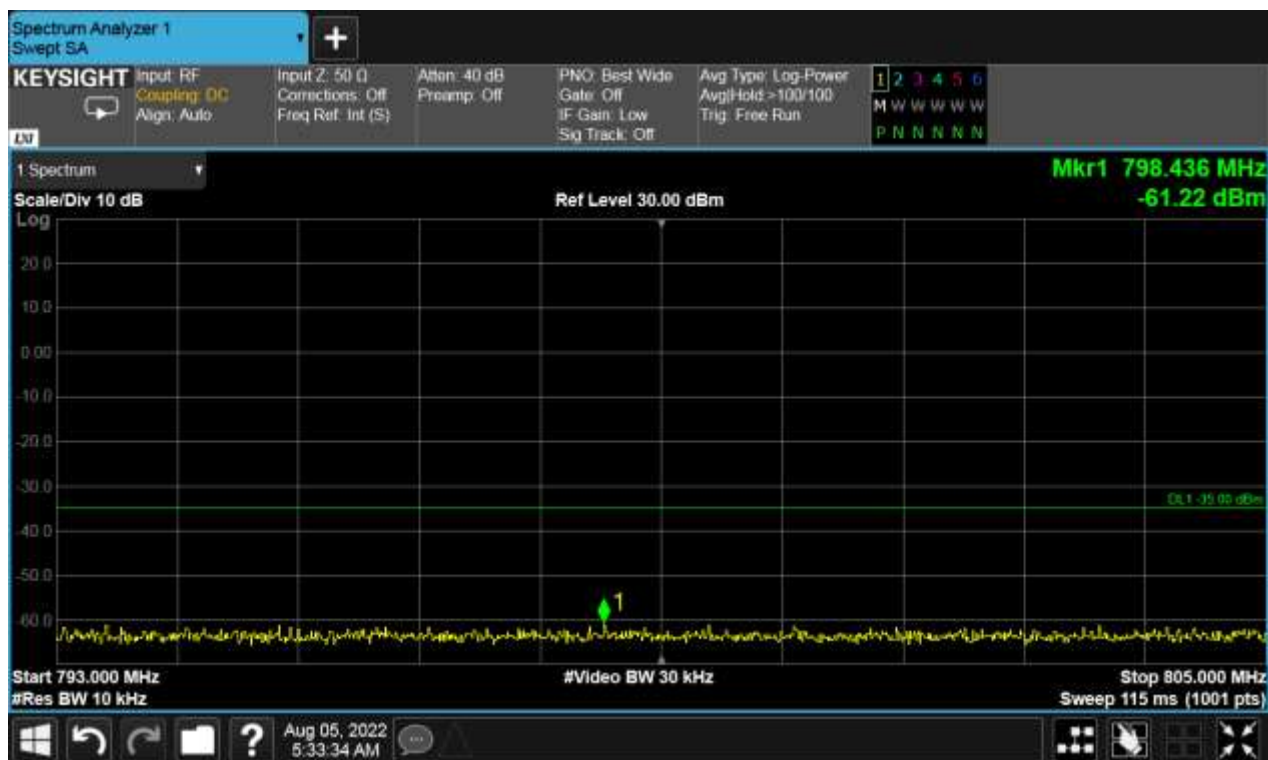


Upper Emission Mask(763 MHz ~775MHz)-16QAM-25RB#0

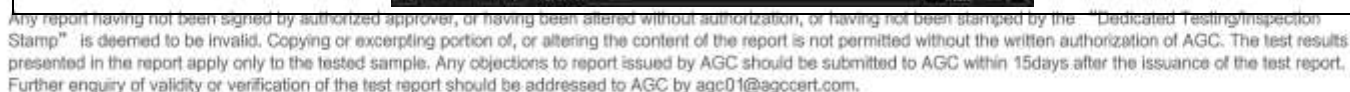
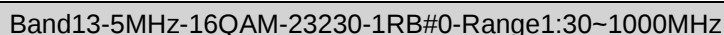
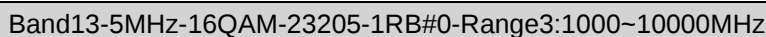
