

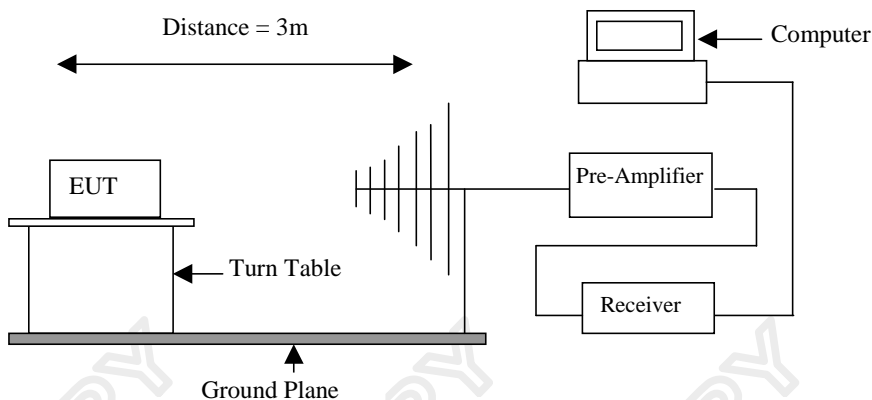

#### **Test Method:**

The sample was placed 0.8m above the ground plane on a standard radiated emission test site \*. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables, rotating turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. The emissions worst-case are shown in Test Results of the following pages.

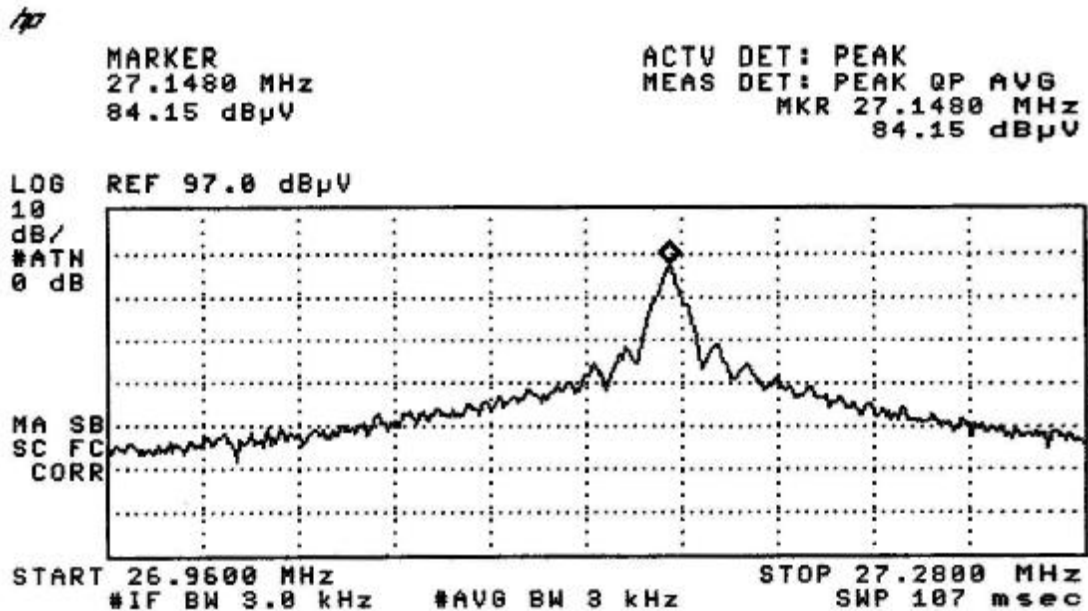

#### Duty Cycle Correction During 100msec

Each function key sends a different series of characters, but each packet period (73.75msec) never exceeds a series of 1 long (9.0msec) or short pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worst case transmit duty cycle would be considered  $1 \times 9.0\text{msec}$  per  $73.75\text{msec} = 12.37\%$  duty cycle. Figure A through B show the characteristics of the pulse train for one of these functions.

Remarks:

Duty Cycle Correction =  $20\text{Log}(0.1237) = -18.1\text{dB}$

Figure A [Pulse Train]

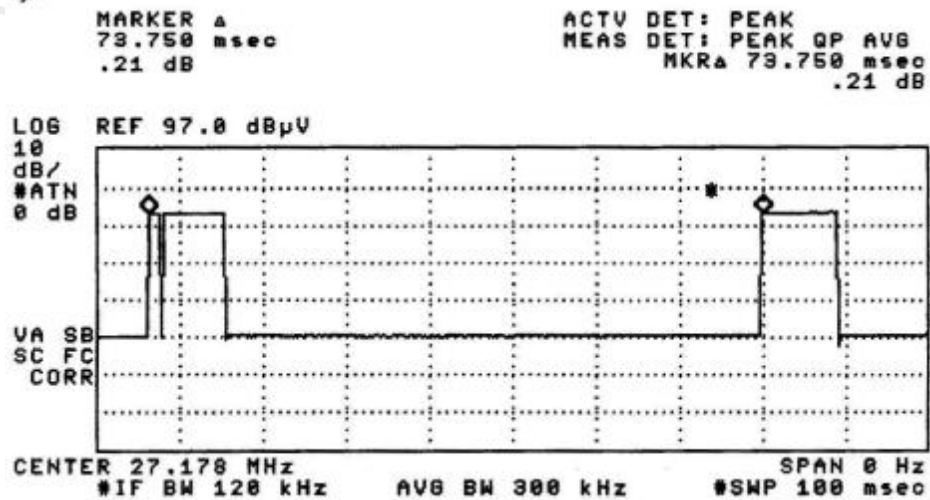
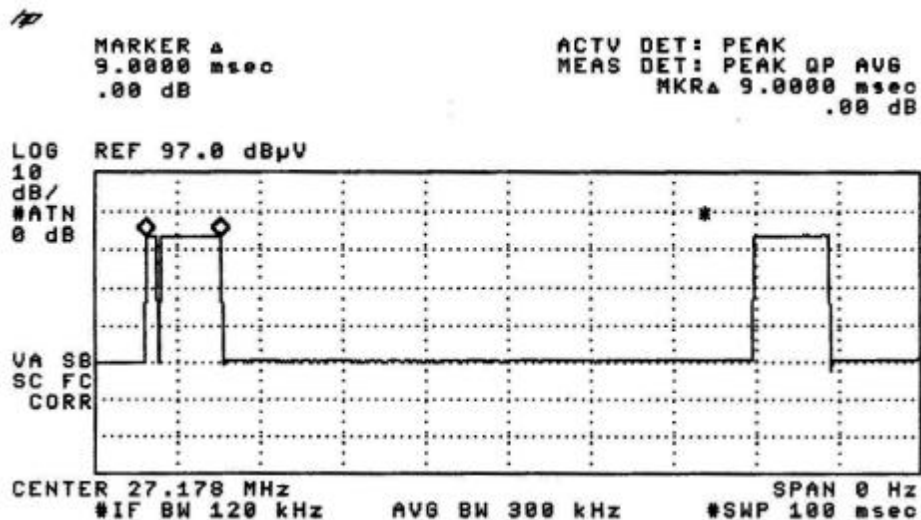


Figure B [Long Pulse or Short Pulse]

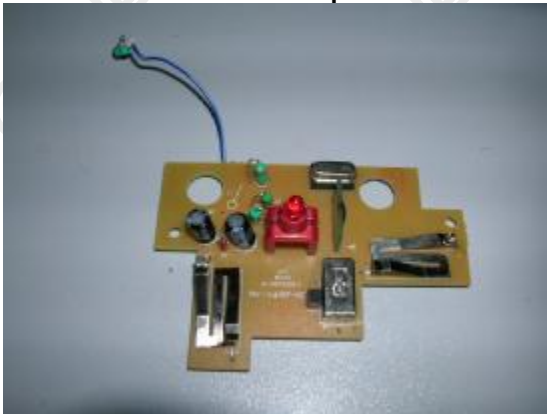
Front View of the product
