- b. The RBW of the receiver was set at 9 kHz in 150 kHz ~ 30MHz with Peak and AVG detector in Max Hold mode. Run the receiver's pre-scan to record the maximum disturbance generated from Product in all power lines in the full band.
- c. For each frequency whose maximum record was higher or close to limit, measure its QP and AVG values and record.





(A) Radiated Emission Test-Up Frequency Below 30MHz




(B) Radiated Emission Test-Up Frequency 30MHz~1GHz








### GFSK: Band Edge, Right Side






# (Right) GFSK: Band Edge, Left Side

# GFSK: Band Edge, Right Side \*RBW 100 kHz Marker 1 [T1 ]




