Band-edge for RF Conducted Emissions_11B_2412_Ant1



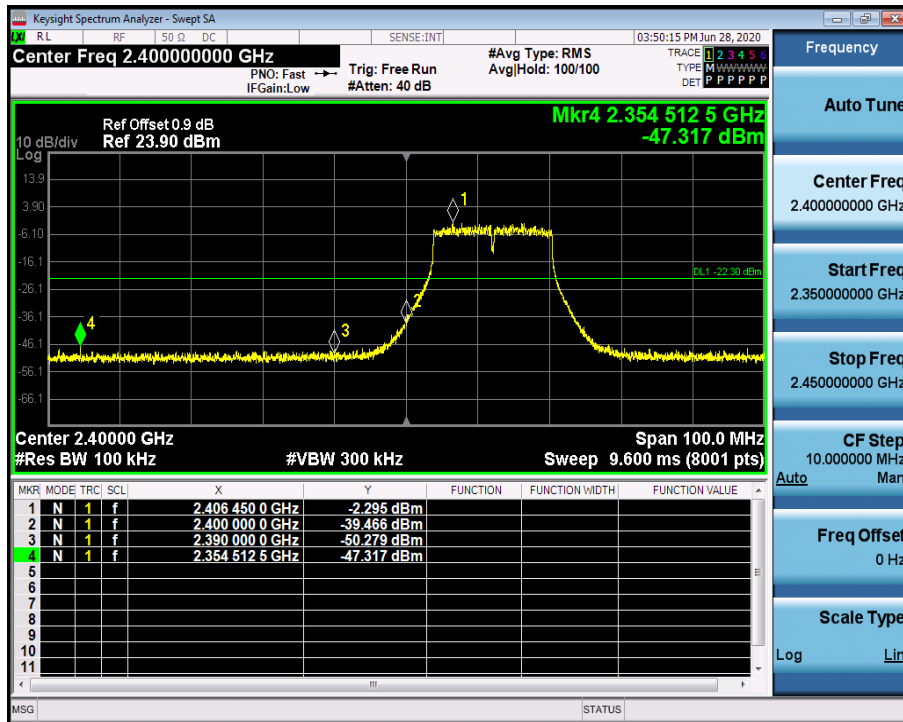
