


IMPORTANT NOTE: The device must be professionally installed and must use the supplied antennae.

The unit is designed for outdoor use and may be attached to either a pole or wall.

Note: The device can be mounted either outdoors or indoors. The included PoE injector must be mounted indoors, as it is not weatherproof.






The FortiAP 224D unit provides dual concurrent radio signals. Use the 2.4GHz antenna mounts to access 802.11b/g/n signals, and the 5GHz antenna mounts to access 802.11a/n signals. To use both radio frequencies concurrently, use all four WiFi antennae.

To Install the WiFi antennae

- 1. Insert the antenna base firmly into the appropriate antenna mount.
- 2. Securely hand tighten the fastening collar.
- 3. Repeat for the remaining antennae.






The unit requires 48V DC power, which is delivered by the PoE injector, over a straight-through Ethernet cable.

To install the cable

- 1. Unscrew the coupling ring from the back of the device, remove the sealing gland, then unscrew the panel connector.
- 2. Thread the RJ-45 plug through the components and insert it into the PoE port on the unit.
- 3. Screw the panel connector onto the back of the device, being careful not to pinch the Ethernet cable.
- 4. Slide the sealing gland along the cable into panel connector.
- 5. Thread the coupling ring onto the panel connector and tighten it until the sealing gland is compressed, making a watertight seal on the cable.







The unit is designed for outdoor use and may be attached to either a pole or wall.

To mount the device on a wall

- 1. Insert the mounting anchors into an appropriate wall.
- Screw the mounting screws into the anchors, ensuring that enough of the screw is exposed to allow for mounting the device.
- Place the device onto the mounting screws, then slide the unit downwards to lock it into place.






To mount the FortiAP unit on a pole

- 1. Loop the provided pole straps through the slots on the back of the device, then around the pole.
- 2. Tighten the strap with an appropriate screw driver and ensure that the device is firmly in place.



Adequate grounding must be provided to the FortiAP unit and the PoE injector. Consult a certified electrician to ensure that all grounding and cabling is installed in compliance with the local electrical code.


Use an exterior-grade or direct burial CAT5 Ethernet cable for connecting the outdoor unit to the PoE injector. Use the weatherproof connection to ensure a tight seal at the PoE port on the unit.



Note: The PoE injector is not weatherproof and must be mounted indoors. **Caution:** Do not connect the PoE injector to a PoE enabled Ethernet port.


To Connect the FortiAP unit

- 1. Connect grounding cables to the grounding lugs on the PoE injector, then connect the other ends of the cables to appropriate ground connections.
- Connect the region-specific AC plug adapter to the AC power adapter by inserting the round disk into the adapter and rotating clockwise until you hear the disk lock in place.
- Insert the DC plug of the power adapter into the DC48V IN port on the PoE injector, then plug the AC adapter into an appropriate power outlet. The PWR LED will light up.
- Connect one end of a cross-over Ethernet cable to the Network port on the PoE injector. Connect the other end to the FortiGate controller or an Internet connection. Do not connect the PoE injector to a PoE enabled Ethernet port.
- 5. Using the weatherproof connection, connect an Ethernet cable to the FortiAP unit, as described in "Cabling" on page 8.
- 6. Connect the Ethernet cable from the device into the AP/Bridge port on the PoE injector.

- 4. Follow the prompts to associate the FortiAP device to an SSID.
- 5. Connect your FortiAP to an Internet connection. This can be a modem or another source of Internet connectivity. The FortiAP will self-configure.

B Deployment through a FortiGate

If your FortiGate is on the same network as your FortiAP:

- 1. Preauthorize your FortiAP device using your FortiGate. If you are not familiar with deploying a FortiAP using your FortiGate, refer to the "Access Point Deployment" section of the Deploying Wireless Networks Guide found at http://docs.fortinet.com.
- 2. Plug your FortiAP into your local Ethernet connection. The FortiAP will self-configure.

Or

- 1. Instead of preauthorizing, you can authorize your FortiAP via the FortiGate after you have connected the FortiAP to your local Ethernet.
- Within two minutes of connecting the FortiAP to your FortiGate, the device will appear on the Managed FortiAP page in the Web-based Manager: authorize the device and assign a profile to the device.


If your FortiGate is not on the same network as your FortiAP:

- 1. Log in to the FortiAP directly (IP address: 192.168.1.2) with username admin and no password, and specify the IP address of the controlling FortiGate.
- 2. Connect to the FortiAP via the CLI using the instructions in the "Connecting to FortiAP CLI" section of the Deploying Wireless Networks guide.
- 3. Specify the IP address of the controlling FortiGate:


where $\mathbf{0.0.0.0}$ is the address of the FortiGate.

(Hereinafter, translation is included without limitation in the term "modification".)

"Source code" for a work means the preferred form of the work for making modifications to it. For a library, complete source code means all the source code for all modules it contains, plus any associated interface definition files, plus the scripts used to control compilation and installation of the library.

Activities other than copying, distribution and modification are not covered by this License; they are outside its scope. The act of running a program using the Library is not restricted, and output from such a program is covered only if its contents constitute a work based on the Library (independent of the use of the Library in a tool for writing it). Whether that is true depends on what the Library does and what the program that uses the Library does.

b) Use a suitable shared library mechanism for linking with the Library. A suitable mechanism is one that (1) uses at run time a copy of the library already present on the user's computer system, rather than copying library functions into the executable, and (2) will operate properly with a modified version of the library, if the user installs one, as long as the modified version is interface-compatible with the version that the work was made with

c) Accompany the work with a written offer, valid for at least three years, to give the same user the materials specified in Subsection 6a, above, for a charge no more than the cost of performing this distribution.

d) if distribution of the work is made by offering access to copy from a designated place, offer equivalent access to copy the above specified materials from the same place. e) Verify that the user has already received a copy of these materials or that you have already sent this user a copy.

for an executable, the required form of the "work that uses the Library" must include any data and utility programs needed for reproducing the executable from it. However, as a special exception, the materials to be distributed need not include anything that is normally distributed (in either source or binary form) with the major components (compiler, kernel, and so on) of the operating system on which the executable runs, unless that component itself accompanies the executable. It may happen that this requirement contradicts the license restrictions of other proprietary libraries that do not normally accompany the operating system. Such a contradiction means you cannot use both them and the Library together in an executable that you distribute.

7. Each time you redistribute the Library (or any work based on the Library), the recipient automatically receives a license from the original licensor to copy, distribute, link with or modify the Library subject to these terms and conditions. You may not impose any further restrictions on the recipients' exercise of the rights granted herein. You are not responsible for enforcing compliance by third parties with this License.

11. If, as a consequence of a court judgment or allegation of patent infringement or for any other reason (not limited to patent issues), conditions are imposed on you (whether by court order, agreement or otherwise) that contradict the conditions of this License, they do not excuse you from the conditions of this License. If you cannot distribute so as to satisfy simultaneously your obligations under this License and any other pertinent obligations, then as a consequence you may not distribute the Library at all. For example, if a patent license would not permit royalty-free redistribution of the Library by all those who receive copies directly or indirectly through you, then the only way you could satisfy both it and this License would be to refrain entirely from distribution of the Library.

If any portion of this section is held invalid or unenforceable under any particular circumstance, the balance of the section is intended to apply, and the section as a whole is intended to apply in other circumstances.

It is not the purpose of this section to induce you to infringe any patents or other property right claims or to contest validity of any such claims: this section has the sole purpose of protecting the integrity of the free software distribution system which is implemented by public license practices. Many people have made generous contributions to the wide range of software distributed through that system in reliance on consistent application of that system; it is up to the author/donor to decide if he or she is willing to distribute software through any other system and a licensee cannot impose that choice. This section is intended to make thoroughly clear what is believed to be a consequence of the rest of this License 12. If the distribution and/or use of the Library is restricted in certain countries either by patents or by copyrighted interfaces, the original copyright holder who places the Library under this License may add an explicit geographical distribution limitation excluding those countries, so that distribution is permitted only in or among countries not thus excluded. In such case, this License incorporates the limitation as if written in the body of this License.

13. The Free Software Foundation may publish revised and/or new versions of the Lesser General Public License from time to time. Such new versions will be similar in spirit to the present version, but may differ in detail to address new problems or concerns. Each version is given a distinguishing version number.
