
A skin care device that provides a solution for skin change that is renewed by finding out the lack of skin

One button for easy use

- Press the button once to proceed in the following order: mode is changed.



A sensor that measures the condition of the skin on your face

- If you measure the center of the ball for 3 seconds in the measurement mode, The most necessary mode is automatically If you want to use a mode other than the recommended mode Press the button to change to the desired mode and use it.

Long lasting use on a single charge


- 60 minutes of use with a full charge within 3 hours (can be used 20 times)


How to use

select

After the skin care step of toner and lotion, use after selecting the desired mode while applying enough cream to the face.



2. Intensive care for the area to enhance the effect, and finish with essence for moisturizing/soothing after use.



Questions about use

Can the measurement mode be affected by the season?

- Spring/Autumn: Due to dry weather, the frequency of moisture and oil care is highly recommended.
- Summer: Due to the intense heat, you sweat a lot, so firming care may be intensively recommended..
- Winter: Due to the cold and bitter wind, moisture and oil care are highly recommended.

Can't you check the measurement result with the LED on the side after using the mode selection?

- After the normal measurement in the measurement mode and the use of the automatically set mode is completed, the side LED You can see how much better it is. (shows up to 4)

Having a hard time checking if the use mode is working?

- You can check which mode is active by checking the color of the button..
((Example: LED color above the button  → BLUE mode)
- Use it so that it comes in contact with your skin, and if you feel the light and vibration, you are using it correctly.

Questions about use

Do you feel a stinging sensation on your skin?

- Safety was verified by conducting a skin safety evaluation test for skin irritation¹
- If you feel uncomfortable with the stinging sensation, you can get a good effect when using it with a mask sheet attached.

Do you feel the light is too bright?

- Completed certification of 'photobiological safety test' for eyes
- However, be careful not to look directly at the light for a long time.
- When using around the eyes, close your eyes to minimize glare. If you feel any discomfort around your eyes, such as eye fatigue, pain, foreign body sensation, etc., please stop using it temporarily.

Precautions when using

when using

If you press it hard on your face, it may irritate your skin. Please rub lightly. Do not use on areas with severe redness or swelling due to skin irritation during use. Please discontinue use until it subsides. • Do not use on infected, burned or cut skin as skin damage may occur. • If you have a wound on your skin, use it after treatment..

when storing

• Do not use if pregnant or nursing mothers. Do not drop the product or subject it to external impact. • Do not allow children or pets to put the product in their mouth or bite it. • Store at room temperature away from direct sunlight, and do not store at too high or low temperatures. • When maintaining the device, wipe lightly with a soft cloth once a week. • Do not leave in direct sunlight for a long time. It may cause discoloration.

when charging

• Using a charger that is not suitable for the product may shorten the life of the product or cause a malfunction. • Do not excessively bend the charger cord or use the product while charging..

Is it okay to use every day?	<ul style="list-style-type: none"> It is designed to be gentle on the skin even if used daily, but it may cause severe stinging depending on the skin type. In the case of sensitive skin, use only 1 set (3 minutes) after applying enough skin care products. If skin trouble occurs after use, stop using it for a while before using it.
A tingling sensation during use Are you feeling uncomfortable?	<ul style="list-style-type: none"> Depending on your skin type or condition, there may be slight irritation. When using for the first time, it is recommended to use MODE 1 (BLUE), which has the weakest microcurrent, for 3 minutes. Gradually increase the usage time step by step, and apply enough skin care products such as cream or massage gel before care.
LED wavelength during use Can't you see?	<ul style="list-style-type: none"> Negative ions and vibration can be checked only when the proximity sensor touches, and the proximity sensor can be checked with a gray dot on the top. The sensor does not work on dry skin, so please use it after applying a skin care product..
Even in combination with dermatological treatment it's okay	<ul style="list-style-type: none"> Since it is a beauty device, not a medical device, it is recommended to use it according to the doctor's opinion related to skin disease. Use it after determining whether to use it or not.
wearing jewelry Is it available??	<ul style="list-style-type: none"> It is possible to use it because there is no direct effect on surfaces that come into contact with the skin, such as earrings and necklaces. Skin care products used after cleansing are recommended to be used without precious metals.
Do you hear a 'beep beep' sound while using it?	<ul style="list-style-type: none"> It is a notification sound that guides you to use it by moving it according to the time easily for each part. A beep sounds when one minute elapses after the power is turned on. Both cheeks (1 minute), eyes & T zone (1 minute), It is convenient to use in the order of forehead, chin & philtrum (1 minute).
