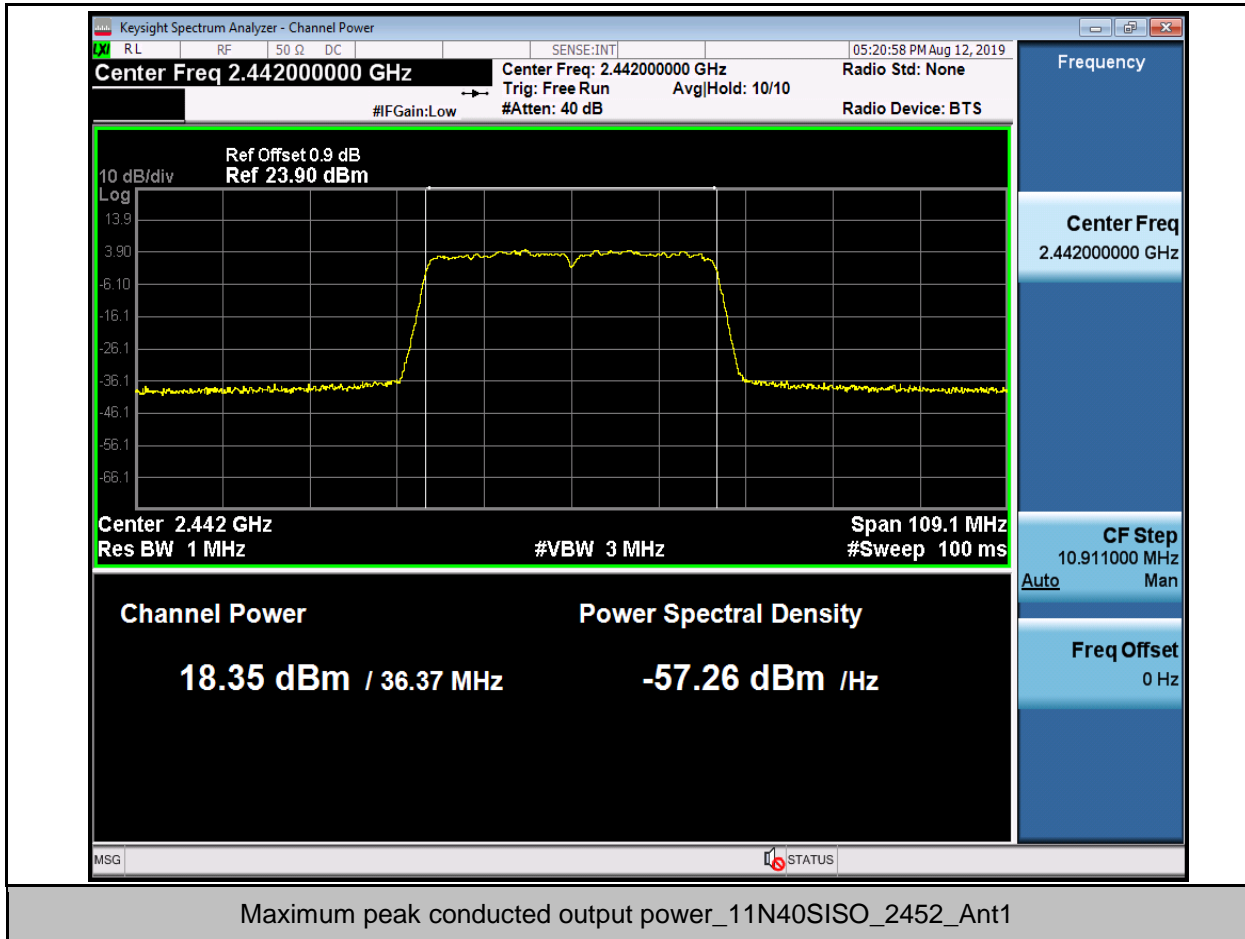

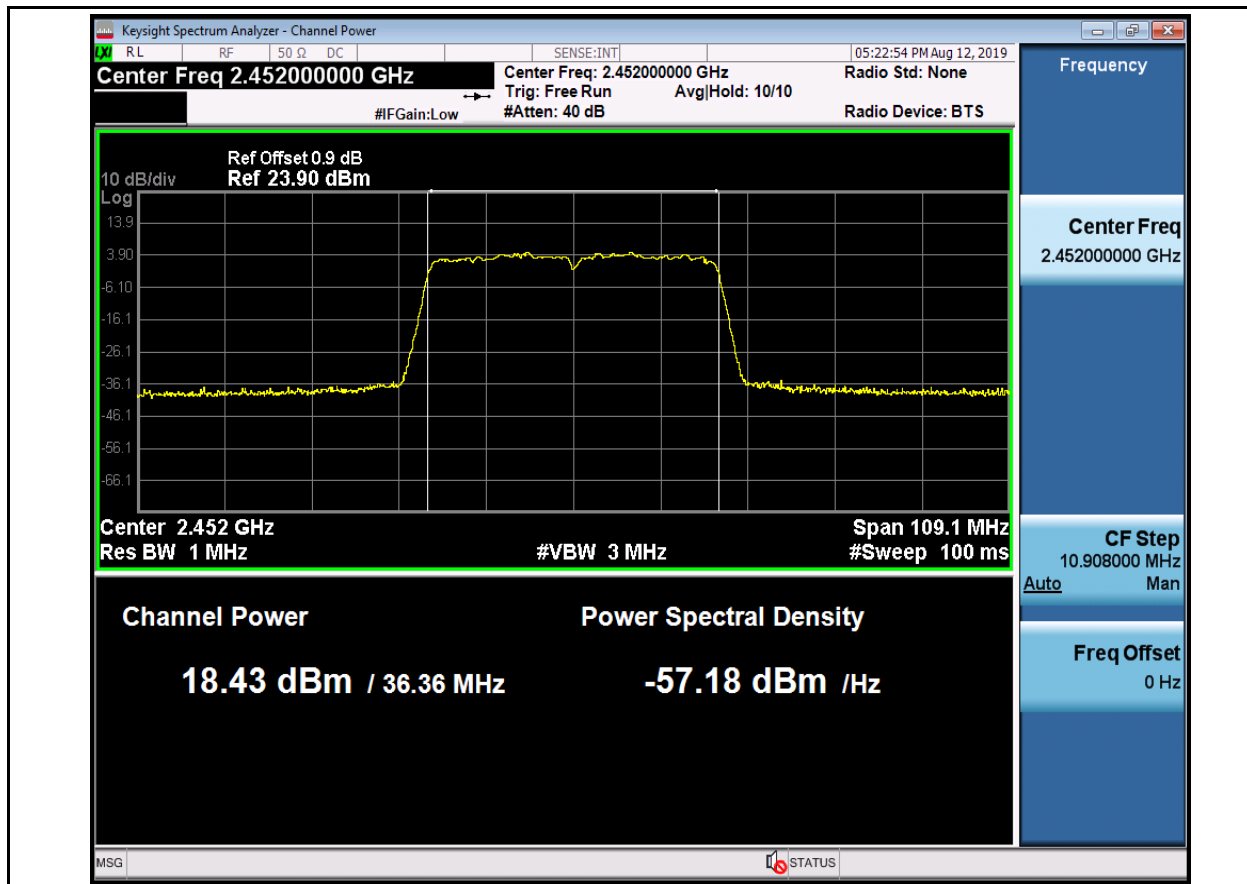

Maximum Peak power spectral density 11B 2442 Ant1

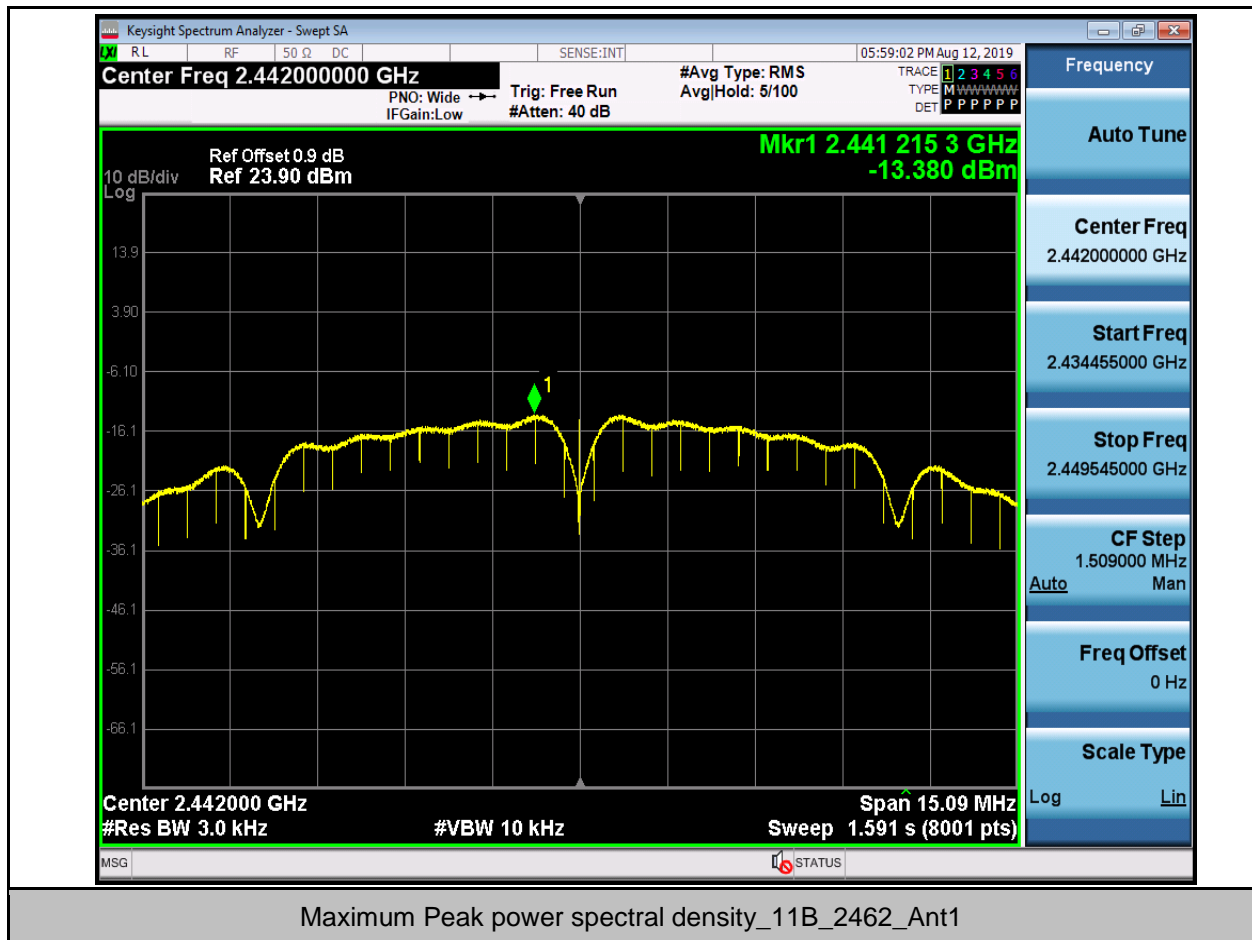

Maximum Peak power spectral density\_11N40SISO\_2422\_Ant1



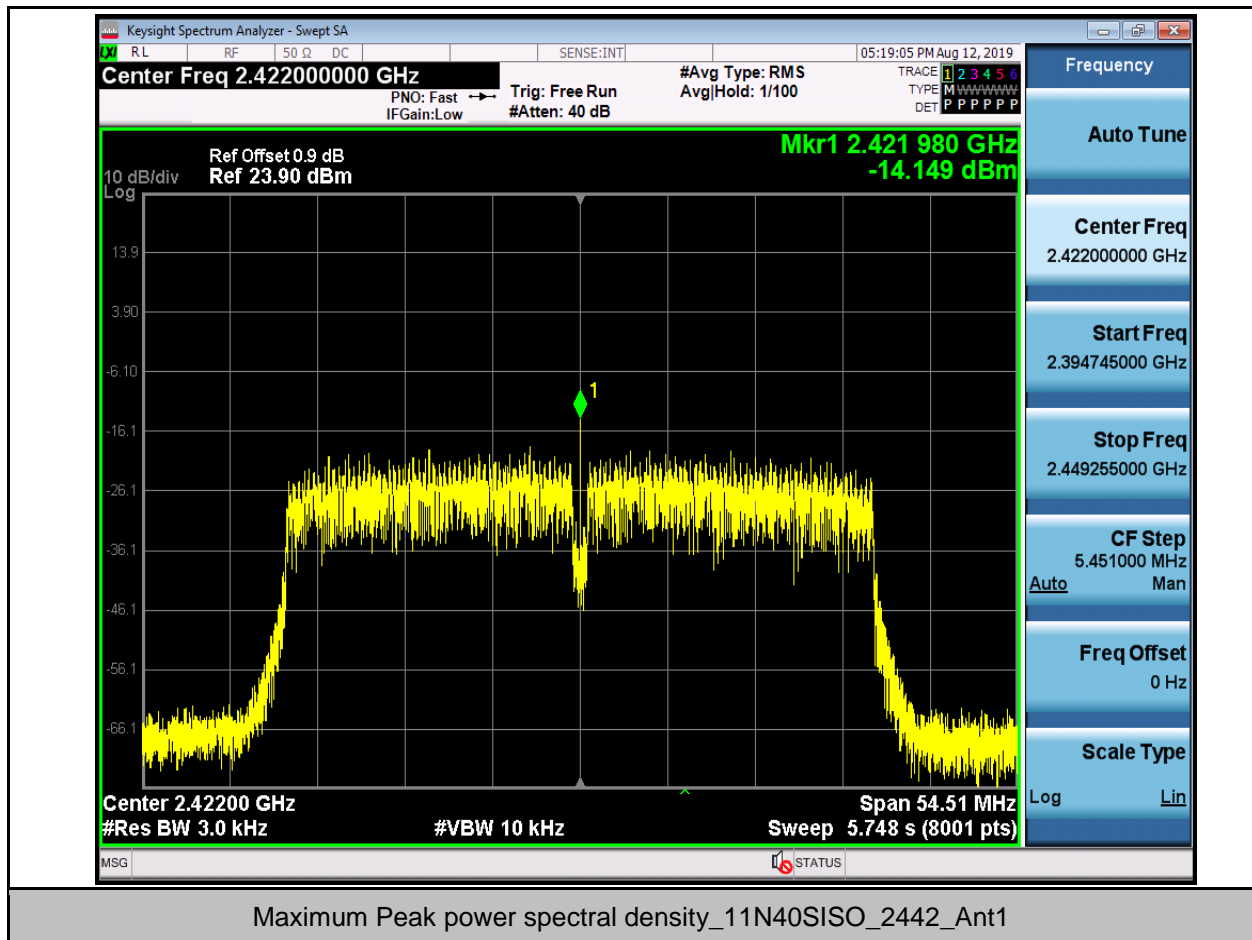
