2.2 Test Mode

- a. The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conduction emission (150 kHz to 30 MHz), radiation emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). 

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 0.5 dB and 10dB attenuator.

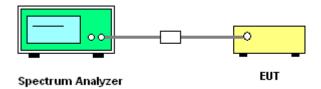

- 4. Make the measurement with the spectrum analyzer's resolution bandwidth (RBW) = 100 kHz. Set the Video bandwidth (VBW) = 300 kHz. In order to make an accurate measurement. The 6 dB bandwidth must be greater than 500 kHz.
- 5. For 99% Bandwidth Measurement, the spectrum analyzer's resolution bandwidth (RBW) is set 1% to 5% of the 99% OBW and the VBW is set to 3 times of the RBW.





3.2 Output Power Measurement

3.2.1 Limit of Output Power

For systems using digital modulation in the 2400-2483.5MHz, the limit for output power is 30dBm. If transmitting antenna of directional gain greater than 6dBi is used, the output power from the intentional radiator shall be reduced below the above stated value by the amount in dB that the directional gain of the antenna exceeds 6 dBi. 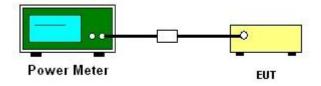

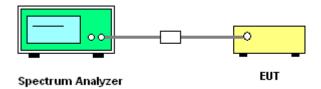

- 7. The Measured power density (dBm)/ 100kHz is a reference level and used as 20dBc down limit line for Conducted Band Edges and Conducted Spurious Emission.





Unwanted Emissions measured in any 100 kHz bandwidth outside of the authorized frequency band shall be attenuated by at least 20 dB relative to the maximum in-band peak PSD level in 100 kHz when maximum peak conducted output power procedure is used. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.



3.5.1 Limit of Radiated Band Edges and Spurious Emission

3.5.3 Test Procedures

- 1. The testing follows ANSI C63.10-2013 clause 11.11 & 11.12
- 2. The EUT was arranged to its worst case and then tune the antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level.
- The EUT was placed on a turntable with 0.8 meter for frequency below 1GHz and 1.5 meter for frequency above 1GHz respectively above ground.
- 4. The EUT was set 3 meters from the interference receiving antenna, which was mounted on the top of a variable height antenna tower.

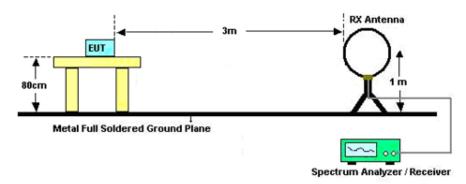



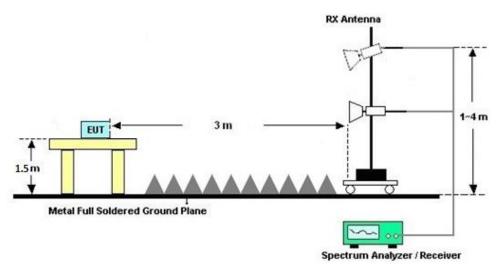
For radiated emissions below 30MHz



3.7 Antenna Requirements

3.7.1 Standard Applicable

If directional gain of transmitting antennas is greater than 6dBi, the power shall be reduced by the same level in dB comparing to gain minus 6dBi. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the rule.


