



Power button: press once to power on and press twice to power off-

4 white power indicators: always on during working and flicker in low battery.

1 blue wireless charging indicator: always on during working and flicker in standby mode.

Press and hold it for 2 seconds to power on. When the green indicator flickers, enable Bluetooth on your mobile phone to search for "SEA IIC", then click on it to connect; the green indicator will be always on after successful connection.

- 2. To take photos/videos, just short press "Bluetooth/Camera" (some phones may not support taking videos). 3. It will enter sleep mode in case of no connection or no key operation in 10
