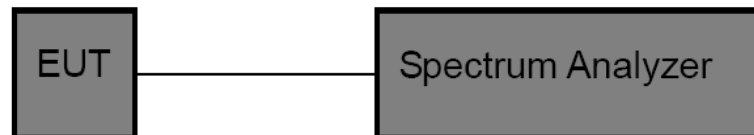

Test Procedure

The EUT was directly connected to the Spectrum Analyzer and antenna output port as show in the block diagram above. The measurement is according to KDB 789033 D02 General UNII Test Procedures New Rules V02r01.

- (1) The EUT was directly connected to the spectrum analyzer and antenna output port as show in the block diagram above.
- (2) Set analyzer center frequency to transmitting frequency.
- (3) Set the span to encompass the entire emissions bandwidth (EBW) (alternatively, the entire 99% OBW) of the signal.
- (4) RBW=1MHz for devices operating in the bands 5.15-5.25 GHz, 5.25-5.35 GHz, and 5.47-5.725 GHz
RBW=500kHz for devices operating in the band 5.725-5.85 GHz.
- (5) Set the VBW to: ≥ 3 RBW
- (6) Detector: AVG
- (7) Trace: Max Hold and View
- (7) Sweep time: auto
- (8) Trace average at least 100 traces in power averaging.
- (9) User the peak marker function to determine the maximum amplitude level within the RBW. Apply correction to the result if different RBW is used.

NOTE: The EUT was set to continuously transmitting in each mode and low, middle and high channel for the test.

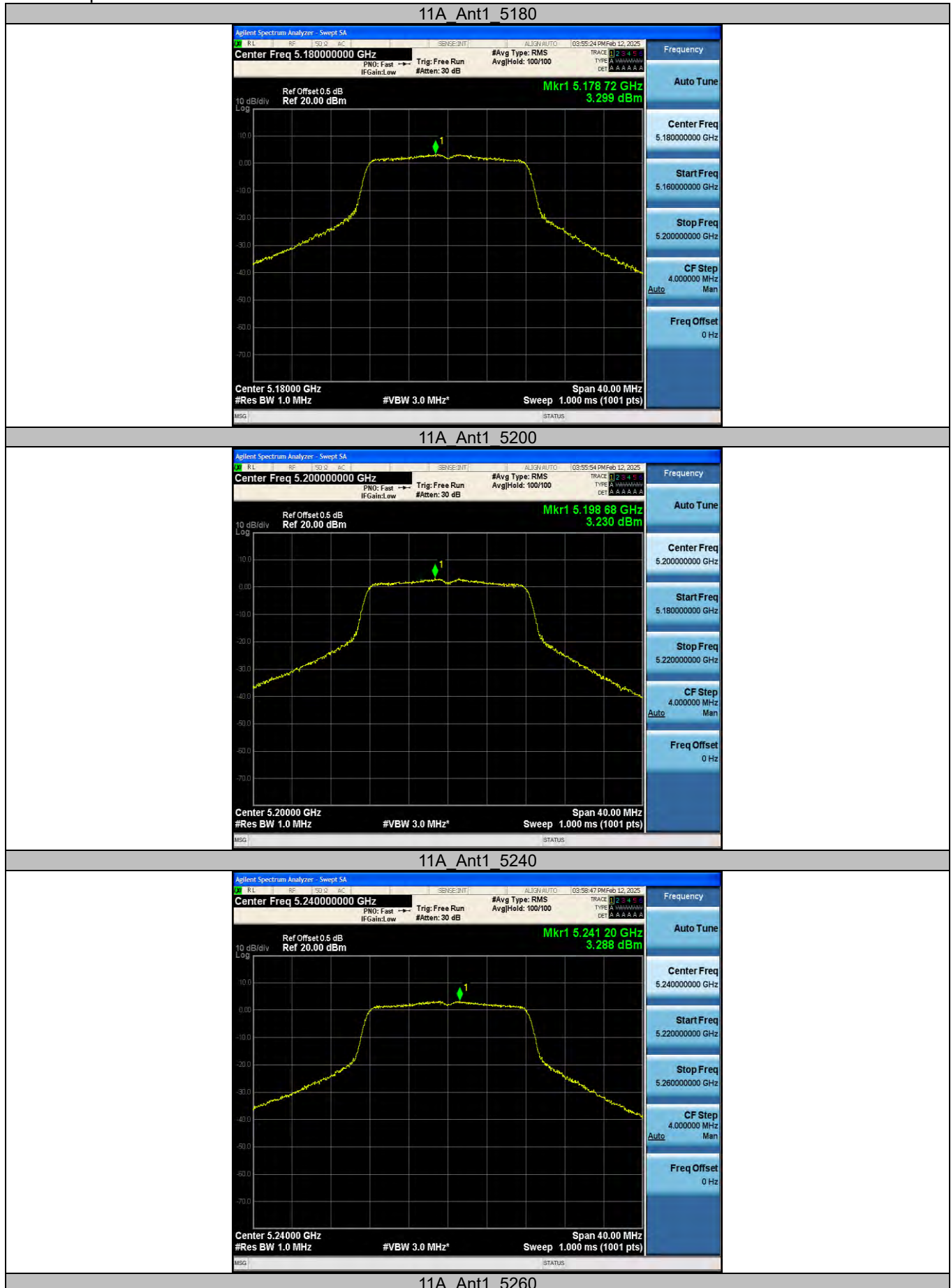
