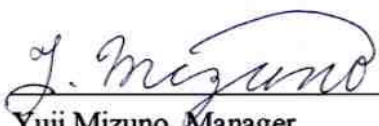
In authorizing CCS Testing Division as our agent, we still recognize that we are responsible to:
