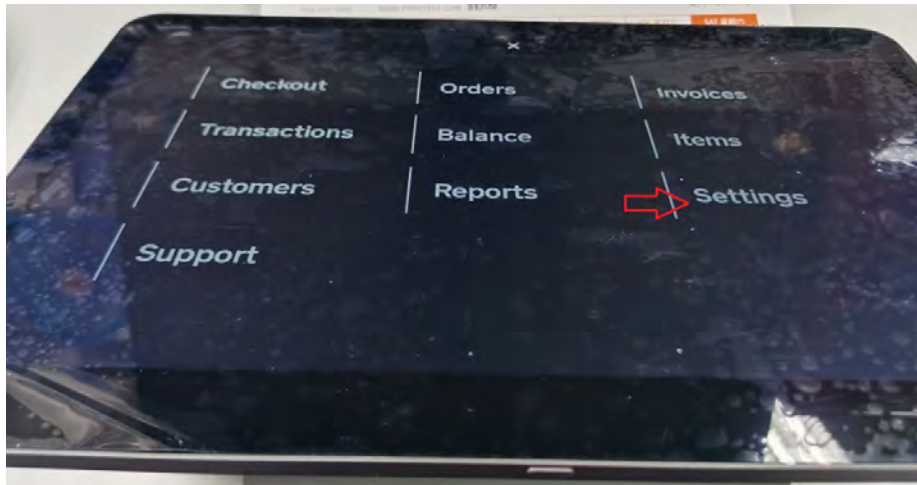

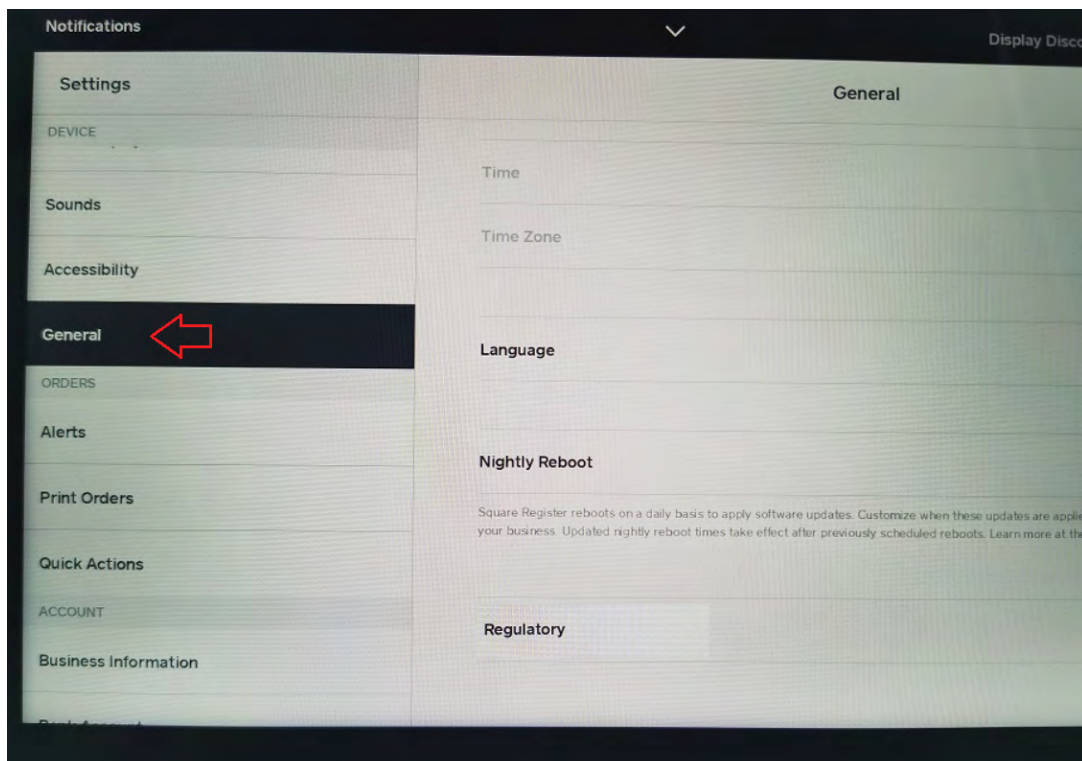
B. Access to the required information on the e-label

1. Users are able to access the information in no more than three steps in a device's menu. The actual steps are:

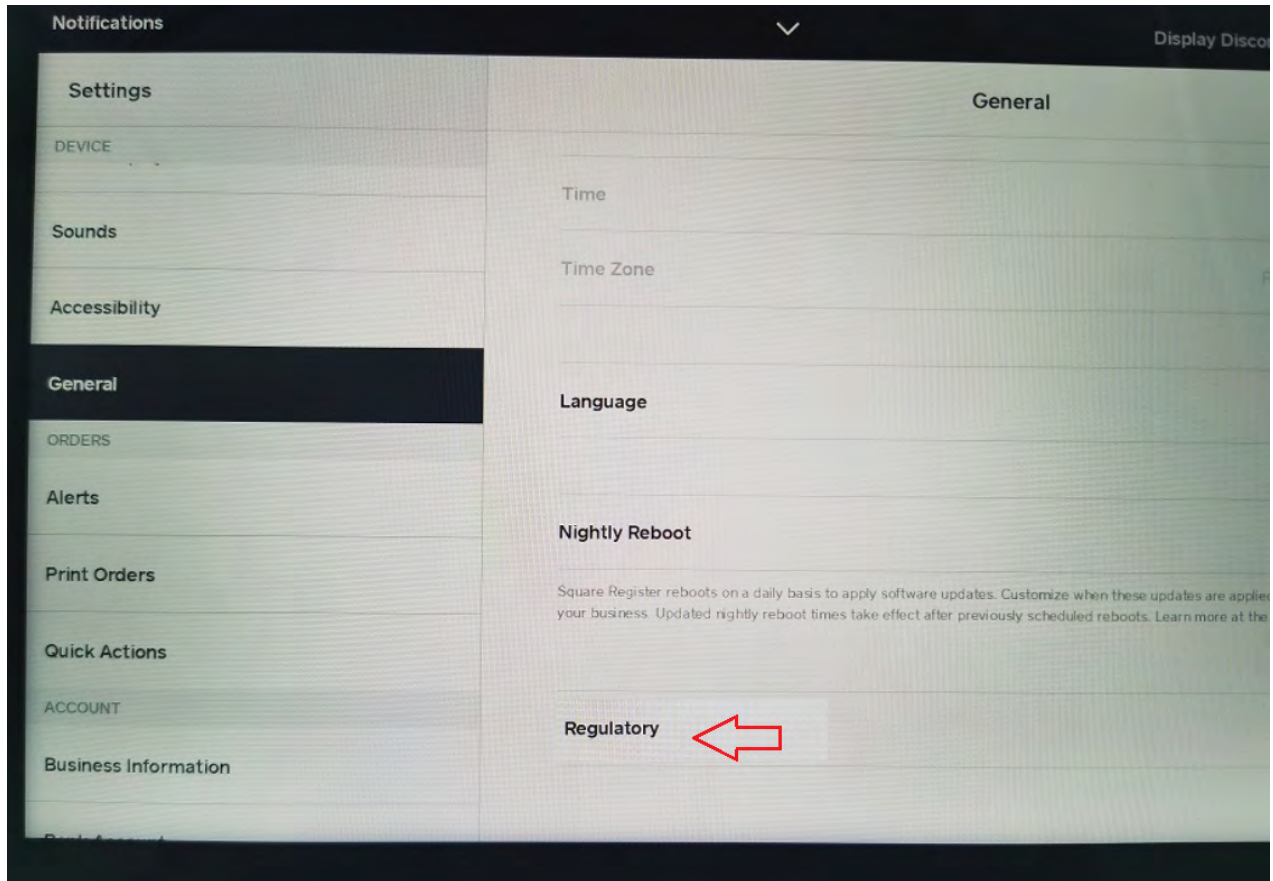
STEP 1: User clicks on detailed Settings entry



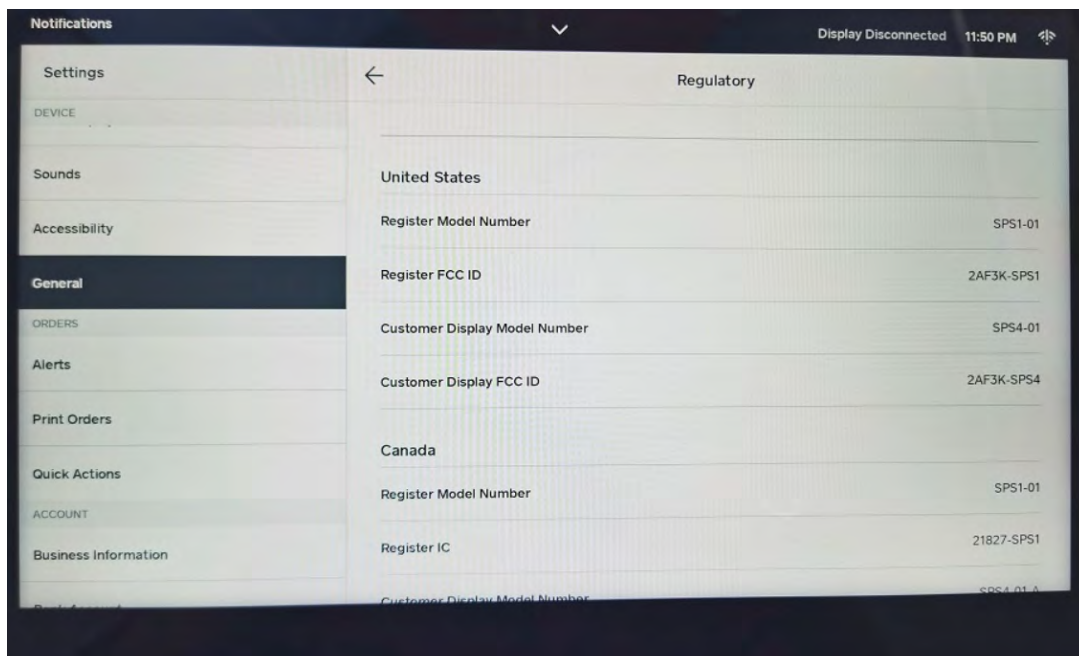
STEP2: User clicks on detailed General entry
