## 1. RF EXPOSURE

### 1.1.The Requirement

System operating under the provisions of this section shall be operated in a manner that ensures that the public is not exposed to radio frequency energy levels in excess of the Commission's guidelines. See Section 15.247(b)(4) and Section 1.1307(b)(1)

### 1.3.MPE Calculation Method

Predication of MPE limit at a given distance

Equation from page 18 of OET Bulletin 65, Edition 97-01

$$S=PG/4\pi R^2$$

Where: S=power density

P=power input to antenna

G=power gain of the antenna in the direction of interest relative to an isotropic radiator

R=distance to the center of radiation of the antenna

From the peak EUT RF output power, the minimum mobile separation distance,  $d=0.2\text{m}$ , as well as the gain of the antenna is 1 dBi, the RF power density can be obtained.

## 1.5.FCC Radiation Exposure Statement
