#### 2.2 MPE CALCULATION FORMULA

 $Pd = (Pout*G) / (4*pi*r^2)$ 

where

Pd = power density in mW/cm<sup>2</sup>

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

#### 2.3 CLASSIFICATION

The antenna of this product, under normal use condition, is at least 20cm away from the body of the user. So, this device is classified as **Mobile Device**.

1. 2.4GHz: Directional gain =  $10 \log[(10^{G1/20} + 10^{G2/20} + ... + 10^{GN/20})^2/N_{ANT}] = 6.22$ 2. 5GHz: Directional gain =  $10 \log[(10^{G1/20} + 10^{G2/20} + ... + 10^{GN/20})^2/N_{ANT}] = 7.46$ 

#### **CONCULSION:**

Both of the WLAN 2.4G & WLAN 5G can transmit simultaneously, the formula of calculated the MPE is:

CPD1 / LPD1 + CPD2 / LPD2 + .....etc. < 1

CPD = Calculation power density

LPD = Limit of power density

1. WLAN 2.4G + WLAN 5.0G = 0.349 + 0.340 = 0.689

Therefore, the maximum calculation of this situation is 0.689, which is less than the "1" limit.
