


Fig.1 Photograph of the SAR measurement system



### Photograph of the tissue simulant fluid liquid depth












Fig.3 EUT Back side to flat phantom




Fig.15 Antenna location of EUT (Tablet mode)




Fig.16 Antenna location of EUT (Notebook mode)
