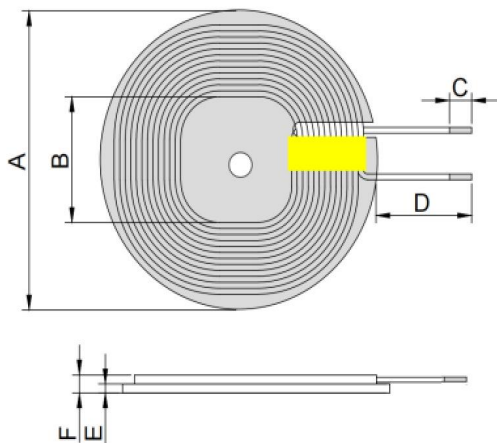

JINHAODE liability shall in no event exceed the cost of repair or replacement of its parts. This warranty does not extend to any materials that has been altered or repaired by others without our written authorization.

Under no circumstance shall JINHAODE have any liability whatsoever for the loss of anticipated profits, interruption of operations, or for special, incidental or consequential damages.
