## 2 Test Configuration of Equipment Under Test

The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conducted emission (150 kHz to 30 MHz) and radiated emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). For radiated measurement, pre-scanned in three orthogonal panels, X, Y, Z. The worst cases (Z plane) were recorded in this report.

The final configuration from all the combinations and the worst-case data rates were investigated by measuring the maximum power across all the data rates and modulation modes under section 2.2.

Based on the worst configuration found above, the RF power setting is set individually to meet FCC compliance limit for the final conducted and radiated tests shown in section 2.3.





# 2.7 Measurement Results Explanation Example

#### For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

#### Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 4.2 dB and 10dB attenuator.

Offset(dB) = RF cable loss(dB) + attenuator factor(dB). = 4.2 + 10 = 14.2 (dB)



- 5. For 99% Bandwidth Measurement, the spectrum analyzer's resolution bandwidth (RBW) = 1MHz and set the Video bandwidth (VBW) = 3MHz.



### 3.2 Output Power Measurement

### 3.2.1 Limit of Output Power

For systems using digital modulation in the 2400-2483.5MHz, the limit for peak output power is 30dBm. If transmitting Antenna of directional gain greater than 6dBi are used the peak output power from the intentional radiator shall be reduced below the above stated value by the amount in dB that the directional gain of the Antenna exceeds 6 dBi. In case of point-to-point operation, the limit has to be reduced by 1dB for every 3dB that the directional gain of the Antenna exceeds 6dBi.



#### 3.5.3 Test Procedures

- 1. The testing follows FCC KDB Publication No. 558074 D01 DTS Meas. Guidance v03r02.
- 2. The EUT was arranged to its worst case and then tune the antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level.

- 3. The EUT was placed on a turntable with 0.8 meter for frequency below 1GHz and 1.5 meter for frequency above 1GHz respectively above ground.
- 4. The EUT was set 3 meters from the interference receiving antenna, which was mounted on the top of a variable height antenna tower.
- 5. Corrected Reading: Antenna Factor + Cable Loss + Read Level Preamp Factor = Level
- 6. For measurement below 1GHz, If the emission level of the EUT measured by the peak detector is 3 dB lower than the applicable limit, the peak emission level will be reported. Otherwise, the emission measurement will be repeated using the quasi-peak detector and reported.
- 7. Use the following spectrum analyzer settings:
  - (1) Span shall wide enough to fully capture the emission being measured;





#### For radiated emissions below 30MHz




#### For radiated emissions from 30MHz to 1GHz

- 3. All the support units are connecting to the other LISN.
- 4. The LISN provides 50 ohm coupling impedance for the measuring instrument.
- 5. The FCC states that a 50 ohm, 50 microhenry LISN should be used.
- 6. Both sides of AC line were checked for maximum conducted interference.
- 7. The frequency range from 150 kHz to 30 MHz was searched.
- 8. Set the test-receiver system to Peak Detect Function and specified bandwidth (IF bandwidth = 9kHz) with Maximum Hold Mode.







### 3.7 Antenna Requirements

#### 3.7.1 Standard Applicable

If directional gain of transmitting antennas is greater than 6dBi, the power shall be reduced by the same level in dB comparing to gain minus 6dBi. For the fixed point-to-point operation, the power shall be reduced by one dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the FCC rule.

#### 3.7.2 Antenna Anti-Replacement Construction

An embedded-in antenna design is used.

#### 3.7.3 Antenna Gain

The antenna peak gain of EUT is less than 6 dBi. Therefore, it is not necessary to reduce maximum peak output power limit.
