

Get Started....

Wired mode



Plug and play: Take out the USB-A to TYPE-C cable from the box and connect the mouse to an available USB port.

Wireless mode



1. Remove the receiver from the box and plug it into an available USB port.



2. Turn on the power switch (10) at the bottom of the mouse and it will connect automatically.

DPI settings

To adjust the DPI settings, you can do the following:

- 1. After plugging in the mouse into the USB port of the computer, press 4 to adjust the DPI level.
- · Number of DPI levels: 4.
- Default Settings: DPI: 800 (DPI1) 1600 (Default, DPI2) 3200 (DPI3) 6400 (DPI4)
- 2. Open the Mad Catz ALL-IN-ONE Companion Software.
- Select M.M.O. 7+ and click on the Feature Settings page.
- Select the desired setting and fill in the desired DPI value (or drag the DPI bar).
- Max DPI: 26000

- Unplug the USB and plug it back into your computer's USB port.
- 2. If possible, try plugging your mouse into the USB port of another computer.
- 3. A powered USB port should be used.
- 4. Try restarting your PC.
