## 1.8. Description of Test Modes

The EUT has been tested under operating condition.

This test was performed with EUT in X, Y, Z position and the worst case was found when EUT in X position.

Worst-case mode and channel used for 150 KHz-30 MHz power line conducted emissions was the mode and channel with the highest output power, that was determined to be **802.11n HT40, Middle Channel** and recorded in this report.

Worst-case mode and channel used for 9 KHz-1000 MHz radiated emissions was the mode and channel with the highest output power, that was determined to be **802.11n HT40, Middle Channel** and recorded in this report.

Worst-Case data rates were utilized from preliminary testing of the Chipset, worst-case data rates used during the testing are as follows:

 IEEE 802.11g Mode: 6 Mbps, OFDM.

## 2. TEST METHODOLOGY

All measurements contained in this report were conducted with ANSI C63.10-2013, American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices. The radiated testing was performed at an antenna-to-EUT distance of 3 meters. All radiated and conducted emissions measurement was performed at Shenzhen Tongzhou Testing Co.,Ltd.

### 2.1. EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

### 2.2. EUT Exercise

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to FCC's request, Test Procedure KDB 558074 D01 DTS Meas Guidance v04 and KDB 662911 D01 Multiple Transmitter Output v02r01 are required to be used for this kind of FCC 15.247 digital modulation device.

According to its specifications, the EUT must comply with the requirements of the Section 15.203, 15.205, 15.207, 15.209 and 15.247 under the FCC Rules Part 15 Subpart C.

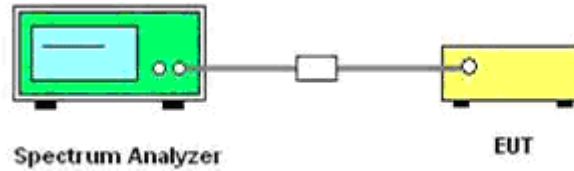

1. Set the center frequency of the spectrum analyzer to the transmitting frequency.
2. Set the span=0MHz, RBW to the largest available value, VBW $\geq$ RBW
3. Detector = peak.
4. Trace mode = Single hold.

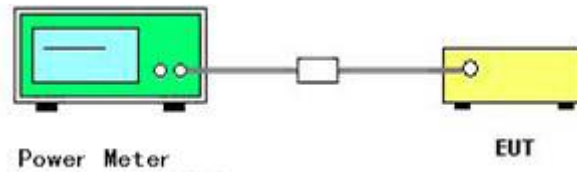
## 5.2. Maximum Conducted Output Power Measurement

### 5.2.1. Standard Applicable

According to §15.247(b): For systems using digital modulation in the 2400-2483.5 MHz and 5725-5850 MHz band, the limit for maximum peak conducted output power is 30dBm. The limit has to be reduced by the amount in dB that the gain of the antenna exceeds 6dBi. In case of point-to-point operation, the limit has to be reduced by 1dB for every 3dB that the directional gain of the antenna exceeds 6dBi.

Systems operating in the 5725-5850 MHz band that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi without any corresponding reduction in transmitter peak output power.

### 5.2.3. Test Procedures

☐ According to KDB558074 D01 DTS Measurement Guidance Section 9.1 Maximum peak conducted output power, 9.1.2 the maximum peak conducted output power may be measured using a broadband peak RF power meter. The power meter shall have a video bandwidth that is greater than or equal to the DTS bandwidth and shall utilize a fast-responding diode detector.

(a) As an alternative to spectrum analyzer or EMI receiver measurements, measurements may be performed using a wideband RF power meter with a thermocouple detector or equivalent if all of the conditions listed below are satisfied.

- 1) The EUT is configured to transmit continuously, or to transmit with a constant duty factor.
- 2) At all times when the EUT is transmitting, it shall be transmitting at its maximum power control level.
- 3) The integration period of the power meter exceeds the repetition period of the transmitted signal by at least a factor of five.

(b) If the transmitter does not transmit continuously, measure the duty cycle (x) of the transmitter output signal as described in Section 6.0.

(c) Measure the average power of the transmitter. This measurement is an average over both the on and off periods of the transmitter.

(d) Adjust the measurement in dBm by adding  $10\log(1/x)$ , where x is the duty cycle to the measurement result.

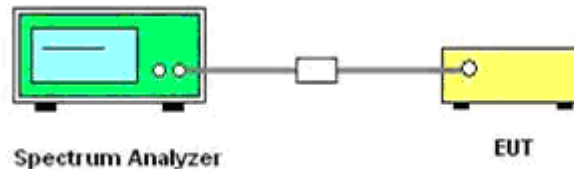


### 5.3. Power Spectral Density Measurement

#### 5.3.1. Standard Applicable

According to §15.247(e): For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

1. The transmitter was connected directly to a Spectrum Analyzer.
2. The power was monitored at the coupler port with a Spectrum Analyzer. The power level was set to the maximum level.
3. Set the RBW = 3 KHz
4. Set the VBW  $\geq 3 \times$  RBW
5. Set the span to 1.5 times the DTS channel bandwidth.
6. Detector = peak.
7. Sweep time = auto couple.
8. Trace mode = max hold.
9. Allow trace to fully stabilize.
10. Use the peak marker function to determine the maximum power level in any 3 kHz band segment within the fundamental EBW.
11. If measured value exceeds limit, reduce RBW (no less than 3 kHz) and repeat.

##### ☒ Maximum Power Spectral Density

1. The transmitter was connected directly to a Spectrum Analyzer.
2. The power was monitored at the coupler port with a Spectrum Analyzer. The power level was set to the maximum level.
3. Set the RBW = 3 KHz~100 KHz.
4. Set the VBW  $\geq 3 \times$  RBW
5. Set the span to 1.5 times the DTS channel bandwidth.
6. Detector = power averaging (rms)
7. Sweep points = 30000
8. Trace mode = max hold.
9. Employ trace averaging (rms) mode over a minimum of 100 traces.
10. Use the peak marker function to determine the maximum power level in any 3 kHz band segment within the fundamental EBW.
11. If measured value exceeds limit, reduce RBW (no less than 3 kHz) and repeat.

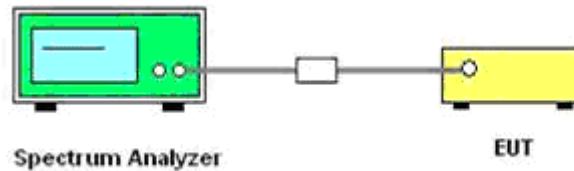


## 5.4. 6 dB Spectrum Bandwidth and Occupied Channel Bandwidth Measurement

### 5.4.1. Standard Applicable

According to §15.247(a) (2): For digital modulation systems, the minimum 6 dB bandwidth shall be at least 500 kHz.

### 5.4.2. Block Diagram of Test Setup



### 5.4.3. Test Procedures

#### 6dB Spectrum Bandwidth Test Procedure:

1. The transmitter output (antenna port) was connected to the spectrum analyzer in peak hold mode.
2. The resolution bandwidth and the video bandwidth were set according to C63.10 11.8.1.
3. Measured the spectrum width with power higher than 6dB below carrier.

#### Occupied Bandwidth Spectrum Bandwidth Test Procedure:

1. The transmitter output (antenna port) was connected to the spectrum analyzer in peak hold mode.
2. The resolution bandwidth and the video bandwidth were set according to C63.10 6.9.3
3. Use the 99% power bandwidth function of the instrument and report the measured bandwidth.

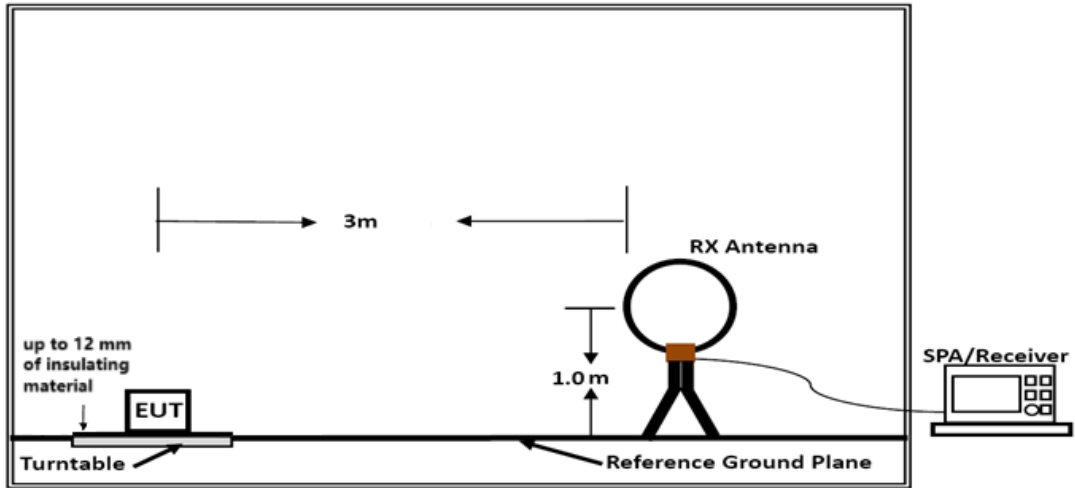

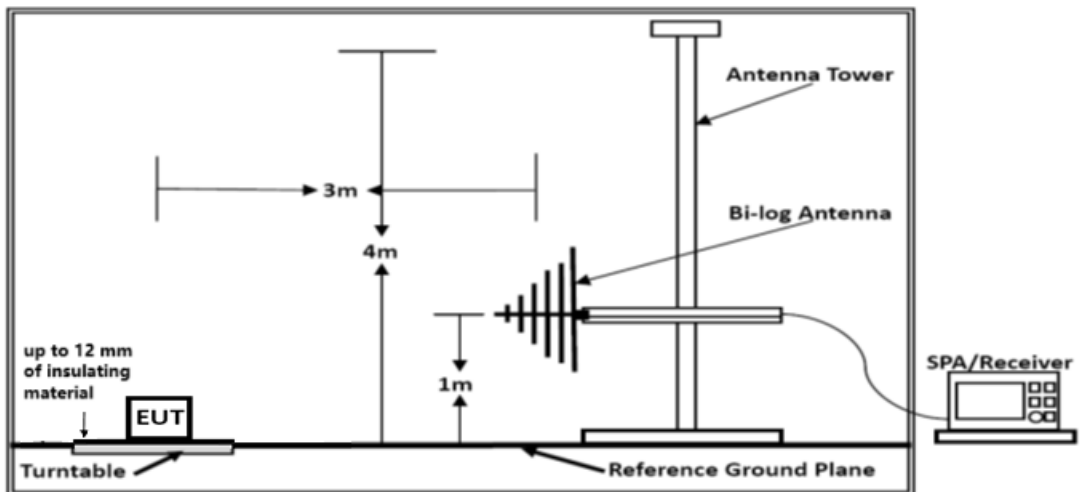

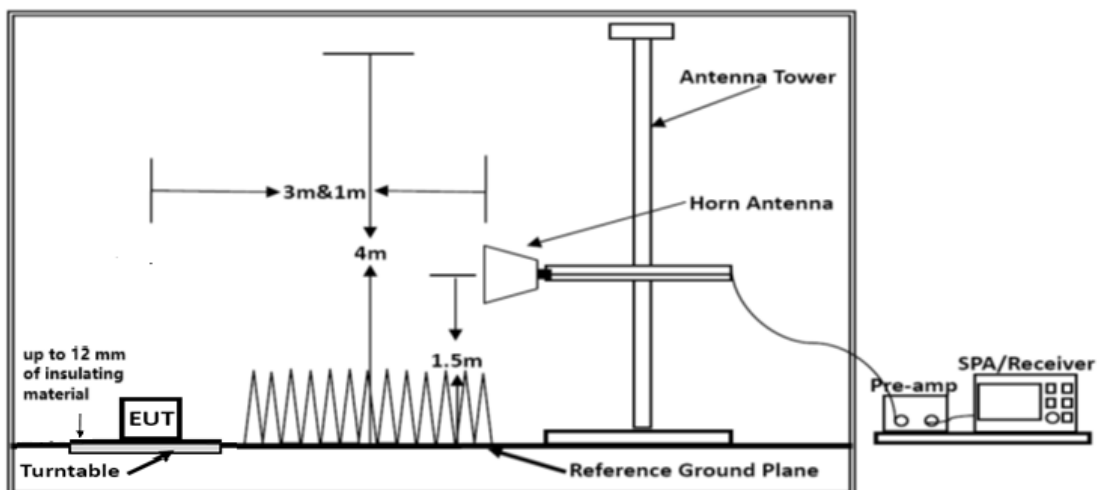

### 5.5.3. Test Procedures

#### 1) Sequence of testing 9 kHz to 30 MHz

##### Setup:

- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- If the EUT is a tabletop system, a rotatable table with 10mm height is used.
- If the EUT is a floor standing device, it is placed on the ground.
- Auxiliary equipment and cables were positioned to simulate normal operation conditions.
- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- The measurement distance is 3 meter.
- The EUT was set into operation.

##### Premeasurement:

- The turntable rotates from 0° to 315° using 45° steps.
- The antenna height is 1.0 meter.
- At each turntable position the analyzer sweeps with peak detection to find the maximum of all emissions

##### Final measurement:

- Identified emissions during the premeasurement the software maximizes by rotating the turntable position (0° to 360°) and by rotating the elevation axes (0° to 360°).
- The final measurement will be done in the position (turntable and elevation) causing the highest emissions with QPK detector.
- The final levels, frequency, measuring time, bandwidth, turntable position, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement and the limit will be stored.

#### 2) Sequence of testing 30 MHz to 1 GHz

##### Setup:

- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- If the EUT is a tabletop system, a table with 10mm height is used, which is placed on the ground plane.
- If the EUT is a floor standing device, it is placed on the ground plane with insulation between both.
- Auxiliary equipment and cables were positioned to simulate normal operation conditions
- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- The measurement distance is 3 meter.
- The EUT was set into operation.

##### Premeasurement:

- The turntable rotates from 0° to 315° using 45° steps.

- The final levels, frequency, measuring time, bandwidth, antenna height, antenna polarization, turntable angle, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement with marked maximum final measurements and the limit will be stored.

#### 3) Sequence of testing 1 GHz to 40 GHz

##### Setup:

- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- If the EUT is a tabletop system, a rotatable table with 10mm height is used.
- If the EUT is a floor standing device, it is placed on the ground plane with insulation between both.
- Auxiliary equipment and cables were positioned to simulate normal operation conditions
- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.



- The measurement distance is 3 meter.
- The EUT was set into operation.

**Premeasurement:**

- The turntable rotates from 0° to 315° using 45° steps.
- The antenna is polarized vertical and horizontal.
- The antenna height scan range is 1 meter to 2.5 meter.
- At each turntable position and antenna polarization the analyzer sweeps with peak detection to find the maximum of all emissions.

**Final measurement:**

- The final measurement will be performed with minimum the six highest peaks.
- According to the maximum antenna and turntable positions of premeasurement the software maximize the peaks by changing turntable position ( $\pm 45^\circ$ ) and antenna movement between 1 and 4 meters. This procedure is repeated for both antenna polarizations.
- The final measurement will be done in the position (turntable, EUT-table and antenna polarization) causing the highest emissions with Peak and Average detector.
- The final levels, frequency, measuring time, bandwidth, turntable position, EUT-table position, antenna polarization, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement with marked maximum final measurements and the limit will be stored.

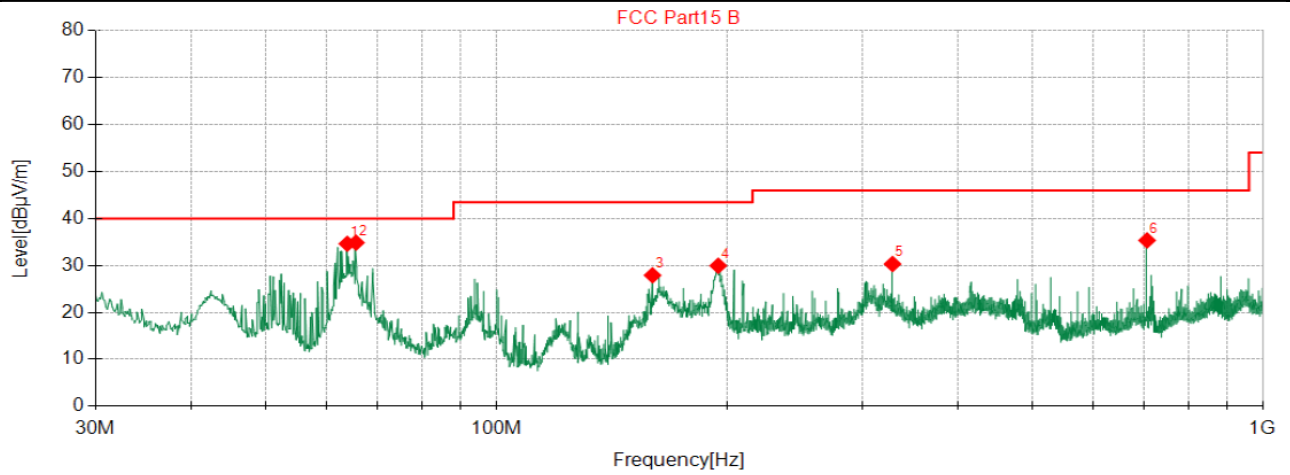

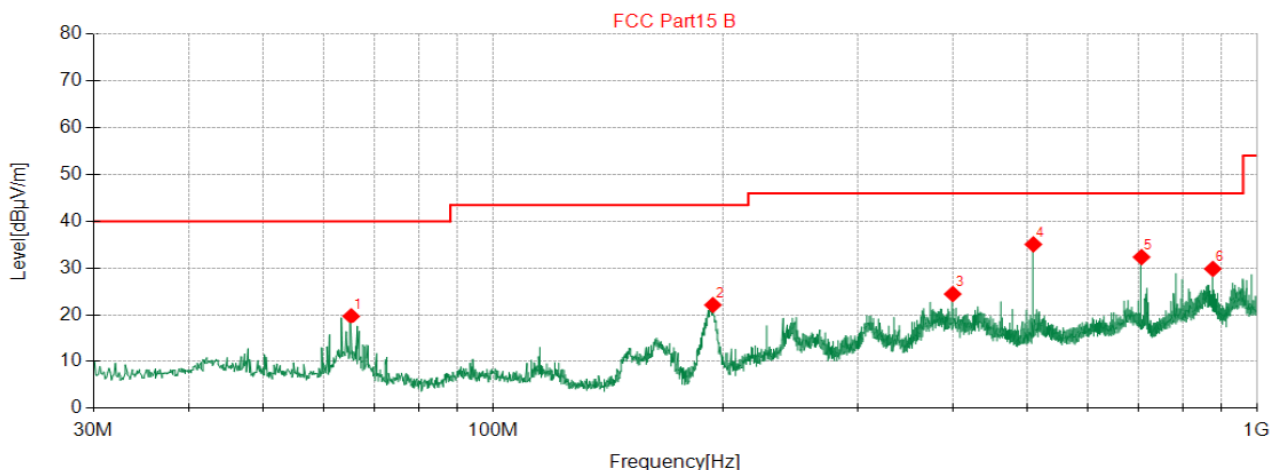

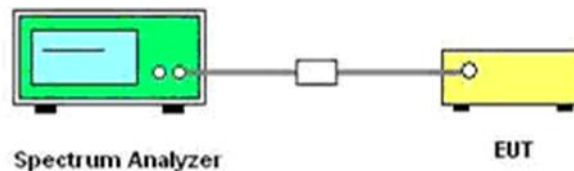
According to §15.247 (d): In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. Attenuation below the general limits specified in Section 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in Section 15.205(a), must also comply with the radiated emission limits specified in Section 15.209(a) (see Section 15.205(c)).

### 5.6.2. Test Procedures

The transmitter output is connected to a spectrum analyzer. The resolution bandwidth is set to 100 kHz. The video bandwidth is set to 300 kHz

The spectrum from 30MHz to 26.5GHz is investigated with the transmitter set to the lowest, middle, and highest channels.

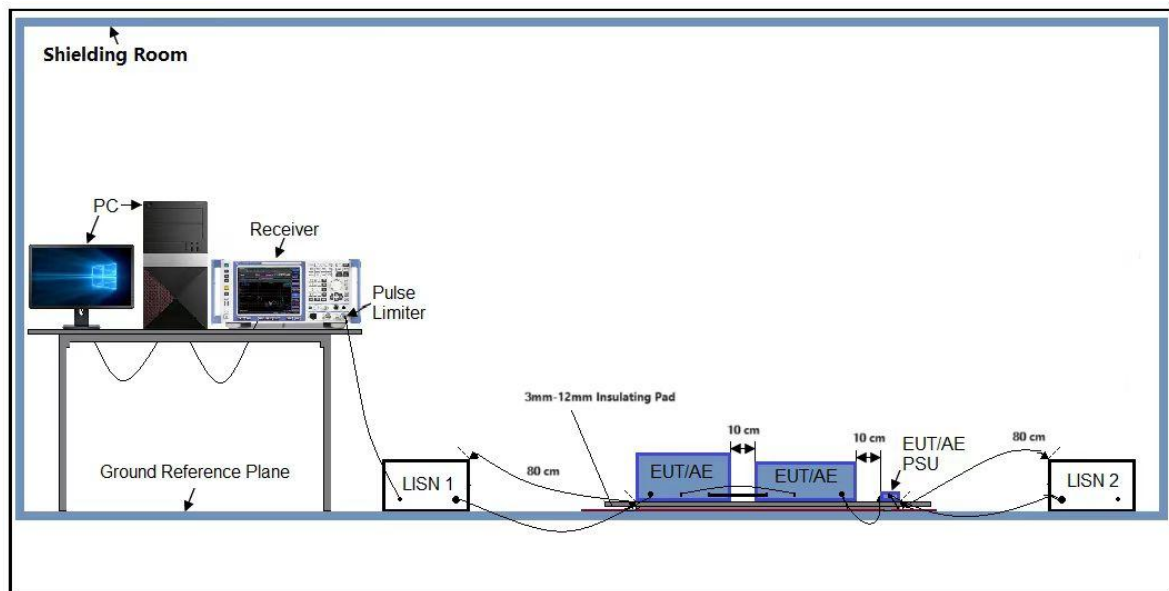

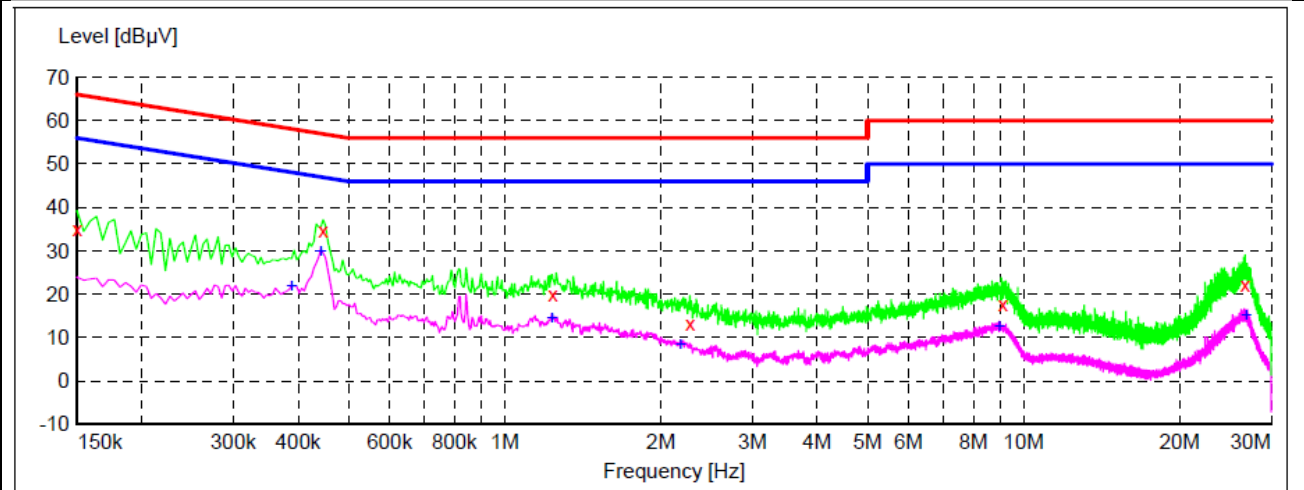

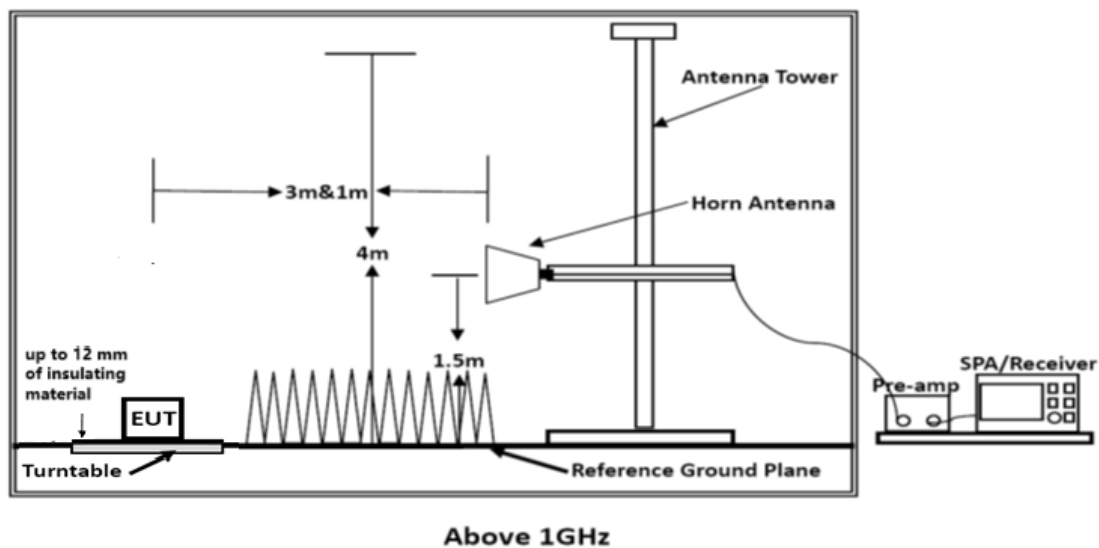
## 5.8. Band-Edge Measurements For Radiated Emissions

### 5.8.1. Standard Applicable

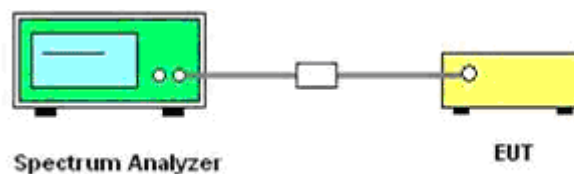
In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

### 5.8.3. Test Procedures

☒ Radiated Method:

1. The EUT was placed on a turn table which is 10mm above ground plane.
2. Maximum procedure was performed by raising the receiving antenna from 1m to 4m and rotating the turn table from 0° to 360° to acquire the highest emissions from EUT.
3. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
4. Repeat above procedures until all frequency measurements have been completed.

☐ **Conducted Method:**

According to KDB 558074 D01 for Antenna-port conducted measurement. Antenna-port conducted measurements may also be used as an alternative to radiated measurements for demonstrating compliance in the restricted frequency bands. If conducted measurements are performed, then proper impedance matching must be ensured and an additional radiated test for cabinet/case spurious emissions is required.

1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
2. Remove the antenna from the EUT and then connect to a low loss RF cable from the antenna port to an EMI test receiver, then turn on the EUT and make it operate in transmitting mode. Then set it to Low Channel and High Channel within its operating range, and make sure the instrument is operated in its linear range.
3. Set both RBW and VBW of spectrum analyzer to 100 kHz with a convenient frequency span including 100kHz bandwidth from band edge, for Radiated emissions restricted band RBW=1MHz, VBW=3MHz for peak detector and RBW=1MHz, VBW=3MHz for AV detector.
4. Measure the highest amplitude appearing on spectral display and set it as a reference level. Plot the graph with marking the highest point and edge frequency.
5. Repeat above procedures until all measured frequencies were complete.
6. Measure the conducted output power (in dBm) using the detector specified by the appropriate regulatory agency (see 12.2.2, 12.2.3, and 12.2.4 for guidance regarding measurement procedures for determining quasi-peak, peak, and average conducted output power, respectively).
7. Add the maximum transmit antenna gain (in dBi) to the measured output power level to determine the EIRP level (see 12.2.5 for guidance on determining the applicable antenna gain)
8. Add the appropriate maximum ground reflection factor to the EIRP level (6 dB for frequencies  $\leq 30$  MHz, 4.7 dB for frequencies between 30 MHz and 1000 MHz, inclusive and 0 dB for frequencies  $> 1000$  MHz).
9. For devices with multiple antenna-ports, measure the power of each individual chain and sum the EIRP of all chains in linear terms (e.g., Watts, mW).
10. Convert the result ant EIRP level to an equivalent electric field strength using the following relationship:

$$E = \text{EIRP} - 20\log D + 104.77 = \text{EIRP} + 95.23$$

Where:

E = electric field strength in dB $\mu$ V/m,

EIRP = equivalent isotropic radiated power in dBm

D = specified measurement distance in meters.

11. Since the out-of-band characteristics of the EUT transmit antenna will often be unknown, the use of a conservative antenna gain value is necessary. Thus, when determining the EIRP based on the measured conducted power, the upper bound on antenna gain for a device with a single RF output shall be selected as the maximum in-band gain of the antenna across all operating bands, or 2 dBi, whichever is greater. However, for devices that operate in multiple frequency bands while using the same transmit antenna, the highest gain of the antenna within the operating band nearest in frequency to the restricted band emission being measured may be used in lieu of the overall highest



gain when the emission is at a frequency that is within 20 percent of the nearest band edge frequency, but in no case shall a value less than 2 dBi be used.

12. Per KDB662911 D01 section b) In cases where a combination of conducted measurements and cabinet radiated measurements are permitted to demonstrate compliance with absolute radiated out-of-band and spurious limits (e.g., KDB Publications 558074 for DTS and 789033 for U-NII), the conducted measurements must be combined with directional gain to compute the radiated levels of the out-of-band and spurious emissions as described in this section.
13. Compare the resultant electric field strength level to the applicable regulatory limit.
14. Perform radiated spurious emission test duress until all measured frequencies were complete.

## **5.9. Antenna Requirements**

### **5.9.1. Standard Applicable**

According to antenna requirement of §15.203.

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be re-placed by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of Sections 15.211, 15.213, 15.217, 15.219, or 15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with Section 15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this Part are not exceeded.

And according to §15.247(4)(1), system operating in the 2400-2483.5MHz bands that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum peak output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6dBi.

### **5.9.2. Antenna Connector Construction**

The directional gains of antenna used for transmitting is refer to section 1.3 of this report, and the antenna is an internal antenna connect to PCB board and no consideration of replacement. Please see EUT photo for details.
