



7.2.4 Measurement Procedure and Data

- 1) The mains terminal disturbance voltage test was conducted in a shielded room.
- 2) The EUT was connected to AC power source through a LISN 1 (Line Impedance Stabilization Network) which provides a $50 \text{ohm}/50 \mu\text{H} + 5 \text{ohm}$ linear impedance. 








