This document describes the Cinterion® PLSx3-X and PLSx3-X2 hardware design differences, including:

- Changes from PLSx3-X Rev. 2.2 to PLSx3-X2 Rev. 2.2
- Differences between PLS83-X/X2 Rev. 2.2 and PLS63-X/X2 Rev. 2.2

As US operator projects, PLSx3-X2 variants support different bands from base variants PLSx3-X, as shown in Table 1. Both variants use the same footprint and PCB layout. Different hardware IDs are implemented to identify different variants.

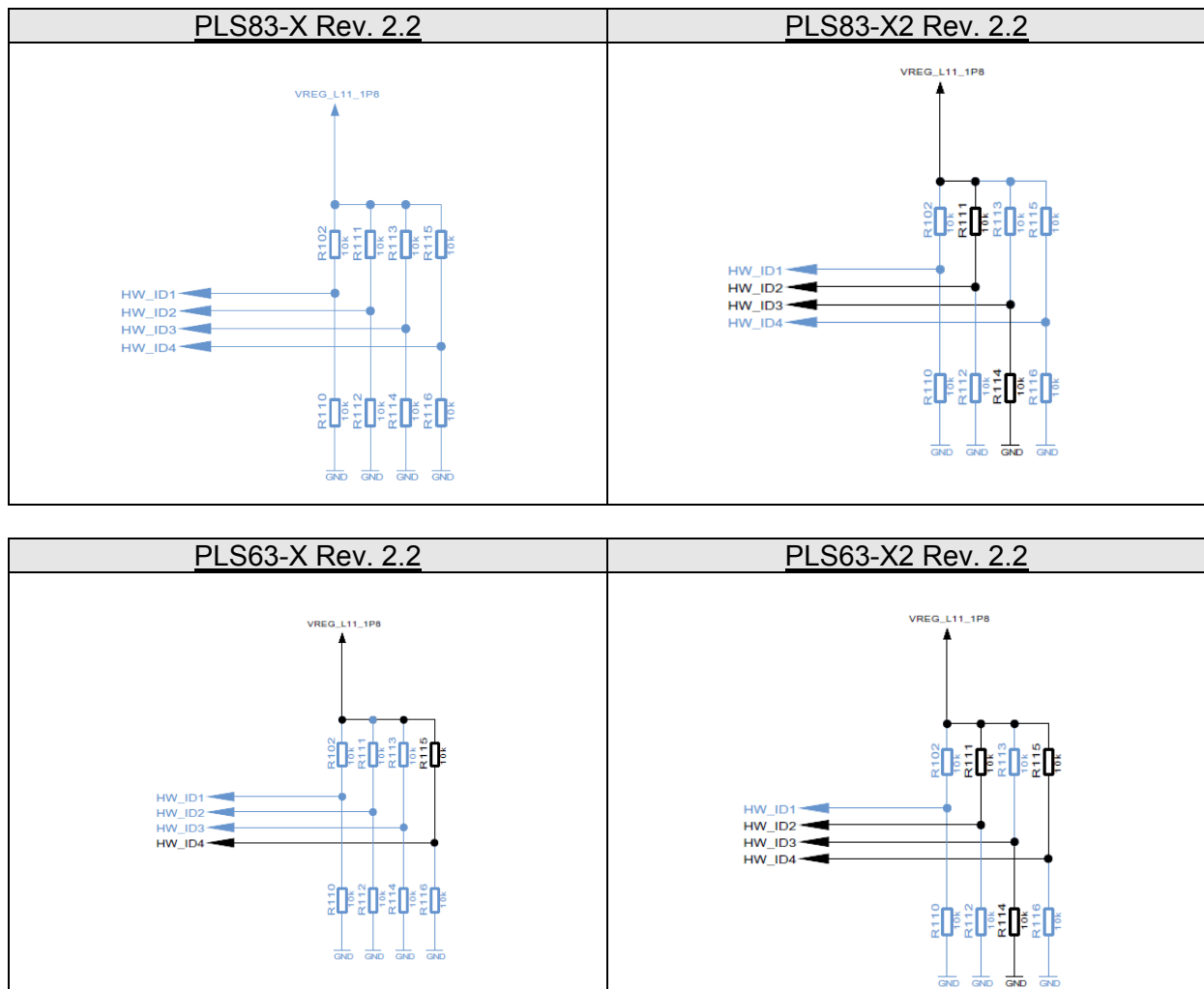

The following section highlights the schematic differences on baseband between PLSx3-X Rev. 2.2 and PLSx3-X2 Rev. 2.2. Different hardware IDs are implemented to identify different variants.

Note: Components in black are populated, components in blue are not populated.



PLS83-X/X2 Rev. 2.2 are designed with a Cat. 4 processor, while PLS63-X/X2 is based on a Cat. 1 processor. The two processors are pin-pin compatible.
