

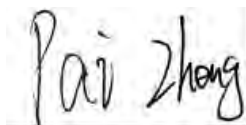

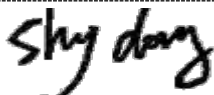

#### 3.1. Antenna Requirement

##### Requirement

##### **FCC CFR Title 47 Part 15 Subpart C Section 15.203:**

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

##### **FCC CFR Title 47 Part 15 Subpart C Section 15.247(c) (1)(i):**

(i) Systems operating in the 2400~2483.5 MHz band that is used exclusively for fixed. Point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6dBi.

##### Test Result

The antenna gain is 2.97dB, the directional gain of the antenna less than 6dBi. It comply with the standard requirement. In case of replacement of broken antenna the same antenna type must be used.

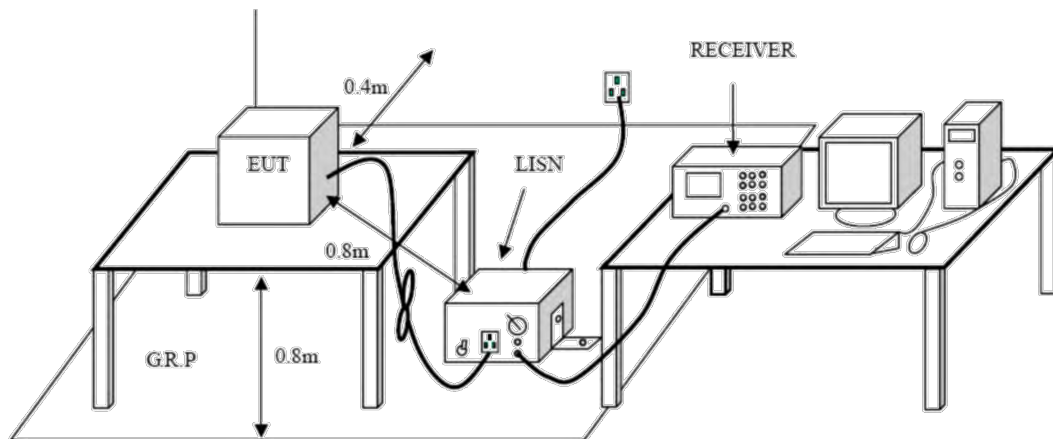

## Test Procedure

1. The EUT was setup according to ANSI C63.10:2020 requirements.
2. The EUT was placed on a platform of nominal size, 1 m by 1.5 m, raised 80 cm above the conducting ground plane. The vertical conducting plane was located 40 cm to the rear of the EUT. All other surfaces of EUT were at least 80 cm from any other grounded conducting surface.
3. The EUT and simulators are connected to the main power through a line impedances stabilization network (LISN). The LISN provides a 50ohm /50uH coupling impedance for the measuring equipment.  
The peripheral devices are also connected to the main power through a LISN. (Please refer to the block diagram of the test setup and photographs)
4. Each current-carrying conductor of the EUT power cord, except the ground (safety) conductor, was individually connected through a LISN to the input power source.
5. The excess length of the power cord between the EUT and the LISN receptacle were folded back and forth at the center of the lead to form a bundle not exceeding 40 cm in length.
6. Conducted Emissions were investigated over the frequency range from 0.15MHz to 30MHz using a receiver bandwidth of 9 kHz.
7. During the above scans, the emissions were maximized by cable manipulation.

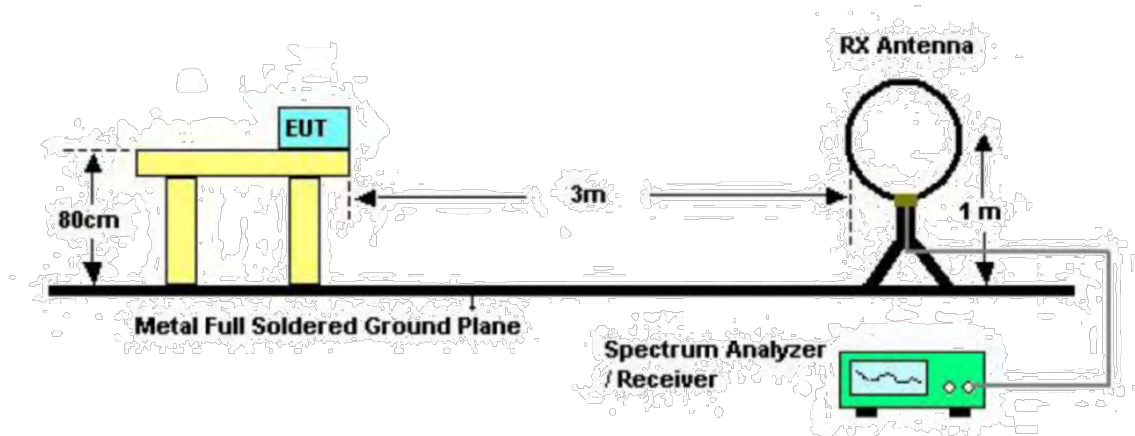

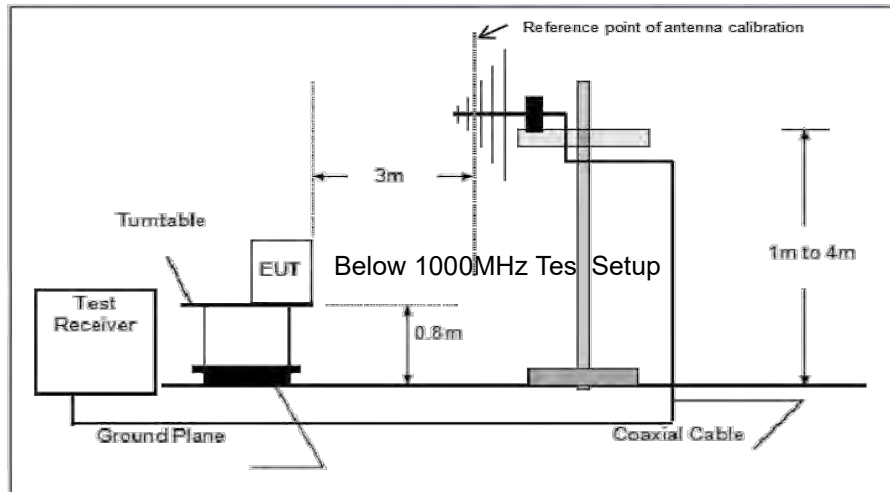

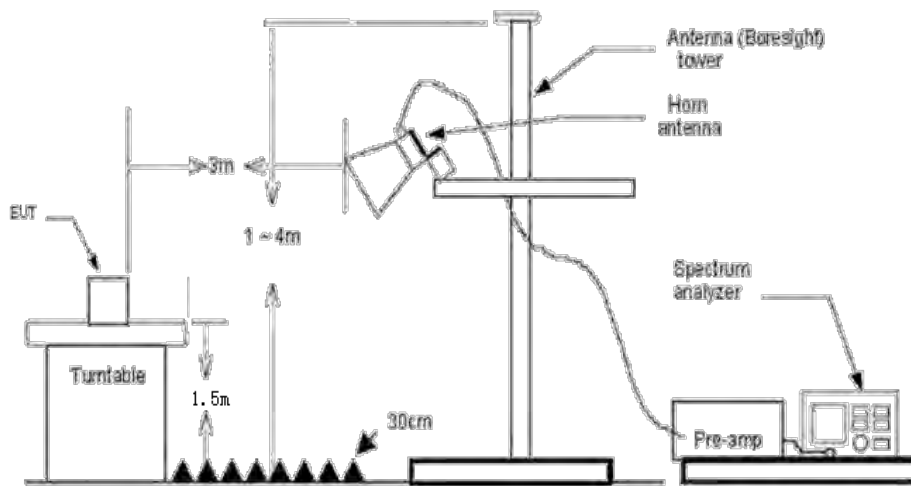
#### Test Configuration

### Test Procedure

1. The EUT was setup and tested according to ANSI C63.10:2020
2. The EUT is placed on a turn table which is 0.8 meter above ground for below 1 GHz, and 1.5 m for above 1 GHz. The turn table is rotated 360 degrees to determine the position of the maximum emission level.
3. The EUT was set 3 meters from the receiving antenna, which was mounted on the top of a variable height antenna tower.
4. For each suspected emission, the EUT was arranged to its worst case and then tune the Antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level to comply with the guidelines.
5. Set to the maximum power setting and enable the EUT transmit continuously.
6. Use the following spectrum analyzer settings
  - (1) Span shall wide enough to fully capture the emission being measured;
  - (2) Below 1 GHz:  
RBW=120 kHz, VBW=300 kHz, Sweep=auto, Detector function=peak, Trace=max hold;

If the emission level of the EUT measured by the peak detector is 3 dB lower than the applicable limit, the peak emission level will be reported. Otherwise, the emission measurement will be repeated using the quasi-peak detector and reported.

(3) From 1 GHz to 10<sup>th</sup> harmonic:

RBW=1MHz, VBW=3MHz Peak detector for Peak value.

RBW=1MHz, VBW=10Hz Peak detector for Peak value.

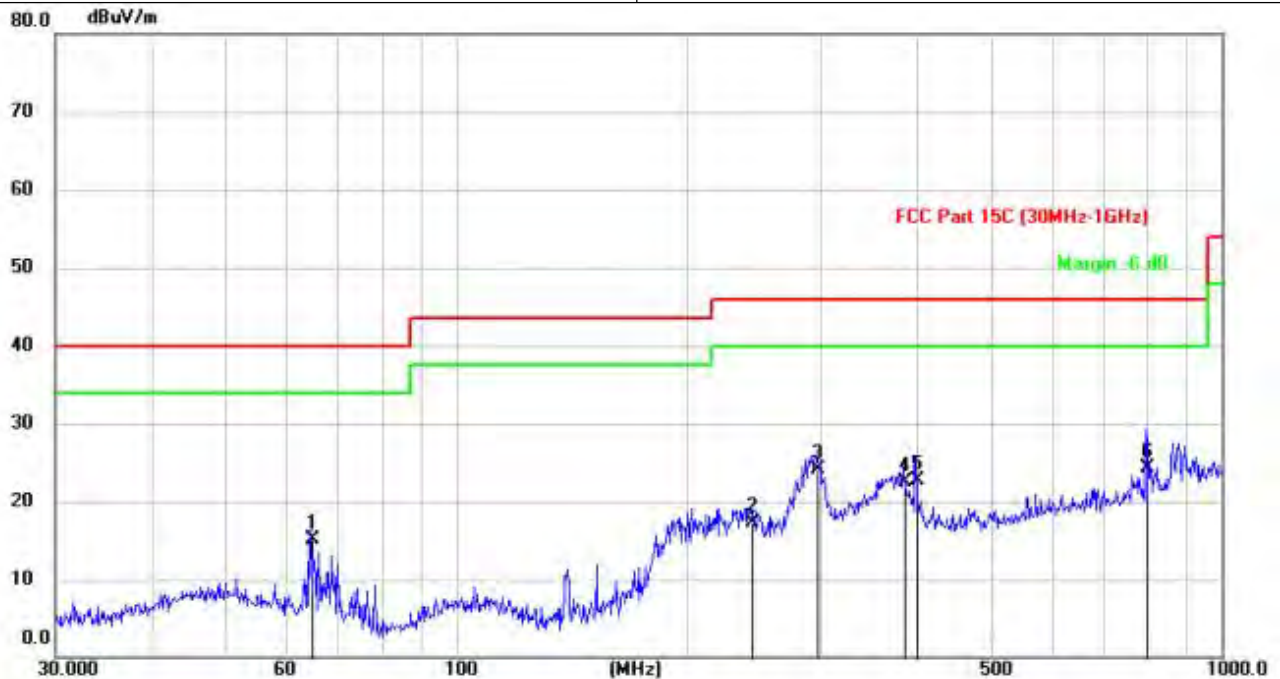

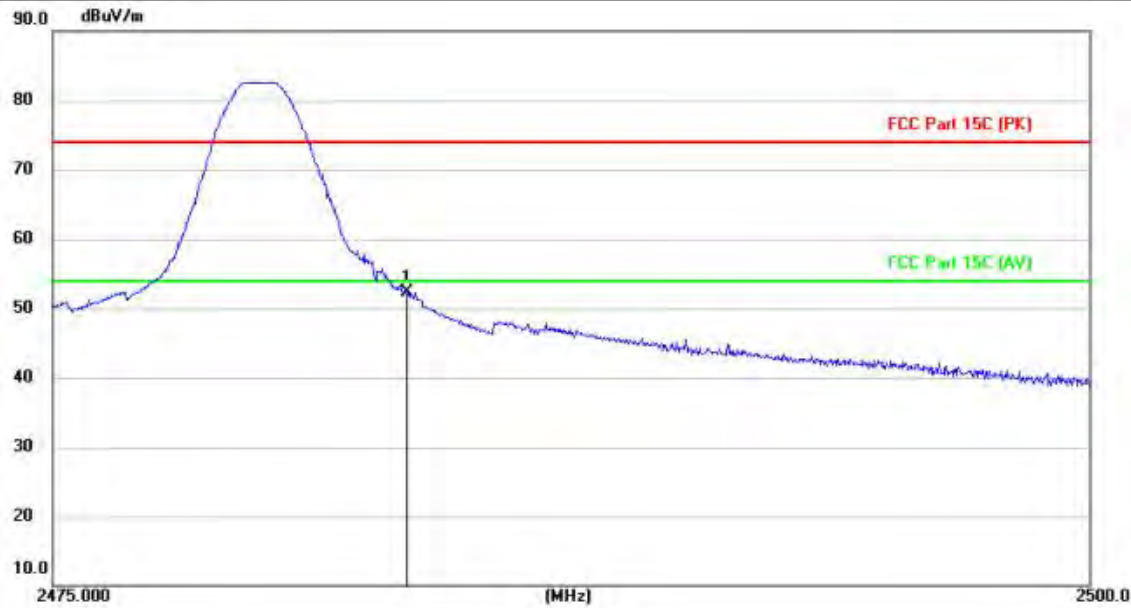

#### Test Procedure

The zero-span mode on a spectrum analyzer or EMI receiver if the response time and spacing between bins on the sweep are sufficient to permit accurate measurements of the on and off times of the transmitted signal. Set the center frequency of the instrument to the center frequency of the transmission. Set RBW  $\geq$  OBW if possible; otherwise, set RBW to the largest available value. Set VBW  $\geq$  RBW. Set detector = peak or average. The zero-span measurement method shall not be used unless both RBW and VBW are  $> 50/T$  and the number of sweep points across duration T exceeds 100. (For example, if VBW and/or RBW are limited to 3 MHz, then the zero-span method of measuring duty cycle shall not be used if  $T \leq 16.7$  microseconds.)

The transmitter output is connected to the Spectrum Analyzer. We tested according to the zero-span measurement method, 6.0(b) in KDB 558074 D01 DTS Meas Guidance v05r02.

The largest available value of RBW is 8 MHz and VBW is 50 MHz. The zero-span method of measuring duty cycle shall not be used if  $T \leq 6.25$  microseconds. ( $50/6.25 = 8$ )

The zero-span method was used because all measured T data are  $> 6.25$  microseconds and both RBW and VBW are  $> 50/T$ .

The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator.

The path loss was compensated to the results for each measurement.

Set to the maximum power setting and enable the EUT transmit continuously.

The EUT was operating in controlled its channel.

Use the following spectrum analyzer settings:

Span = Zero Span

RBW = 8MHz (the largest available value)

VBW = 8MHz ( $\geq$  RBW)

Number of points in Sweep  $> 100$

Detector function = peak

Trace = Clear write

Measure Total and Ton

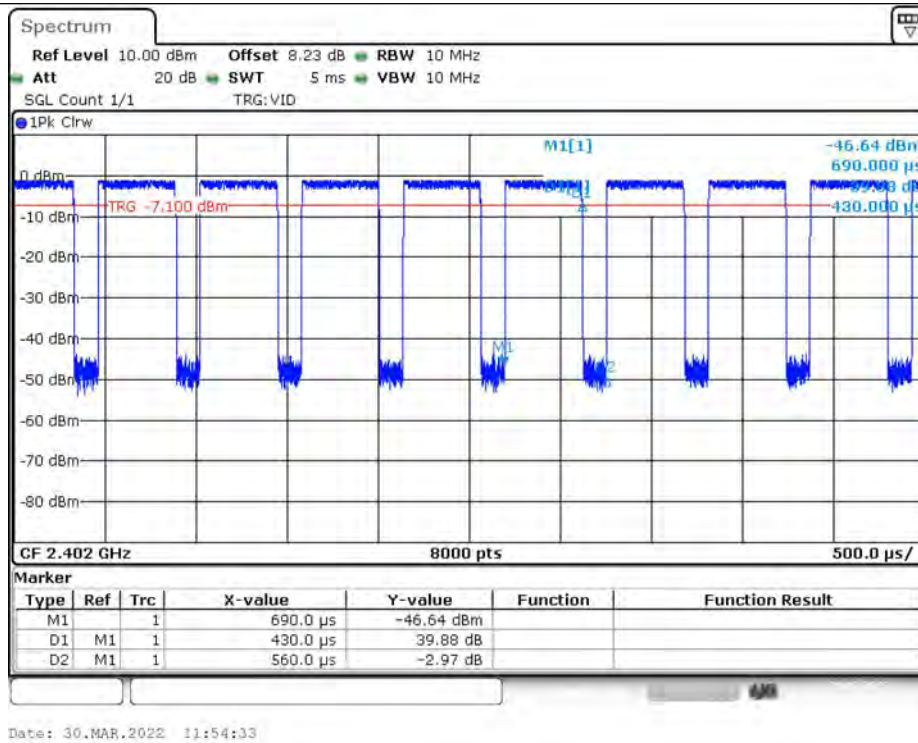

#### **FCC CFR Title 47 Part 15 Subpart C Section 15.247 (d):**

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement.

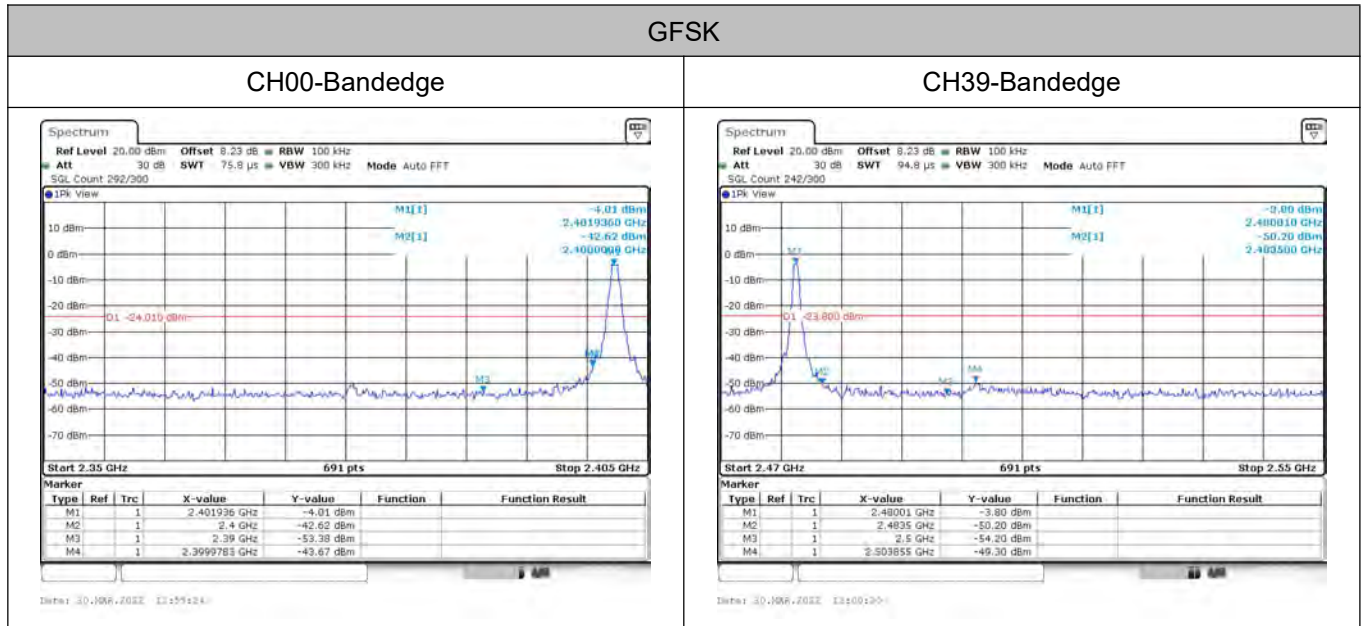

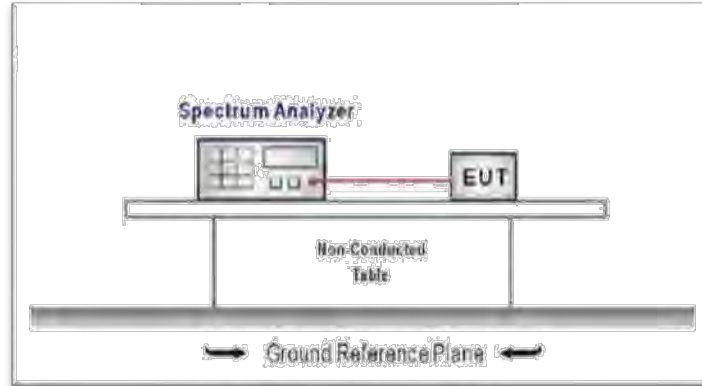

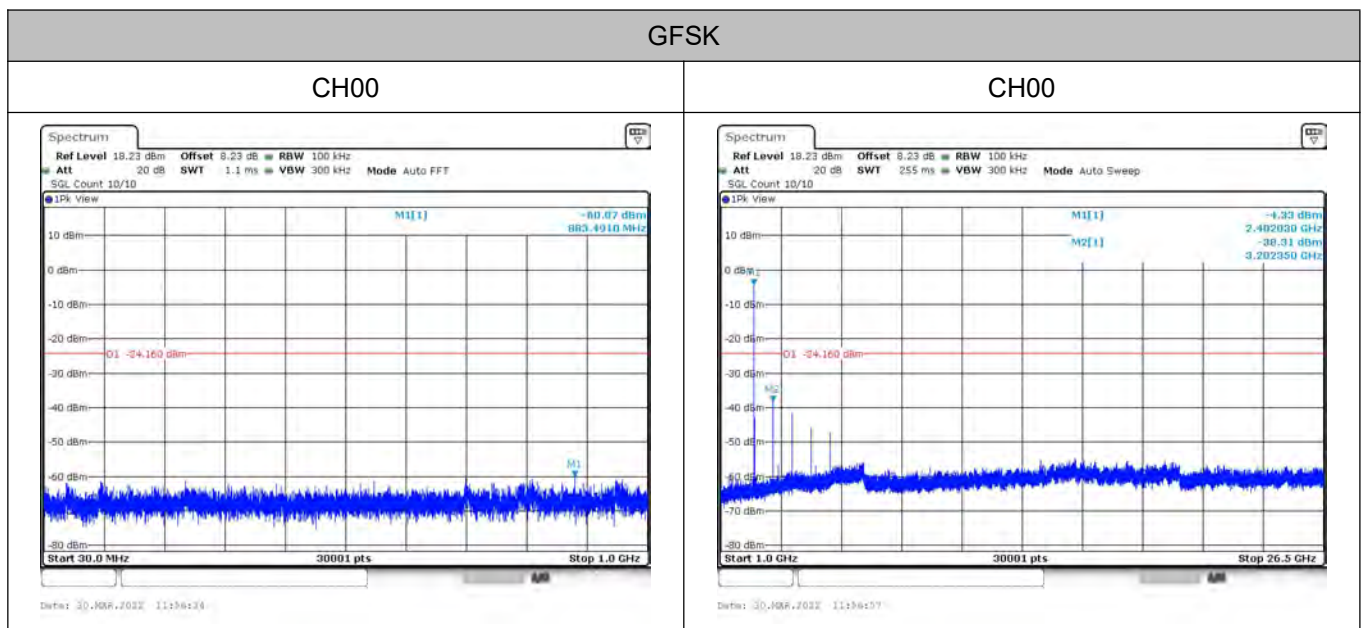
#### Test Procedure

The Spurious RF conducted emissions compliance of RF radiated emission should be measured by following the guidance in ANSI C63.10-2013 with respect to maximizing the emission by rotating the EUT, measuring the emission while the EUT is situated in three orthogonal planes (if appropriate), adjusting the measurement antenna height and polarization etc. Set RBW=100kHz and VBW= 300kHz to measure the peak field strength, and measure frequency range from 30MHz to 26.5GHz.

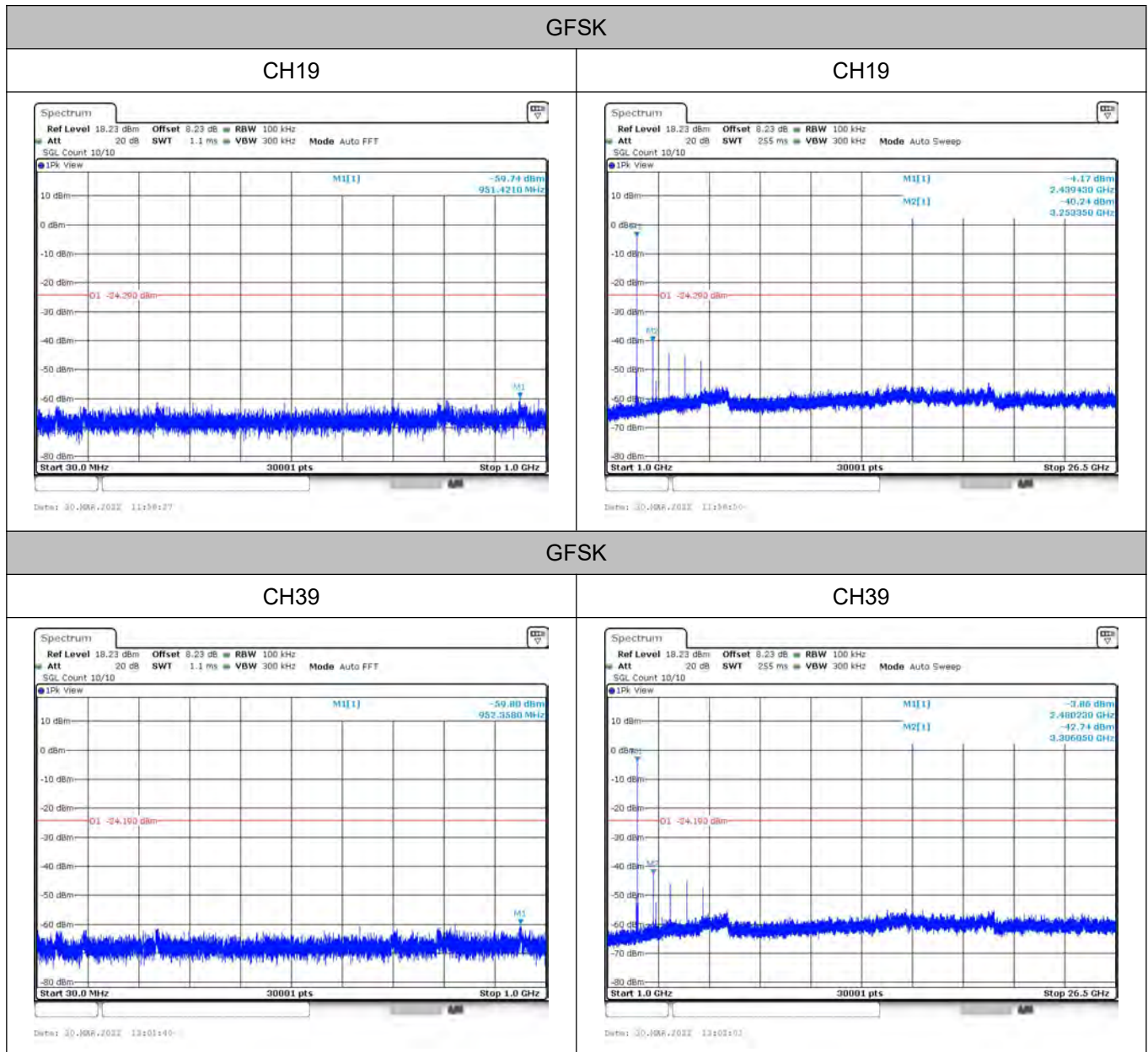

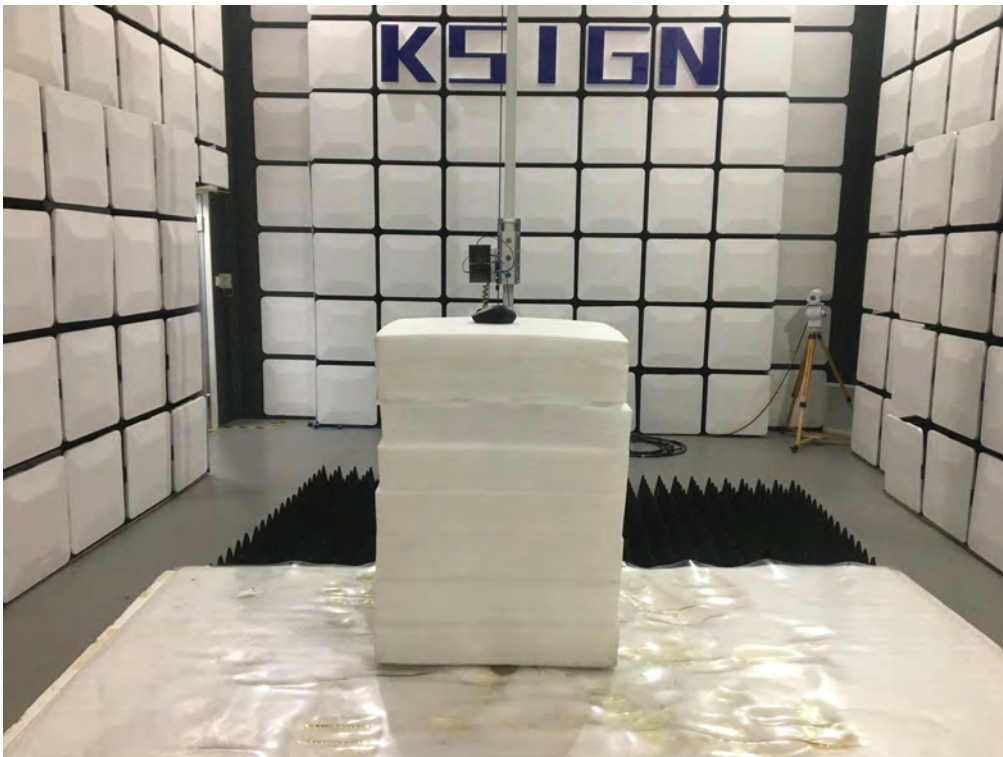
