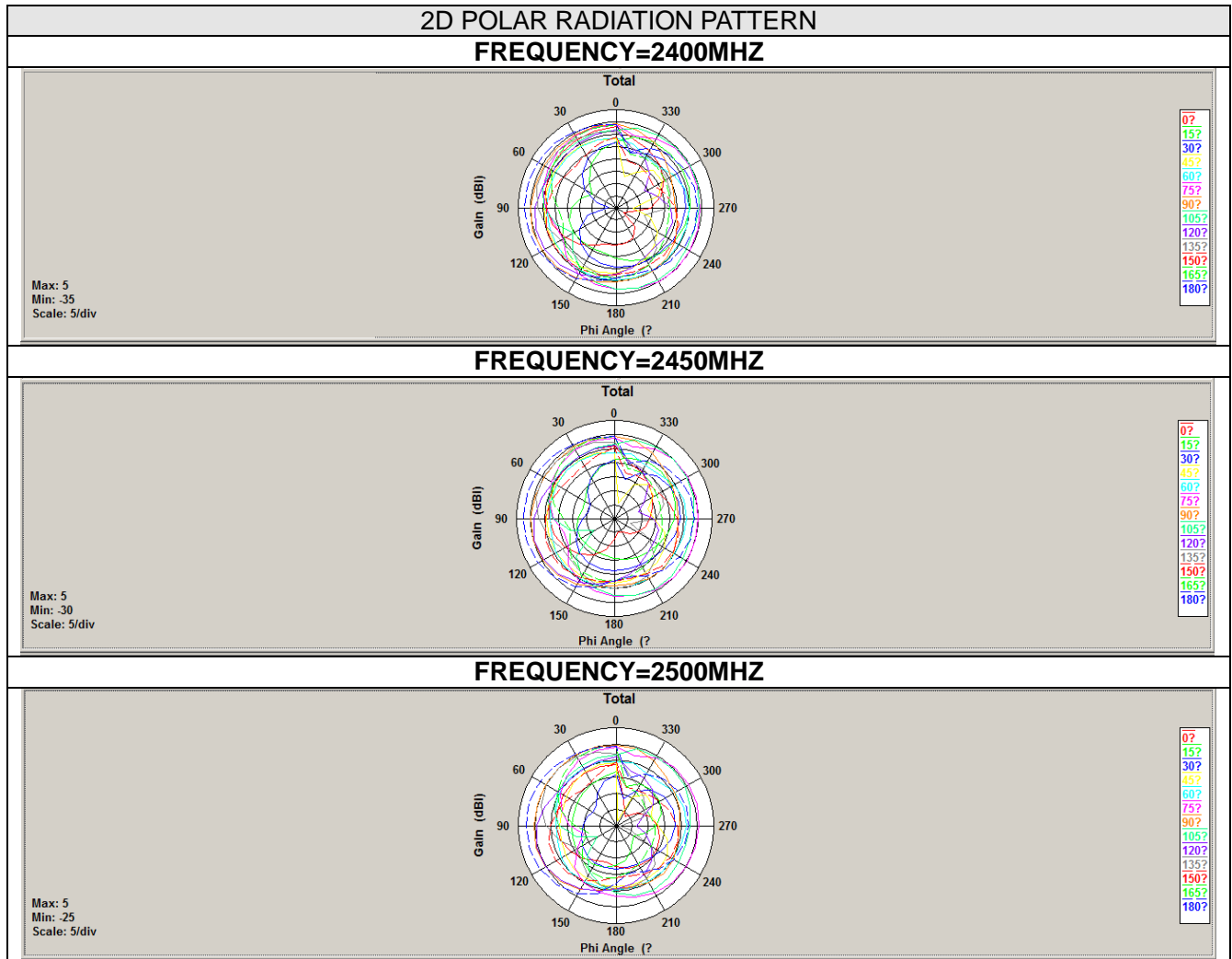

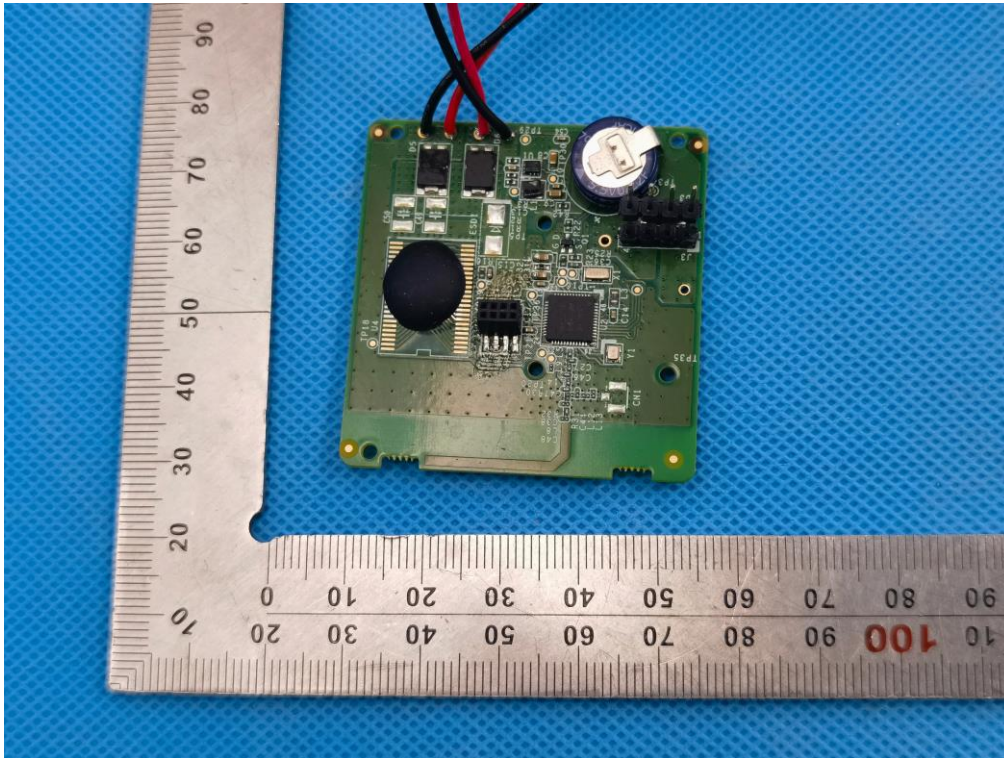

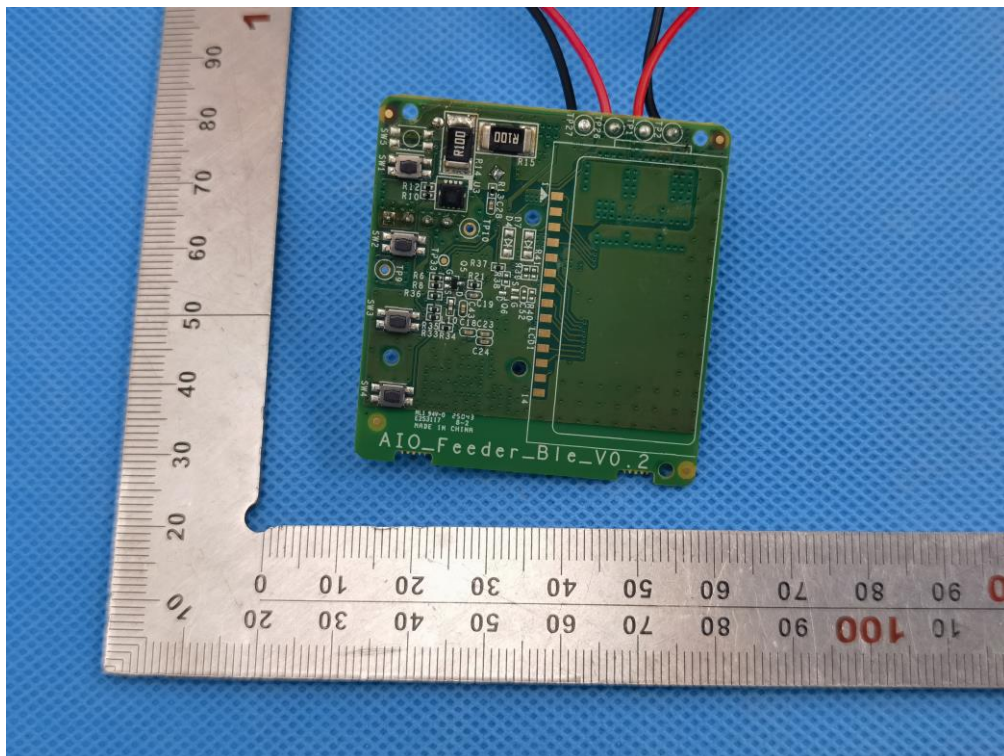

ANTENNA VIEW (FIGURE 2)



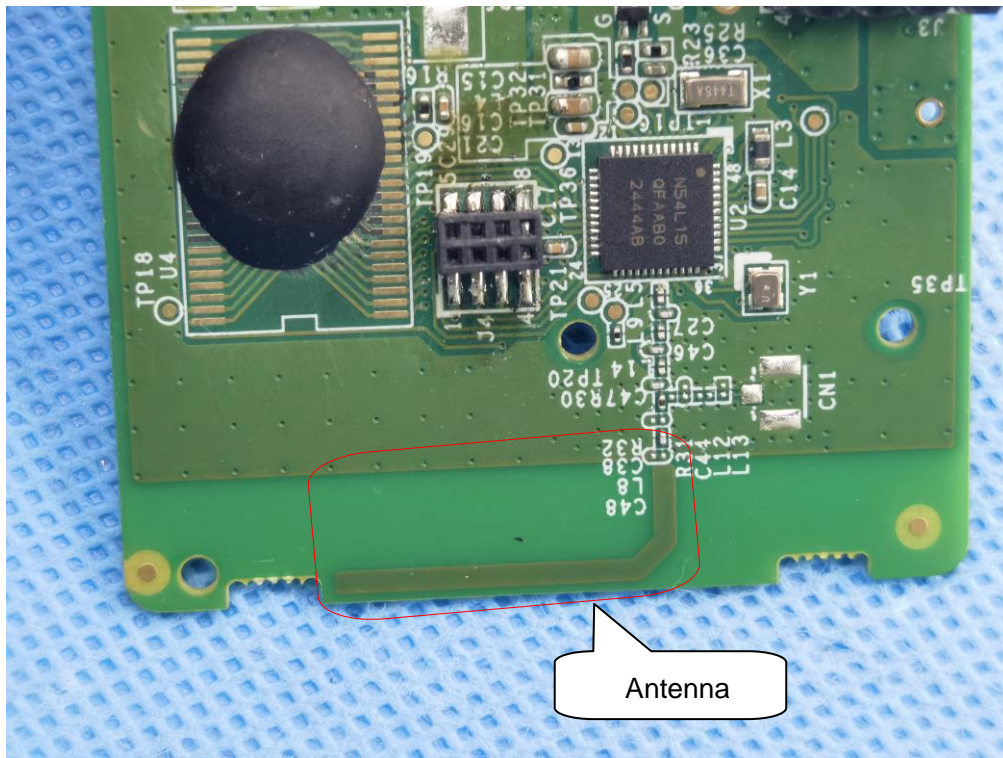

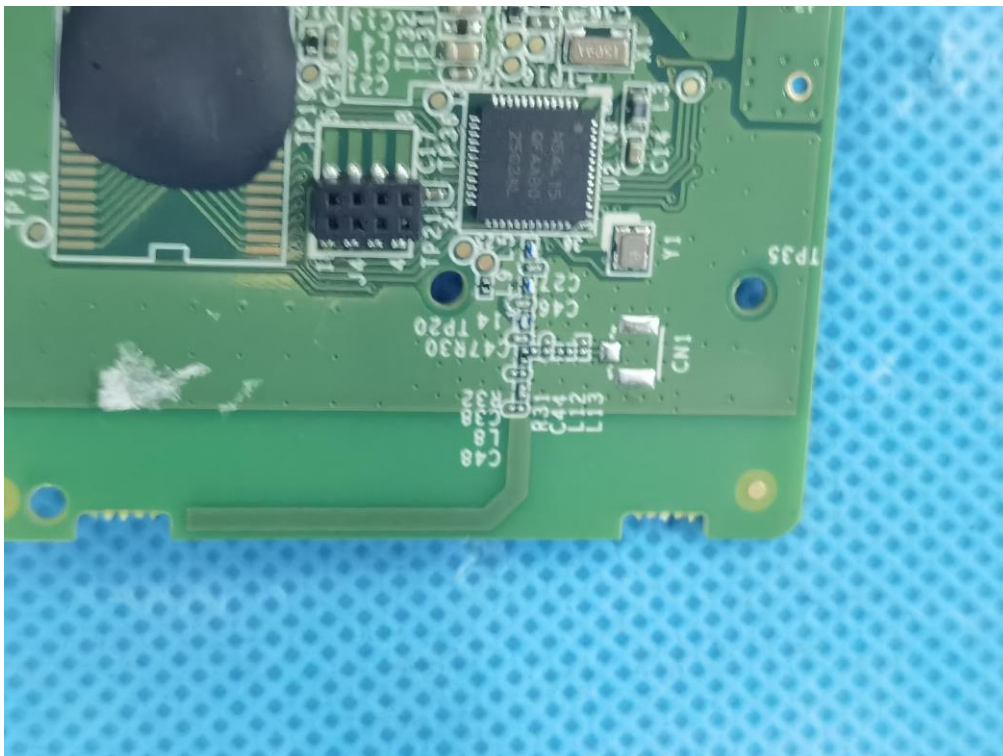
