

SETUP DIAGRAM FOR TESTS



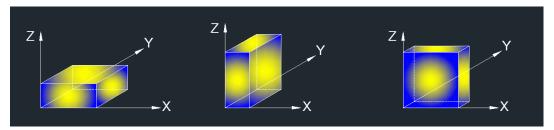
