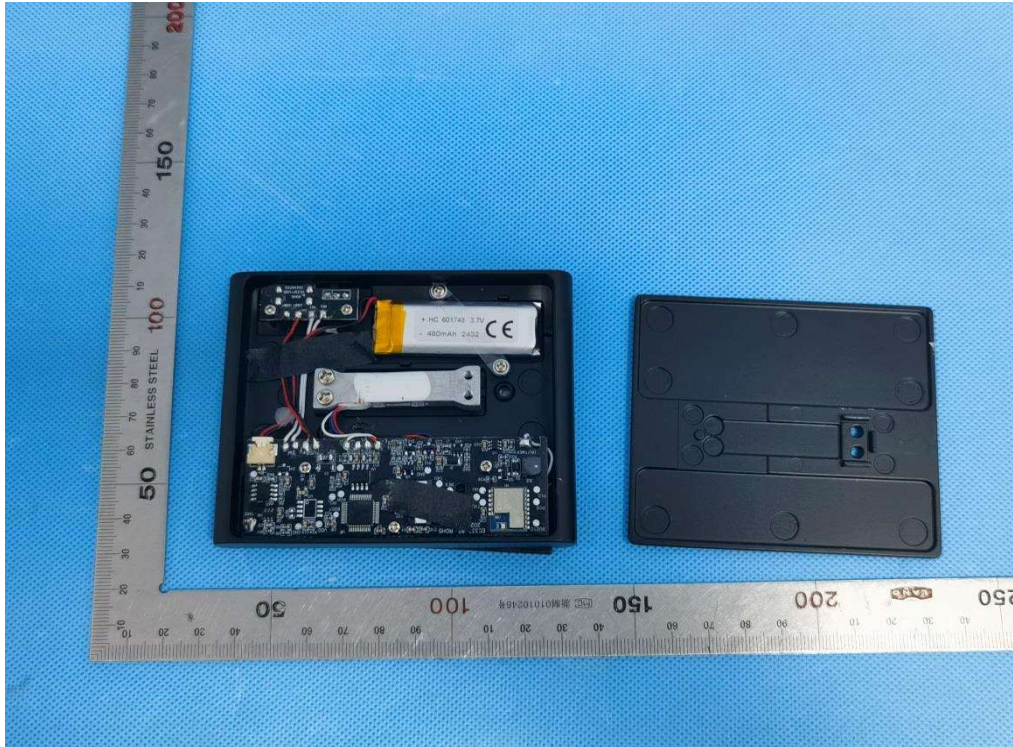

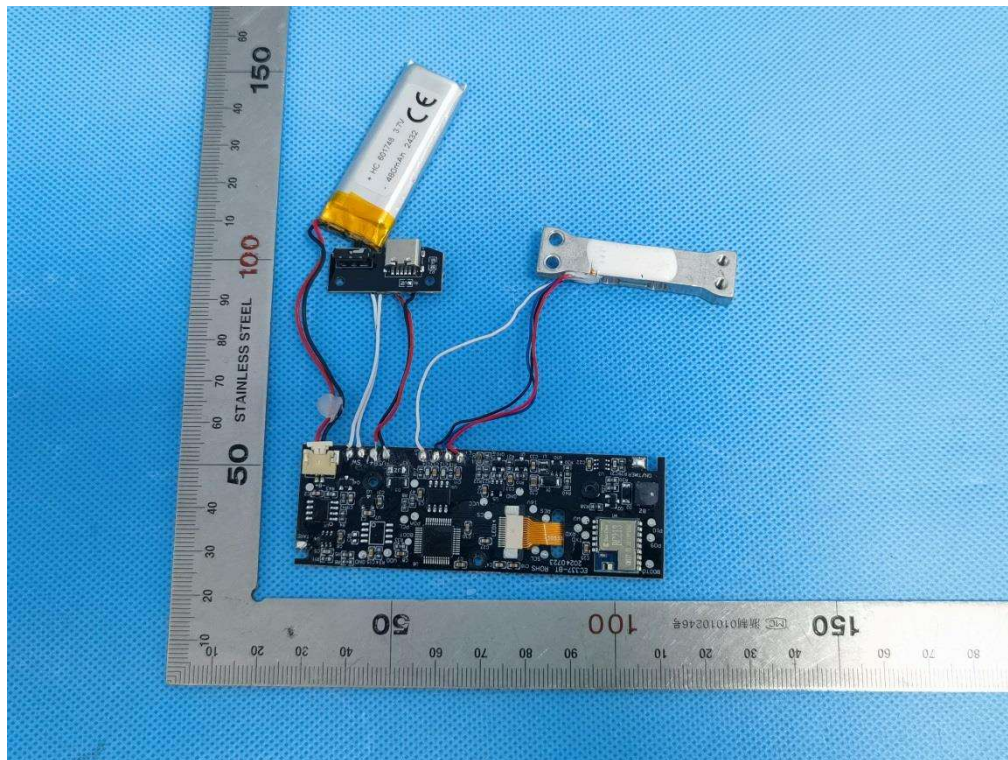

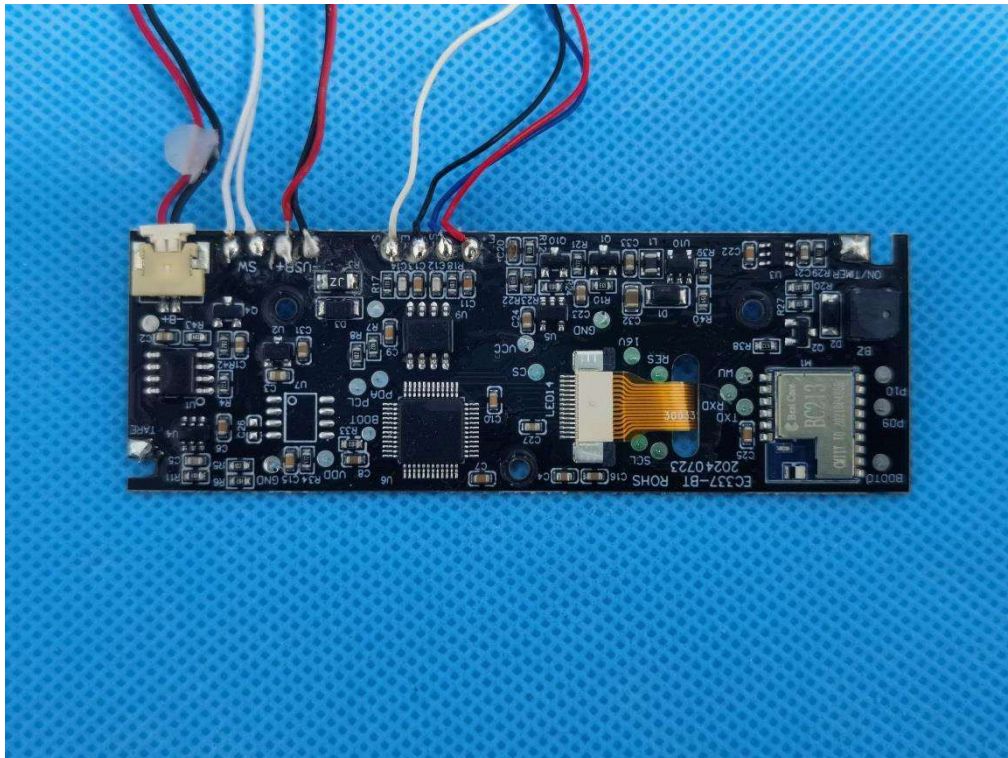

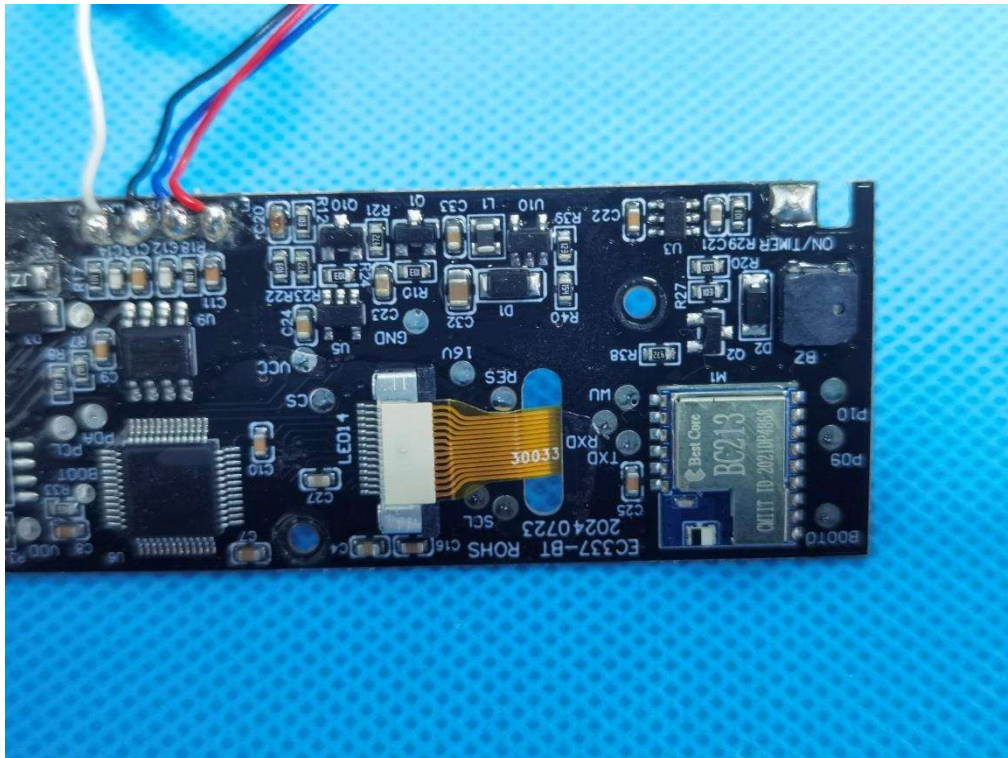

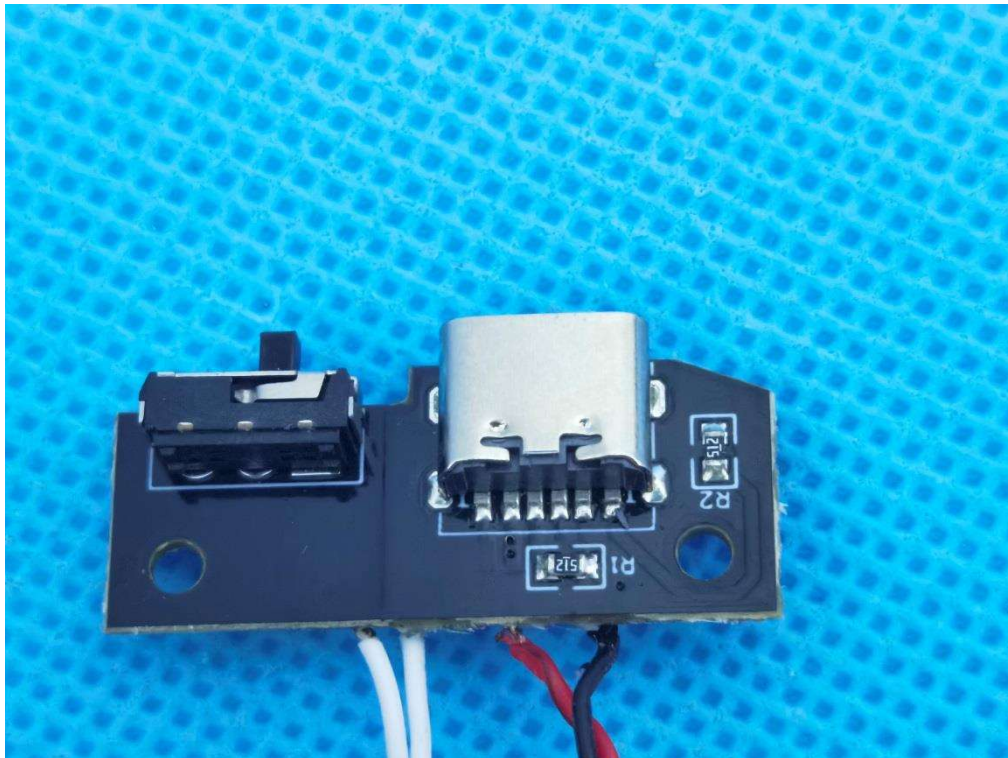

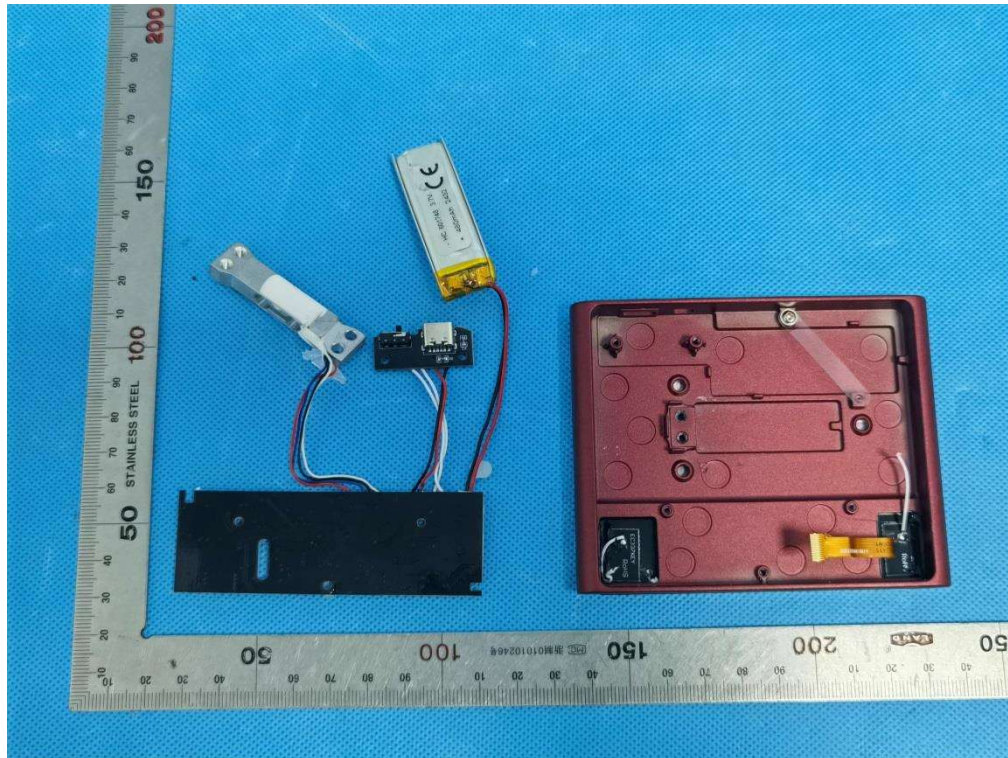

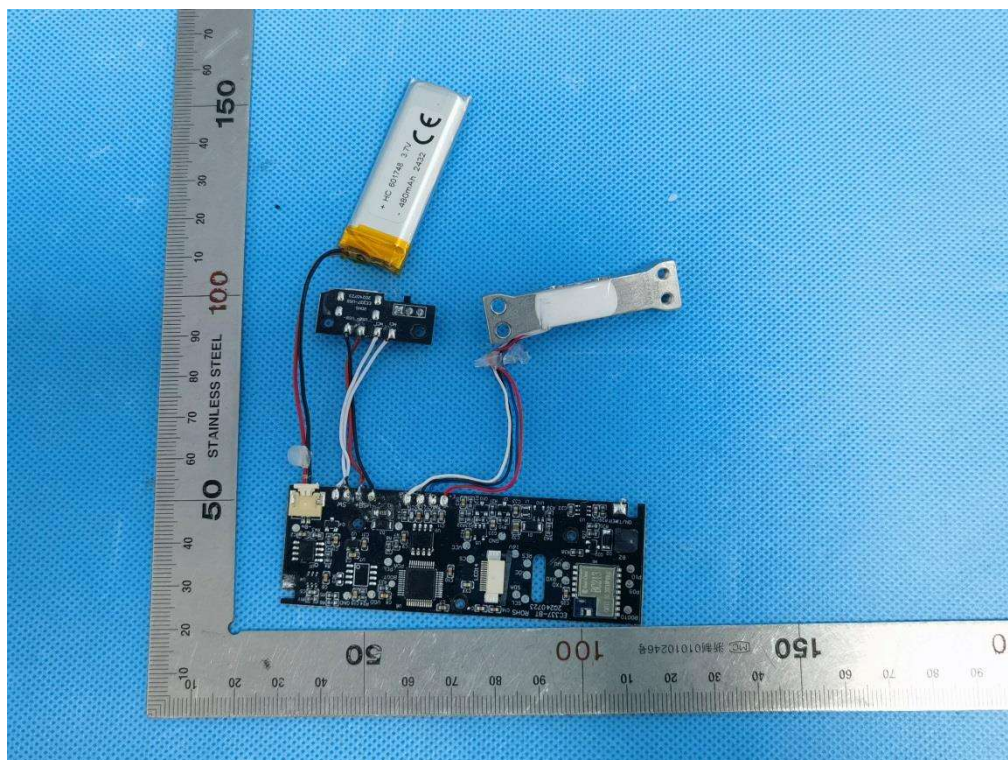

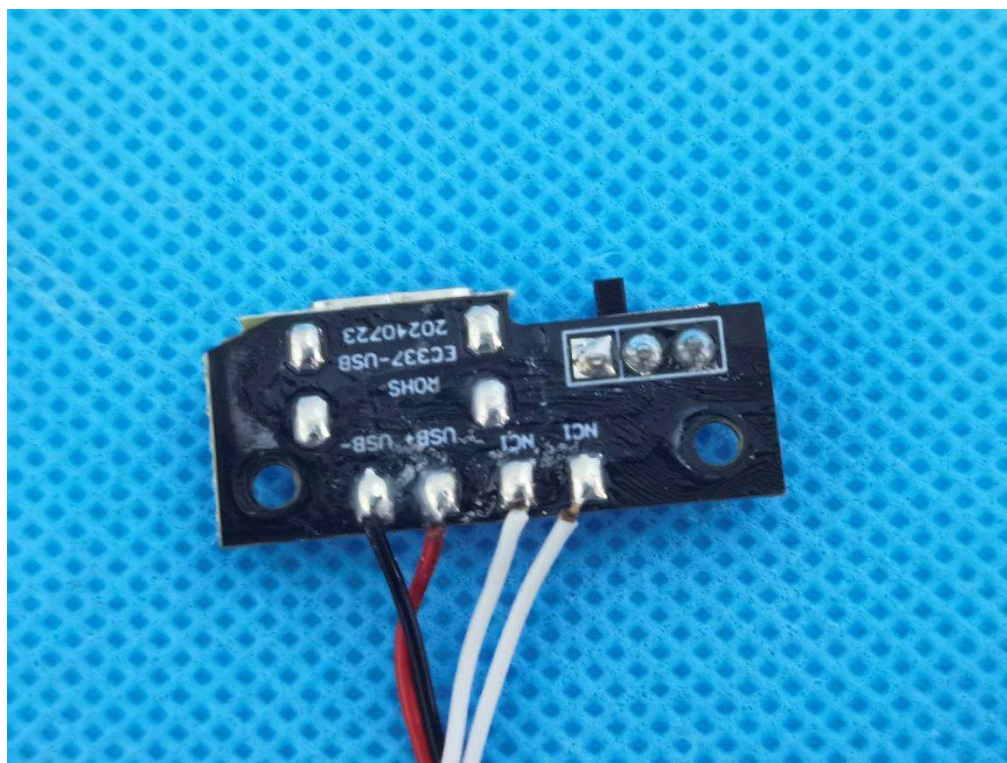

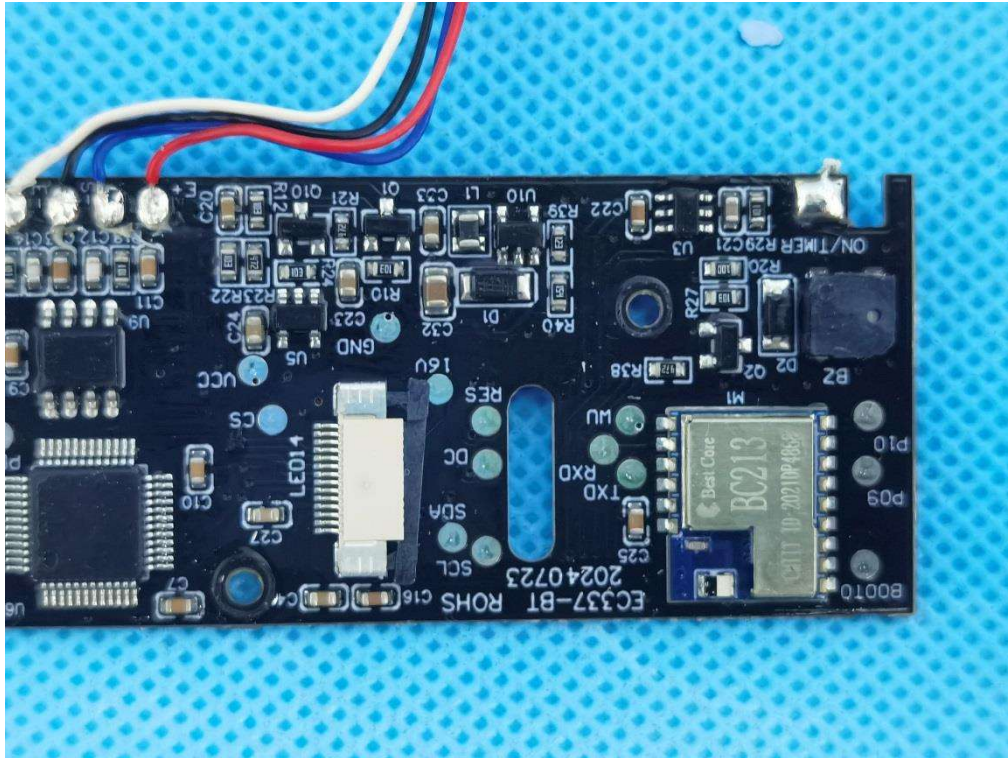


INTERNAL VIEW OF EUT (FIGURE 6)

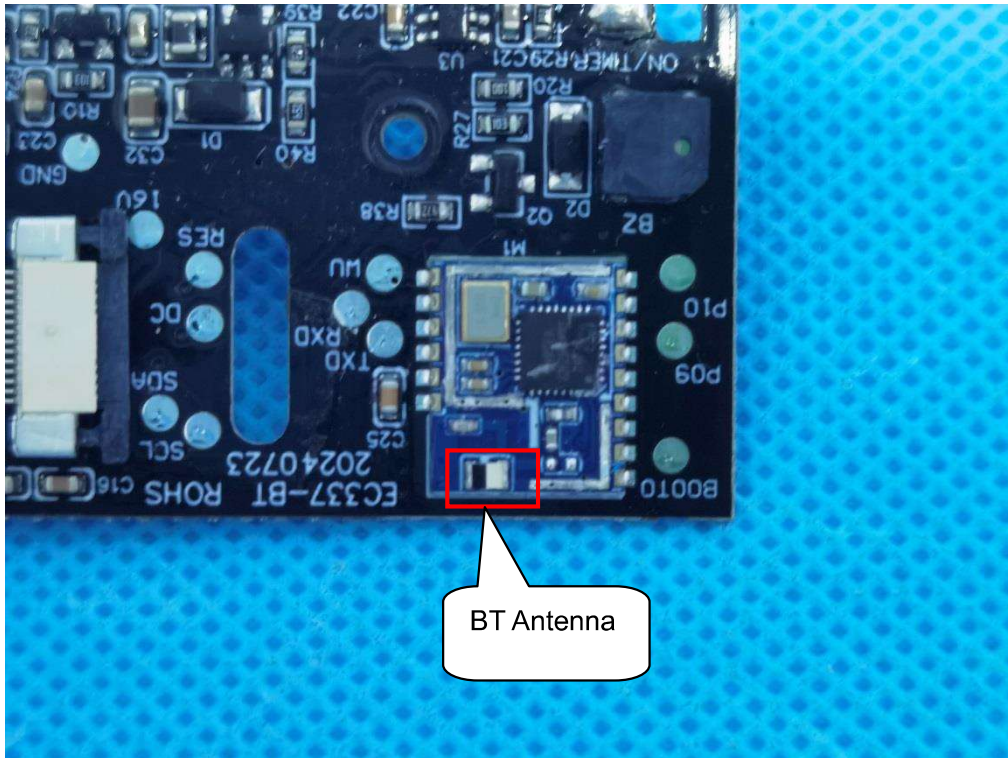
