Common problems and solving methods

Common providence advances in the device will often turn off in auto. The battery is insufficient, please charge it to full capacity then turn it on again. 2. The device does not work very well whether beyond the effective distance of BT connection, or some barriers on there. 3. Can not connect the BT, pic check whether already enter into the BT search mode or not, or reboot the device. Sometimes many Blueboth devices around, pic turn them off.
