#### TWS:

The two same model speakers can be connected to one wireless device at the same time. Firstly, turn on the 2 speakers, triple press " button on either of them for few seconds; then you will hear the sound of "DING-DONG" to indicate that the two units have been paired successfully. Please ensure that before pairing, the two units are not connected with other devices.
