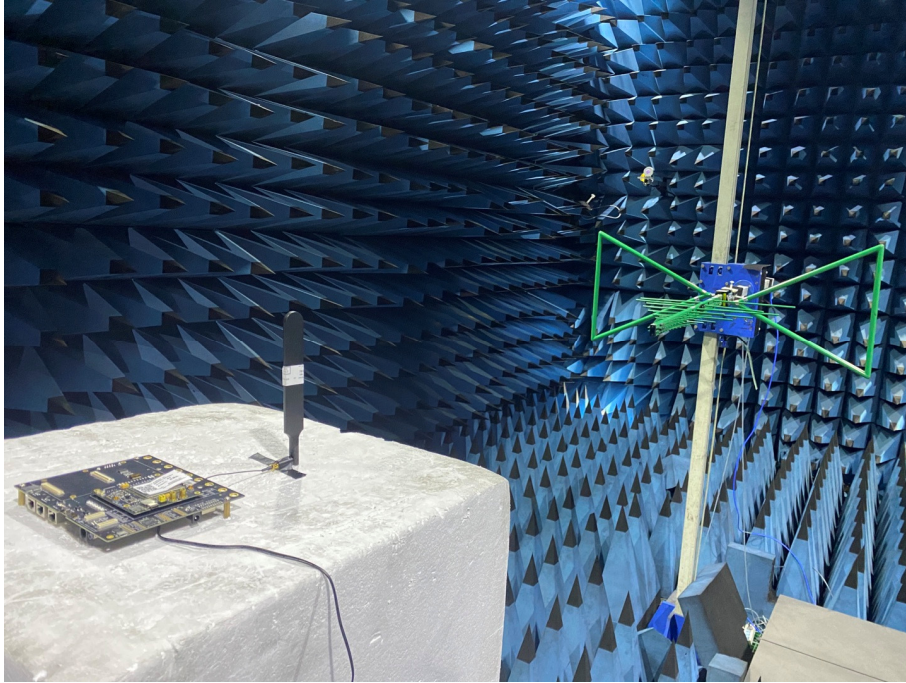

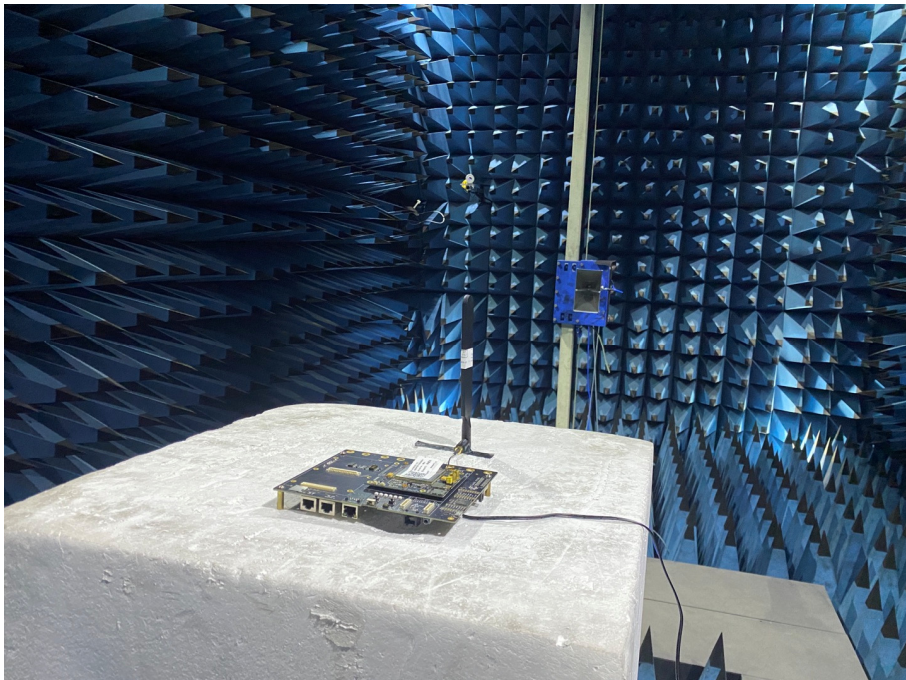

2 Radiated Spurious Emissions 1-18GHz



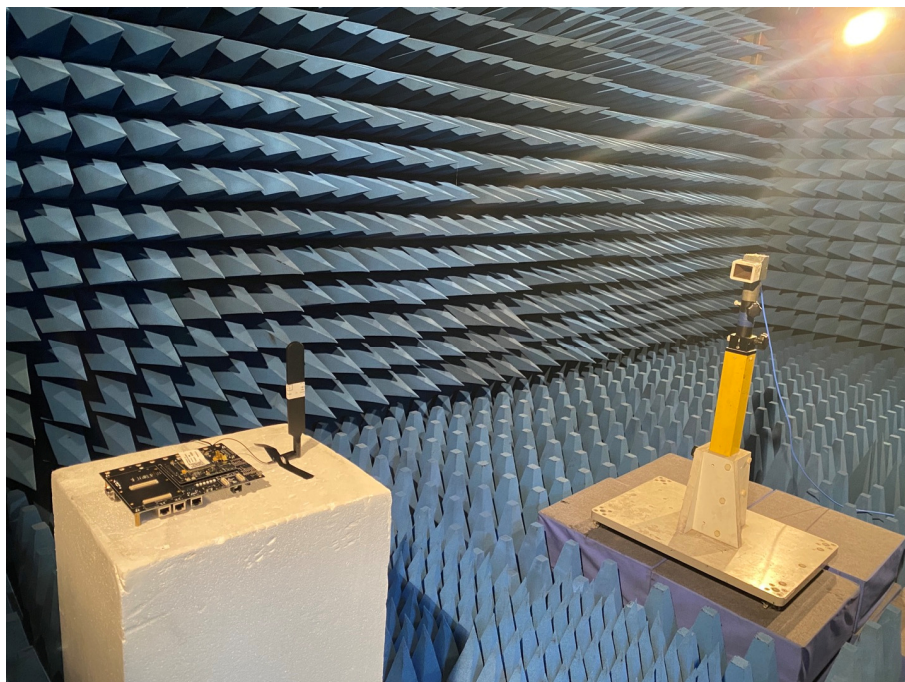

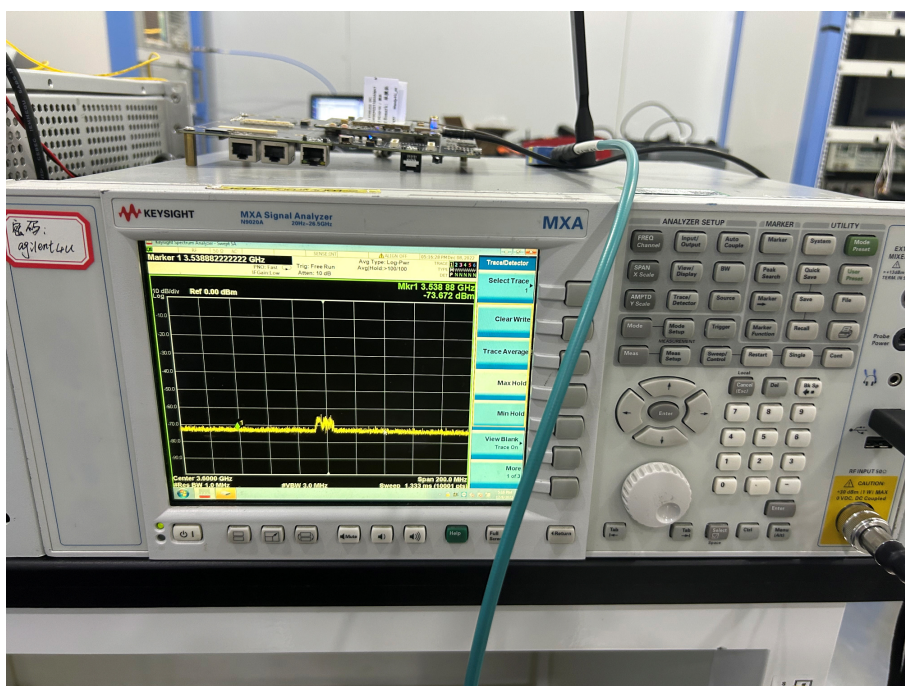
