Band13-5MHz-QPSK-23205-1RB#0-Range2:1000~10000MHz

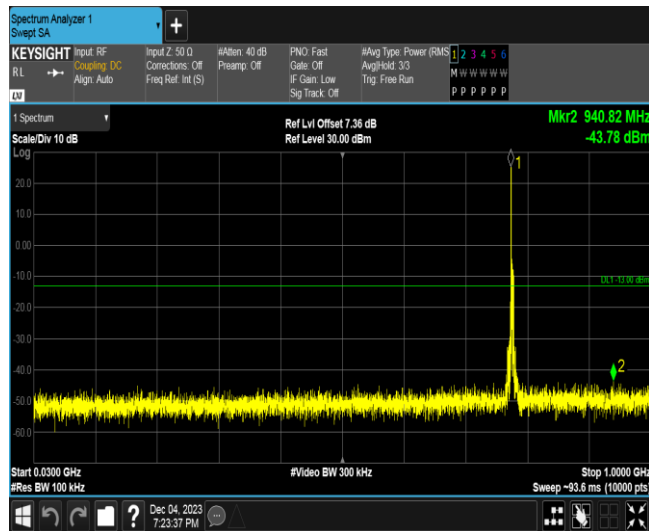


Band13-5MHz-QPSK-23205-1RB#0-Range3:1559~1610MHz

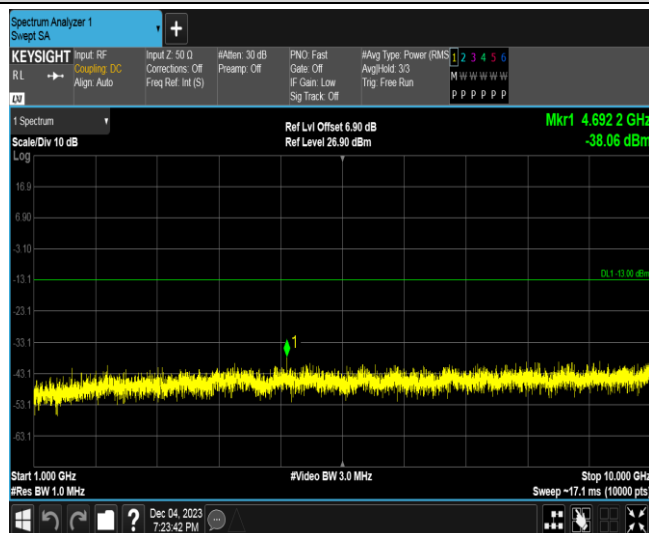
