Inquiry: Dear OET Officer,

Here we have an inquiry regarding Artwork Submission Exemption for indicating sec. 15.19 on Packaging in FCC Certification procedure on behalf of Grantee FLYSKY RC MODEL TECHNOLOGY CO., LTD (Grantee Code: N4Z).

The Product is a 2.4G TX Module, FCC ID: N4ZX8B00, Labeling area is quite small, only 24mm\*17mm, which leaves no place to properly label sec.15.19 on the module itself permanently. Grantee intend to indicate sec.15.19(a)(3) statement in its Manual and Packaging.

Because the device will be sold in batch only, no individual package for each product, therefore, the package of the products will be a box which contains dozens of this module in dedicated plastic stock tray. Containing box varies from each order and shipment, which means no designated package. Grantee guarantee that 15.19(a)(3) will be properly labeled on the containing box in actual shipment. Currently in the regulatory Certification stage, such box can't be finally designed and decided, thus Grantee urge FCC OET to honor its request "submission exemption of the packaging artwork" and kindly approve TCB SGS NA INC to proceed the FCC Grant issuance.

### FCC Response on 05/07/2018:

As a certified transmitter being sold to other manufactures the instructions to the other manufactures to put the 15.19A statement on their products must be in the integration instructions manual. This is not a device intended to be sold to end users. This means the integrator must comply with this statement on their product.
