GENERAL INFORMATION

Product Description for Equipment under Test (EUT)

The *Cubix Latin America*, *LLC* 's product, model number: *PQ5* (*FCC ID*: 2ACDEMP3G-PQ5) or the "EUT" in this report was a *GSM and WCDMA Mobile Phone*, which was measured approximately:14.8 cm (L) x 7.5 cm (W) x 0.9 cm (H), rated with input voltage: DC 3.8 V rechargeable Li-ion battery or DC5.0 V from adapter, The highest operating frequency is 1.2GHz.

Model *PQ5* was selected for fully testing, which was explained in the attached product similarity declaration letter.





The Corrected factor is calculated by adding LISN/ISN VDF (Voltage Division Factor), Cable Loss and Transient Limiter Attenuation. The basic equation is as follows:

Correction Factor = LISN VDF + Cable Loss + Transient Limiter Attenuation







Test Procedure

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All data was recorded in the Quasi-peak detector mode from 30 MHz to 1 GHz and PK and average detector modes for frequencies above 1 GHz.
