


Below 30MHz Test Setup





- 4) The amplitude of spurious emissions which are attenuated by more than 20dB below the permissible value has no need to be reported.
- 5) Pre-scan CH00, CH19 and CH39 modulation, and found the CH00 which it is worse case for 30MHz-1GHz, so only show the test data for worse case.




Radiated Measurement (Above 1GHz)
