### Product Description for Equipment under Test (EUT)

The **SWAGTEK**'s product, model number: **LOGIC Z1 (FCC ID: 055184916)** (the "EUT") in this report was a **1.77 inch Feature Phone**, which was measured approximately: 11.25 cm (L) × 4.7 cm (W) × 1.35 cm (H), rated input voltage: DC3.7V battery or DC5V charging from adapter.

Adapter Information:

INPUT: AC 100-240V 50/60Hz 0.2A

OUTPUT: DC 5.0V 400mA

*Note: The series product, model LOGIC Z1, iSWAG FOX, UNONU U1 are electrically identical, the differences between them are the different model name and color, we selected LOGIC Z1 for fully testing, the details was explained in the declaration letter.*

### Objective

This report is prepared on behalf of **SWAGTEK** in accordance with: Part 2-Subpart J, Part 22-Subpart H, and Part 24-Subpart E of the Federal Communications Commission's rules.

All emissions measurement was performed and Bay Area Compliance Laboratories Corp. (Chengdu).

## **Test Facility**

The test site used by BACL to collect test data is located in the 5040, HuiLongWan Plaza, No. 1, ShaWan Road, JinNiu District, ChengDu, China.

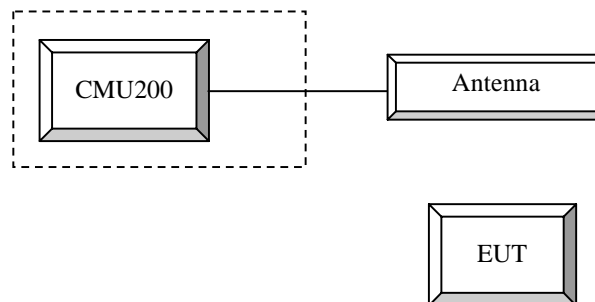

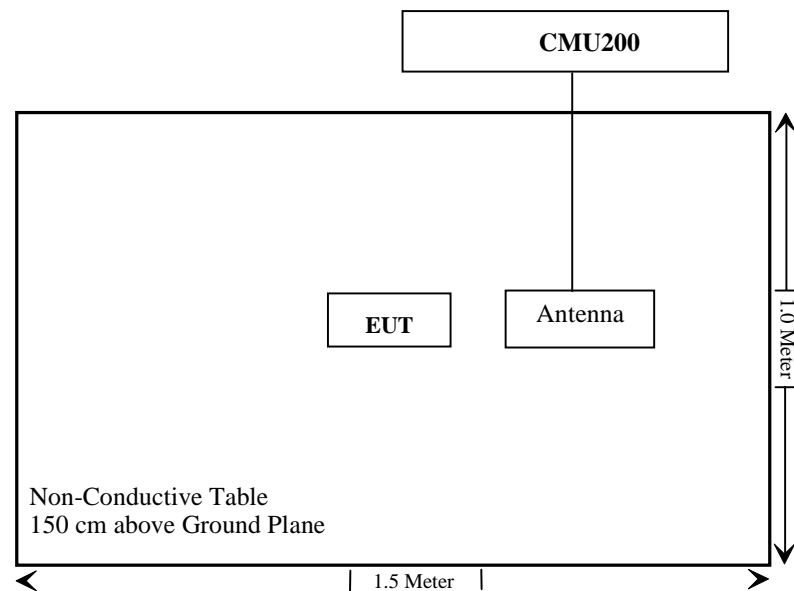

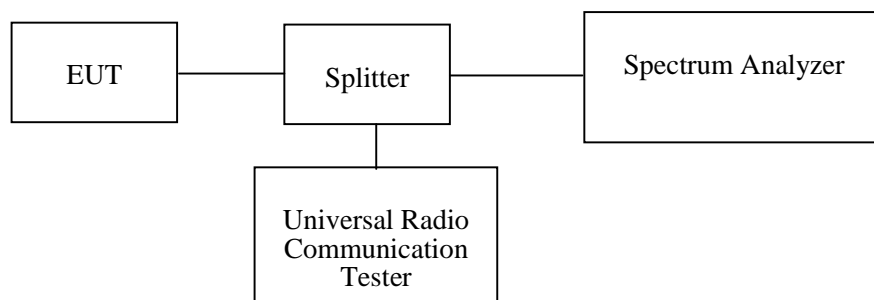

The RF output of the transceiver was connected to a spectrum analyzer and simulator through appropriate attenuation. Sufficient scans were taken to show any out of band emissions up to 10<sup>th</sup> harmonic.

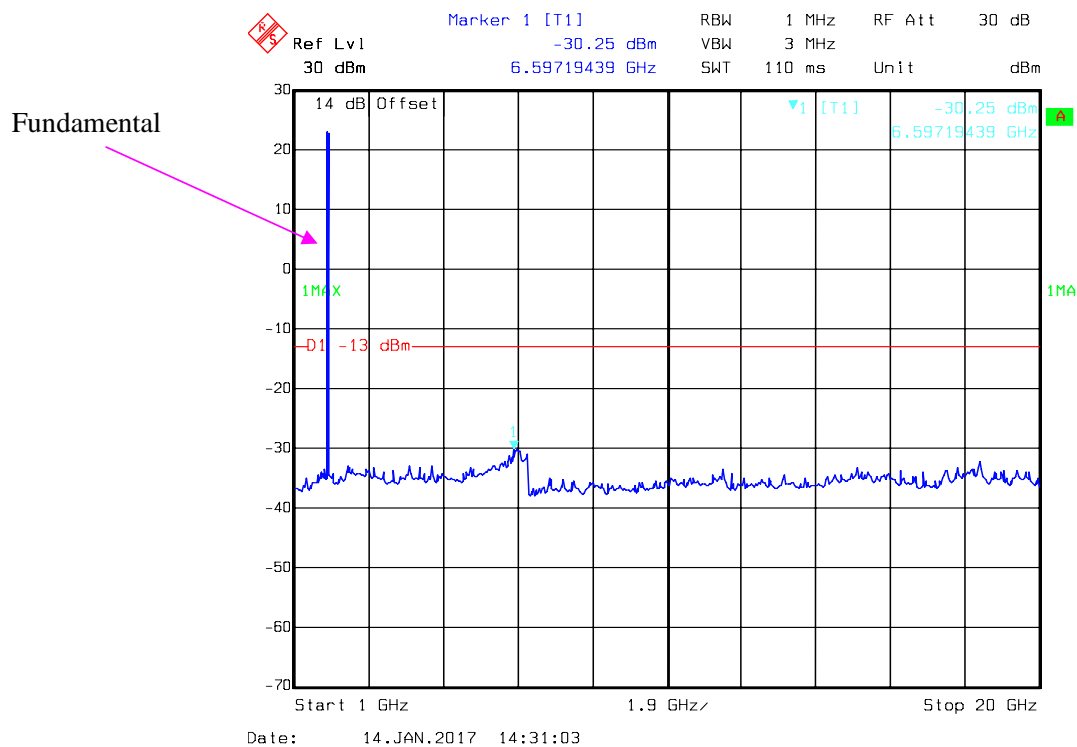

## **FCC §2.1053, §22.917 & §24.238 - SPURIOUS RADIATED EMISSIONS**

---

### **Applicable Standard**

FCC § 2.1053, §22.917 and § 24.238.

### **Test Procedure**

The transmitter was placed on a wooden turntable, and it was transmitting into a non-radiating load which was also placed on the turntable.

The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and polarization as well as EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. The test was performed by placing the EUT on 3-orthogonal axis.

The frequency range up to tenth harmonic of the fundamental frequency was investigated.

Remove the EUT and replace it with substitution antenna. A signal generator was connected to the substitution antenna by a non-radiating cable. The absolute levels of the spurious emissions were measured by the substitution.

Spurious emissions in dB =  $10 \lg (\text{TXpwr in Watts}/0.001)$  – the absolute level

Spurious attenuation limit in dB =  $43 + 10 \text{Log}_{10} (\text{power out in Watts})$

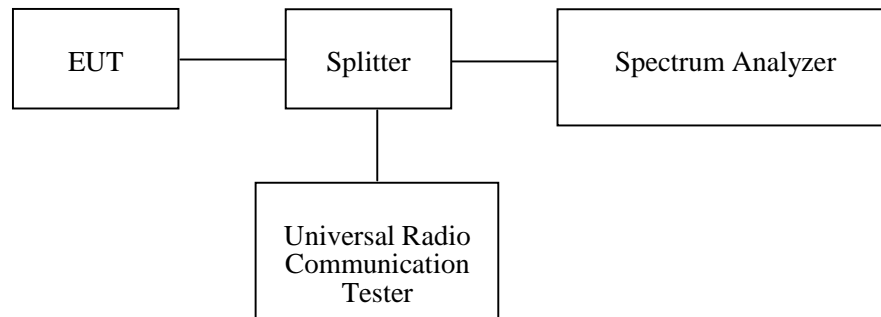

The center of the spectrum analyzer was set to block edge frequency.

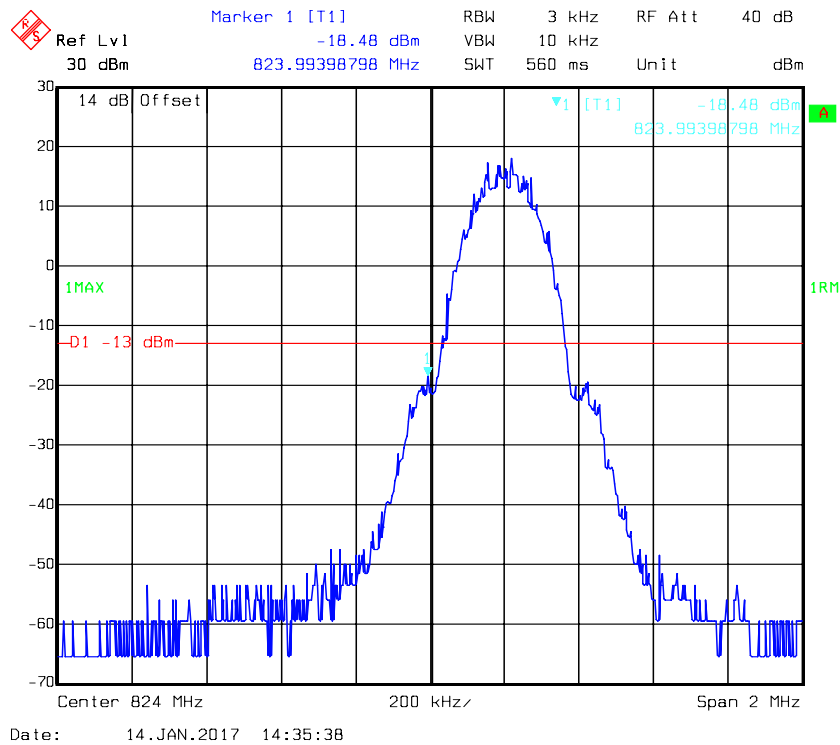

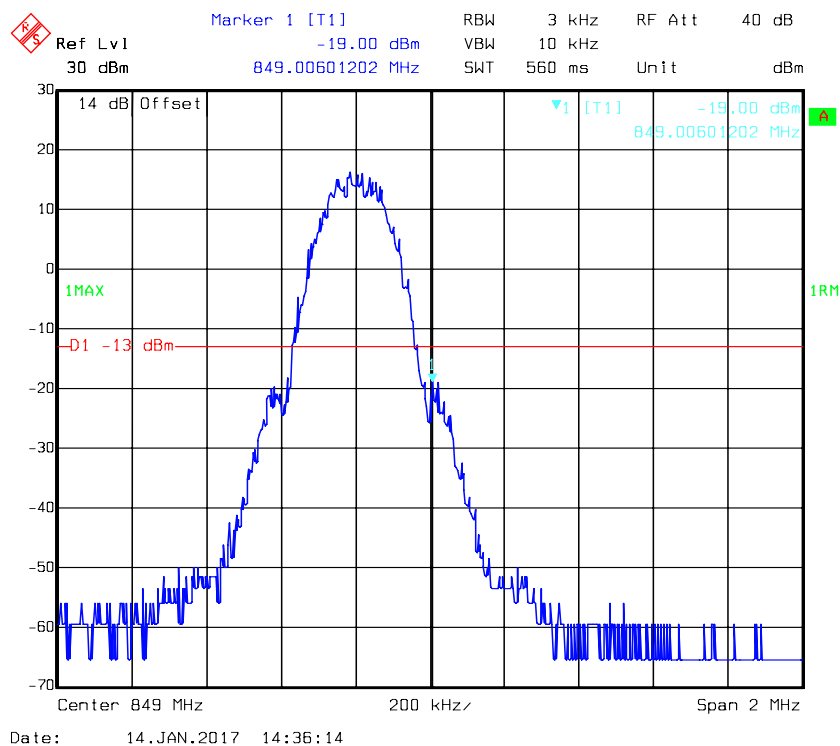

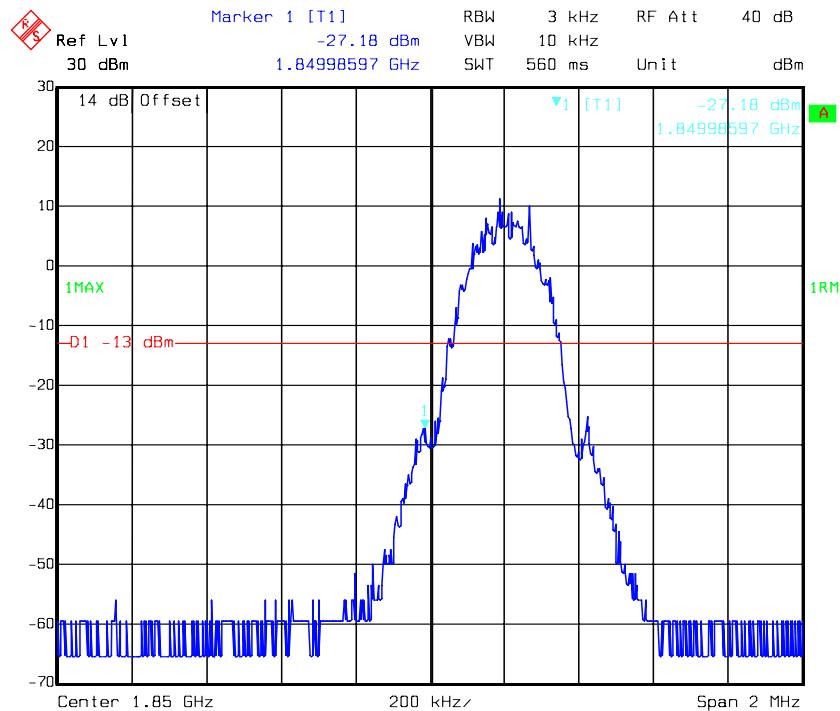
### GSM 850, Left Band Edge



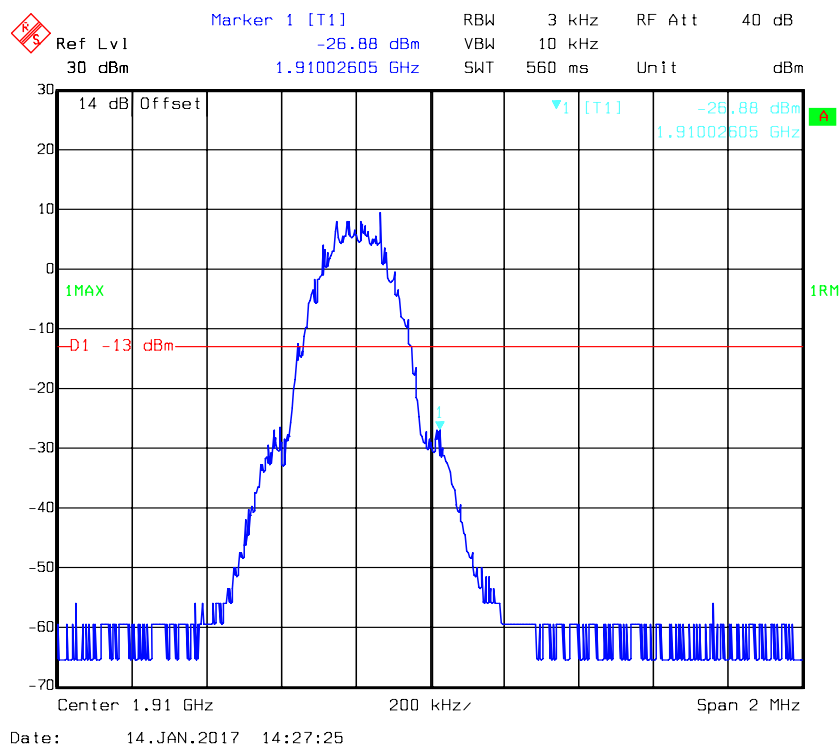
### GSM 850, Right Band Edge

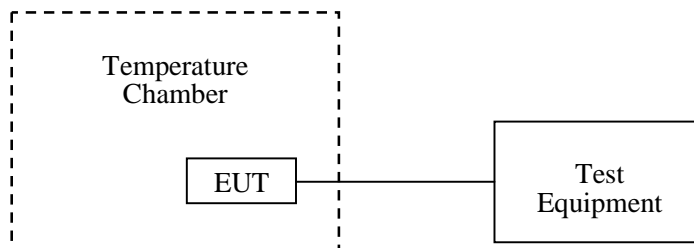
According to §24.235, the frequency stability shall be sufficient to ensure that the fundamental emissions stays within the authorized frequency block.

### Test Procedure

**Frequency Stability vs. Temperature:** The equipment under test was connected to an external DC power supply and the RF output was connected to communication test set via feed-through attenuators. The EUT was placed inside the temperature chamber. The DC leads and RF output cable exited the chamber through an opening made for the purpose.

After the temperature stabilized for approximately 20 minutes, the frequency output was recorded from the communication test set.

**Frequency Stability vs. Voltage:** An external variable DC power supply was connected to the battery terminals of the equipment under test. The voltage was set from 85% to 115% of the nominal value and was then decreased until the transmitter light no longer illuminated; i.e., the battery end point. The output frequency was recorded for each battery voltage.
