




Photo 8: Tissue Simulant Liquid for Body 1900




Photo 9: Tissue Simulant Liquid for Head 2450




Photo 10: Tissue Simulant Liquid for Body 2450




Photo 11: Tissue Simulant Liquid for Head 2600




Photo 12: Tissue Simulant Liquid for Body 2600




