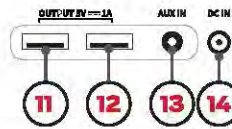

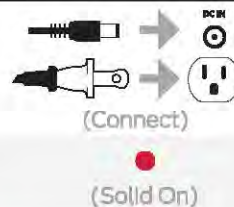

POWER

Power

- 1 **CONNECT** the Included Power Adapter to the appropriate Port (14) on the back of the device.

While unit is off and has power, the LED Indicator light (1) turns **RED**.



- 2 Press and hold the **POWER** Button (2), 3 seconds, to turn the unit **ON**.

Unit will confirm with LED visual and audible sound.



- Press and hold the **POWER** Button (2), 2 seconds, to turn the unit **OFF**.

Unit will confirm with LED visual and audible sound.



AUDIO

AUX IN

- Plugging in a 3.5mm audio cable into the **AUX IN** (13) will automatically turn off the Bluetooth® function and switch the unit to AUX.



Speaker will confirm connection with audible sound.





FEATURES

Bluetooth Pairing & Controls




- 1 Place your smart device within **3 FEET** of the speaker. 

Make sure **Bluetooth®** is enabled on your device.  
- 2 The unit will automatically enter Into Bluetooth® Pairing Mode when turned on.  (Blinking)

Speaker will confirm mode with audible sound and LED indicator Light will blink **BLUE** every second. **"Bluetooth"** → **"Pairing"**


- 3 Select **"MONSTER TRIO"** on your smart device to pair with the speaker.  









Speaker will confirm connection with audible sound. **"Connected"**

 - The **PREVIOUS (7)** and **NEXT (8)** buttons are available to change tracks.  **</⌚ or >** (Press)
 - The **BLUETOOTH® (9)** buttons can be used to play /pause music.   (Press)
 - Press and hold the **BLUETOOTH® Button (9)**, 3 seconds, to unpair device.   (Blinking)

Speaker will confirm disconnection and pairing mode with audible sound. **"Disconnected"** → **"Pairing"**

Setting Time

- 1 Press and hold the **PREVIOUS Button (7)**, 2 seconds, to enter into the Clock Setting Mode.  (Hold 2 Sec.)

Unit will exit Clock Setting Mode after 8 seconds of being idle. 
- 2 Select 24 or 12 Hour Clock Mode by using the **INCREASE or DECREASE VOLUME Button**.  **12** ↔ **24**
— or + (Press)
- 3 Press the **PREVIOUS Button (7)** once to select the **HOURS (10.2)** section. Use the **DECREASE (4)** or **INCREASE (5) VOLUME Button** to change the digits.  →  (Press) — or + (Press)
- 4 Press the **PREVIOUS Button (7)** once again to select the **MINUTES (10.3)** section. Use the **DECREASE (4)** or **INCREASE (5) VOLUME Button** to change the digits.  →  (Press) — or + (Press)
- Press the **PREVIOUS Button (7)** once again to exit Clock Mode.   (Press)

Light Color

- 1 Press the **LIGHT MODE BUTTON (3)** to select the color/style of the ambient LED light.



Unit reverts to default solid **RED** when turned off.

Red → Blue → Green → Pink → Yellow
Teal → White → Color Transition → OFF

Qi Charging

- 1 Set a compatible device on one of the two Qi chargers.



Make sure the **Qi** feature is enabled on your device.



- Device is charging when the lights slowly breath on/off.
Qi 1: Blue; Qi 2: Green.

Qi 1: Qi 2:
(Breathing On/Off)

Speaker will confirm connection with audible sound.



- If incompatible, lights flash **Red** three times and remains solid.

Qi 1 & 2:
(Blinks x3 & Solid)

- While unit is **OFF**, quickly press the **POWER** Button twice to enter into **ECO** **MODE**, turning off the Qi Chargers.



(Press Rapidly Twice while OFF)

Unit will make visual confirmation.

ECO



Chargers are meant for Qi compatible devices and will only work when the phone is placed upright.

USB Ports

- **USB PORTS (11 or 12)** found on the back of the unit are available 5V chargers while powered (On or Off).

Call Connectivity

- 1 **ANSWER** phone calls while Bluetooth Connected to the device by pressing the **BLUETOOTH** Button (9).



Unit will make visual confirmation when call is incoming.

CALL

- **SILENCE** phone calls by holding the **BLUETOOTH** Button (9) for two seconds.



Display Brightness

- Short press the **POWER** Button (2) while powered (On or Off) to select one of three LED brightness levels.

Speaker is not powering on	<ul style="list-style-type: none"> Make sure POWER ADAPTER is fully inserted into the unit <i>(See pg. 1)</i>
Buttons are not responding	<ul style="list-style-type: none"> Reset the speaker by turning the power OFF, and then back ON. <i>(See pg. 1)</i> Unplug the POWER ADAPTER, then plug it back in. <i>(See pg. 1)</i>
No music is playing	<ul style="list-style-type: none"> Make sure the speaker is set to the same source as your audio device. If you are playing audio via AUX IN jack, make sure the speaker is in AUX IN mode, etc. <i>(See pg. 2)</i> Make sure the VOLUME level is high enough on your audio device as well as the speaker.
