GENERAL INFORMATION

Product Description for Equipment under Test (EUT)

The GSOU Technology (Shen Zhen) Co., LTD's product, model number: U200 (FCC ID: SXS-BT200) (the "EUT") in this report was a Bluetooth Speaker, which was measured approximately: 7.6 cm (L) x 7.6 cm (W) x 16.4 cm (H), rated input voltage: DC 3.7V rechargeable Li-ion battery or DC5V charging from USB port.

Note: The series product, model U200, U200A are electrically identical, the difference between them is model name, we selected U200 for testing, the details was explained in the attached declaration letter.

All measurement and test data in this report was gathered from production sample serial number: 141216010 (Assigned by BACL, Dongguan). The EUT was received on 2014-12-18.

Objective

This report is prepared on behalf of *GSOU Technology* (*Shen Zhen*) *Co., LTD* in accordance with Part 2-Subpart J, Part 15-Subparts A, B and C of the Federal Communications Commission's rules.

The tests were performed in order to determine the compliance of the EUT with FCC Part 15-Subpart C, section 15.203, 15.205, 15.207, 15.209 and 15.247 rules.

Test Methodology

All measurements contained in this report were conducted with ANSI C63.4-2003, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed and Bay Area Compliance Laboratories Corp. (Dongguan). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Test Facility

The Test site used by Bay Area Compliance Laboratories Corp. (Dongguan) to collect test data is located on the No.69 Pulongcun, Puxinhu Industrial Zone, Tangxia, Dongguan, Guangdong, China

Test site at Bay Area Compliance Laboratories Corp. (Dongguan) has been fully described in reports submitted to the Federal Communications Commission (FCC). The details of these reports have been found to be in compliance with the requirements of Section 2.948 of the FCC Rules on February 02, 2012. The



The maximum conducted output power (including tune-up tolerance) = 2 dBm (1.58 mW) at $2402 \text{MHz} \sim 2480 \text{ MHz}$







The radiated emission tests were performed in the 3 meters test site, using the setup accordance with the ANSI C63.4-2003. The specification used was the FCC 15.209, and FCC 15.247 limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The spacing between the peripherals was 10 cm.

Data was recorded in Quasi-peak detection mode for frequency range of 30 MHz-1 GHz, peak and Average detection modes for frequencies above 1 GHz.






Middle Channel





FCC §15.247(d) – 100 kHz BANDWIDTH OF FREQUENCY BAND EDGE

Applicable Standard

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

Test Procedure

- 1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2. Position the EUT without connection to measurement instrument. Turn on the EUT and connect its antenna terminal to measurement instrument via a low loss cable. Then set it to any one measured frequency within its operating range, and make sure the instrument is operated in its linear range.
- 3. Set RBW to 100 kHz and VBW of spectrum analyzer to 300 kHz with a convenient frequency span including 100 kHz bandwidth from band edge.
- 4. Measure the highest amplitude appearing on spectral display and set it as a reference level. Plot the graph with marking the highest point and edge frequency.
- 5. Repeat above procedures until all measured frequencies were complete.









Power Spectral Density, Low Channel


