3. Limit

According to KDB447498 D01 General RF Exposure Guidance V07

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

[(max. power of channel, including tune-up tolerance, mW)/(min. test separation distance, mm)] * $[\sqrt{f(GHz)}] \le 3.0$ for 1-g SAR and ≤ 7.5 for 10-g extremity SAR, where

f(GHz) is the RF channel transmit frequency in GHz;

Power and distance are rounded to the nearest mW and mm before calculation;

The result is rounded to one decimal place for comparison;

The test exclusions are applicable only when the minimum test separation distance is \leq 50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is \leq 5 mm, a distance of 5 mm is applied to determine SAR test exclusion.

We use 5mm as separation distance to calculate.



4. Test Results

Maximum measured transmitter power:

2404MHz: EIRP=E+20log(d)-104.7=87.54+9.54-104.7=-7.62 dBm 2469MHz: EIRP=E+20log(d)-104.7=84.55+9.54-104.7=-10.61 dBm 2479MHz: EIRP=E+20log(d)-104.7=83.95+9.54-104.7=-11.21 dBm
