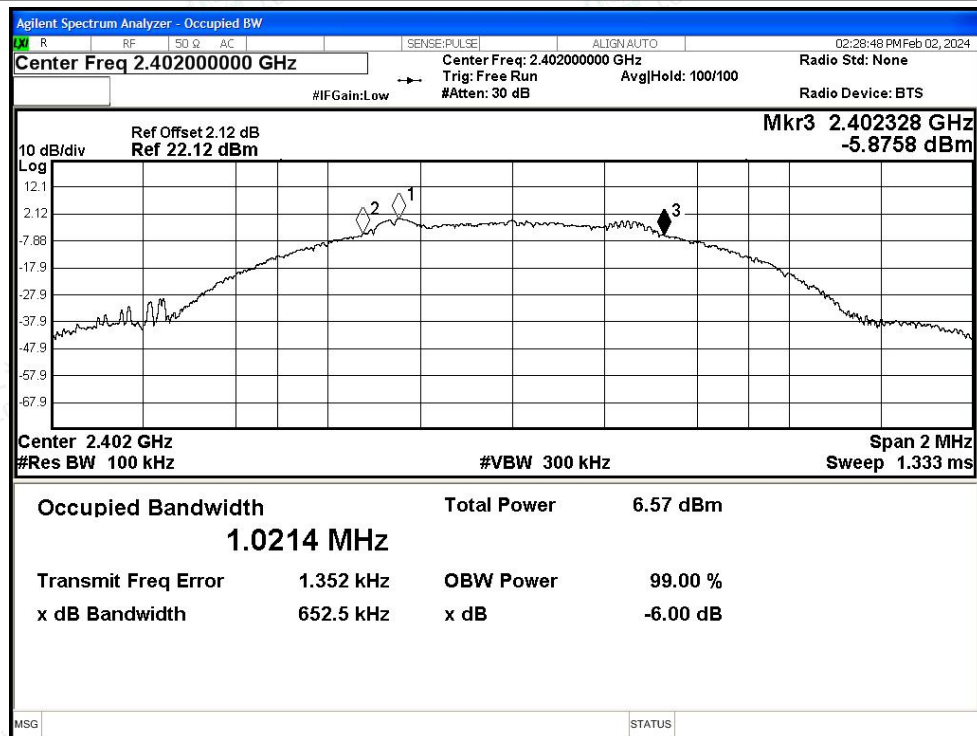

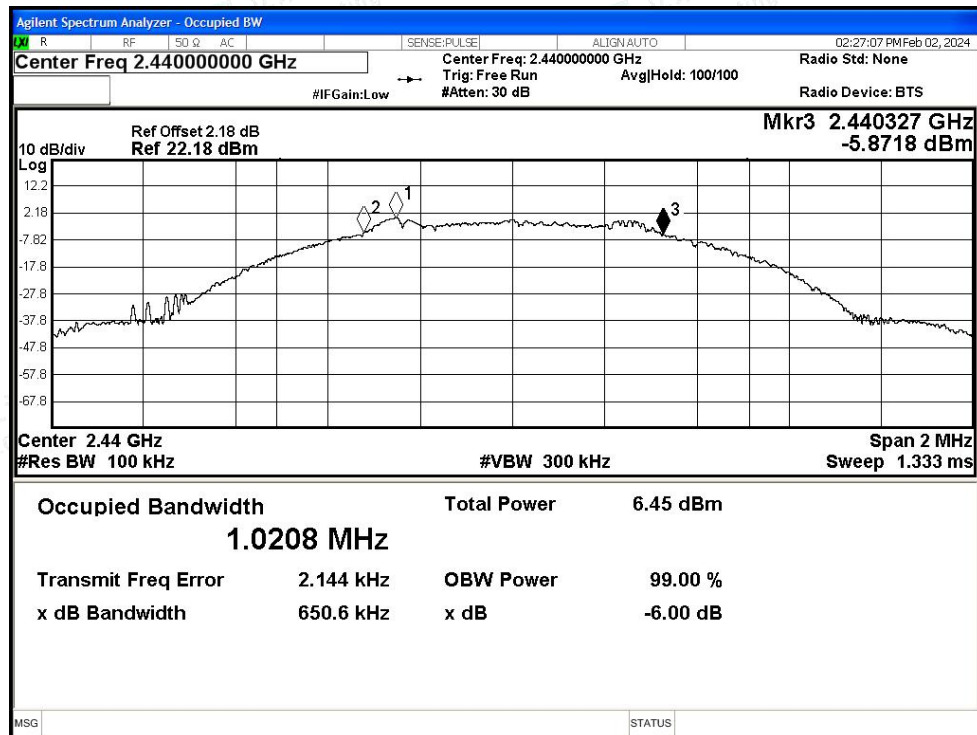

-6dB Bandwidth NVNT BLE 1M 2440MHz Ant1

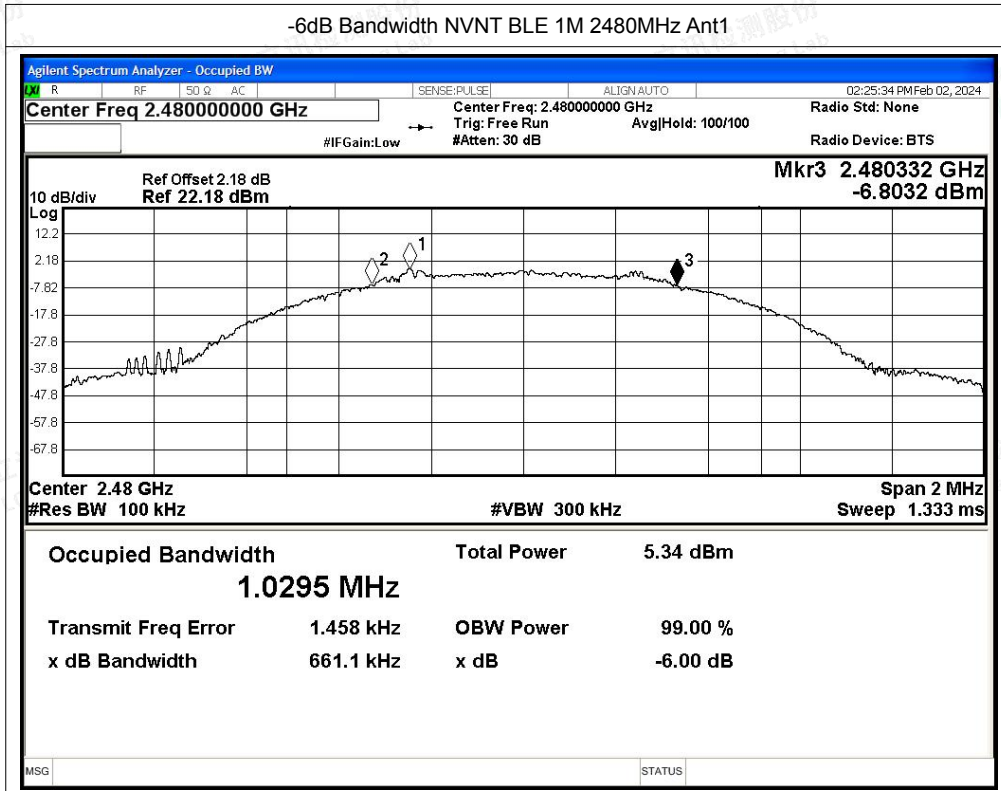

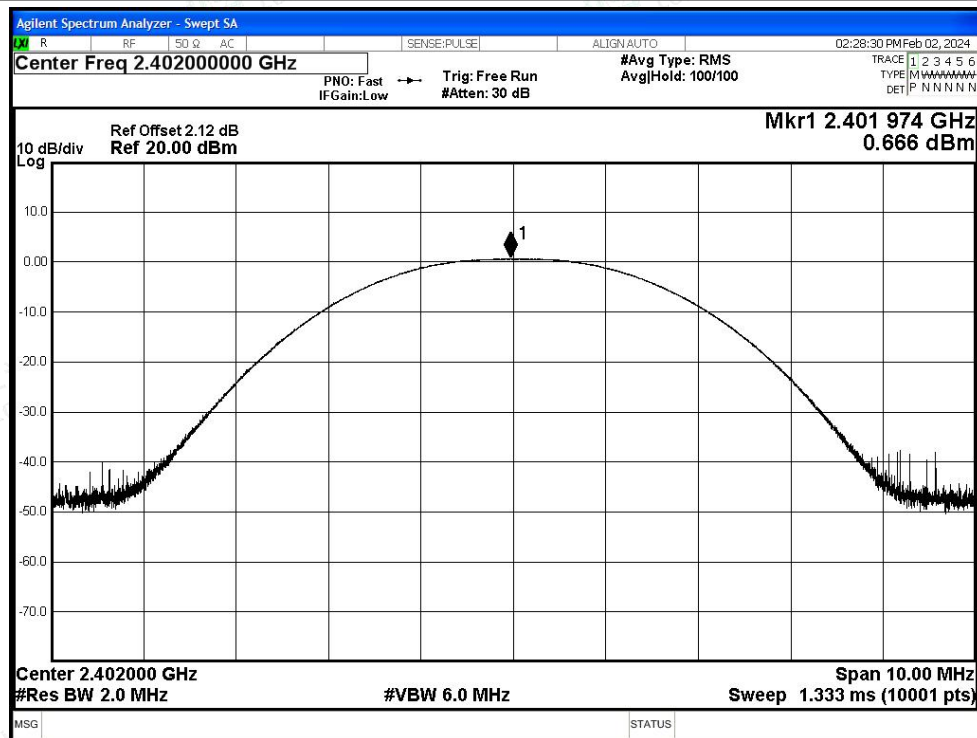

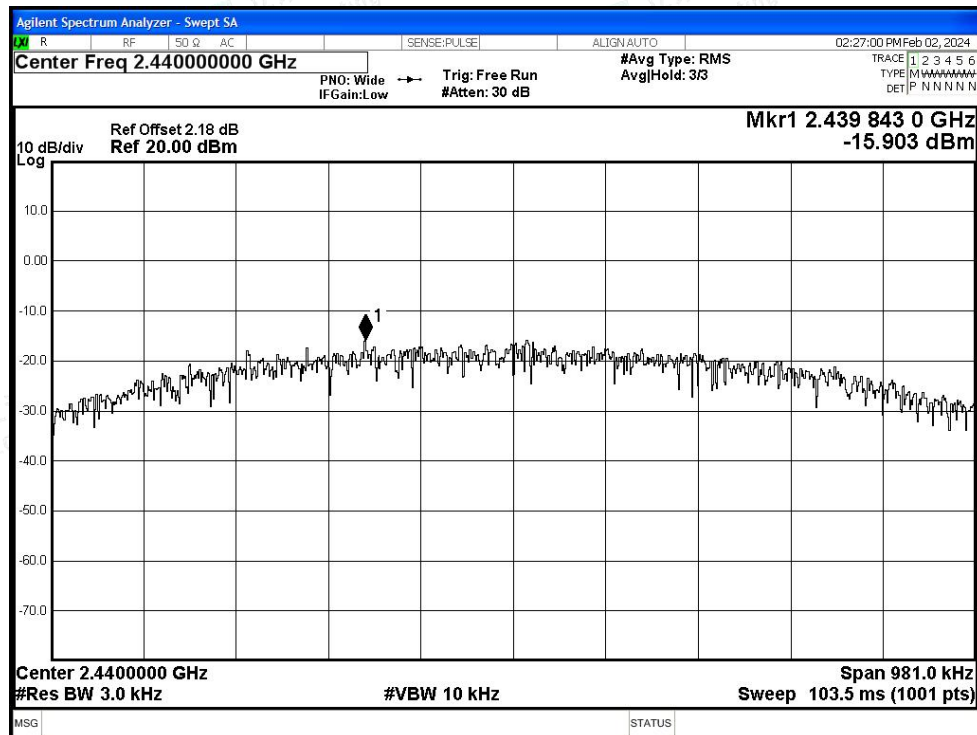

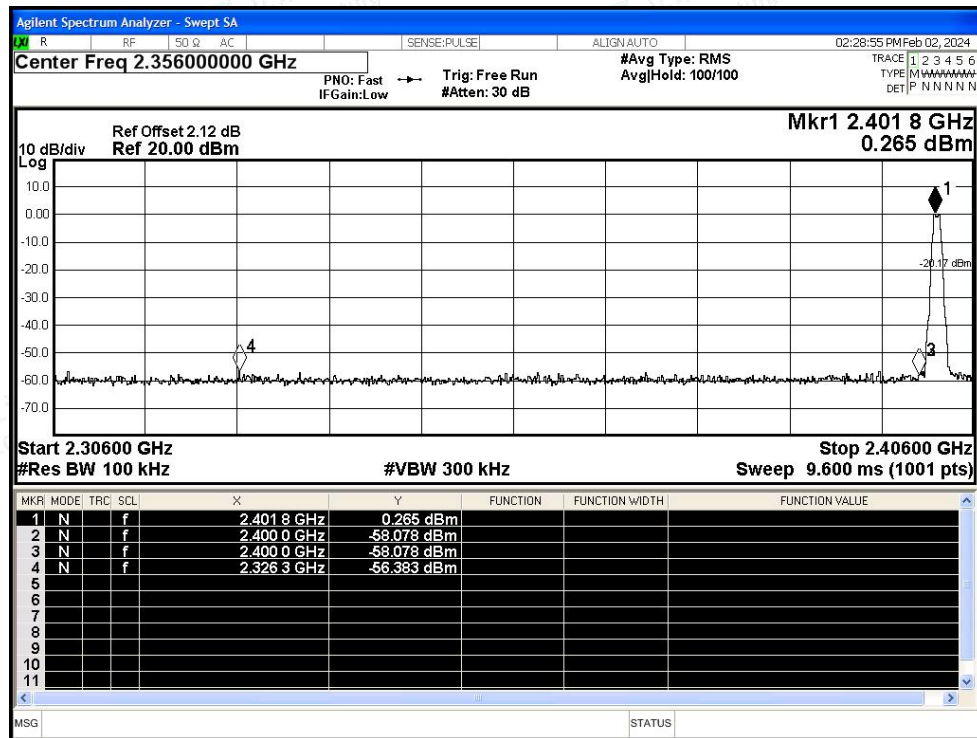

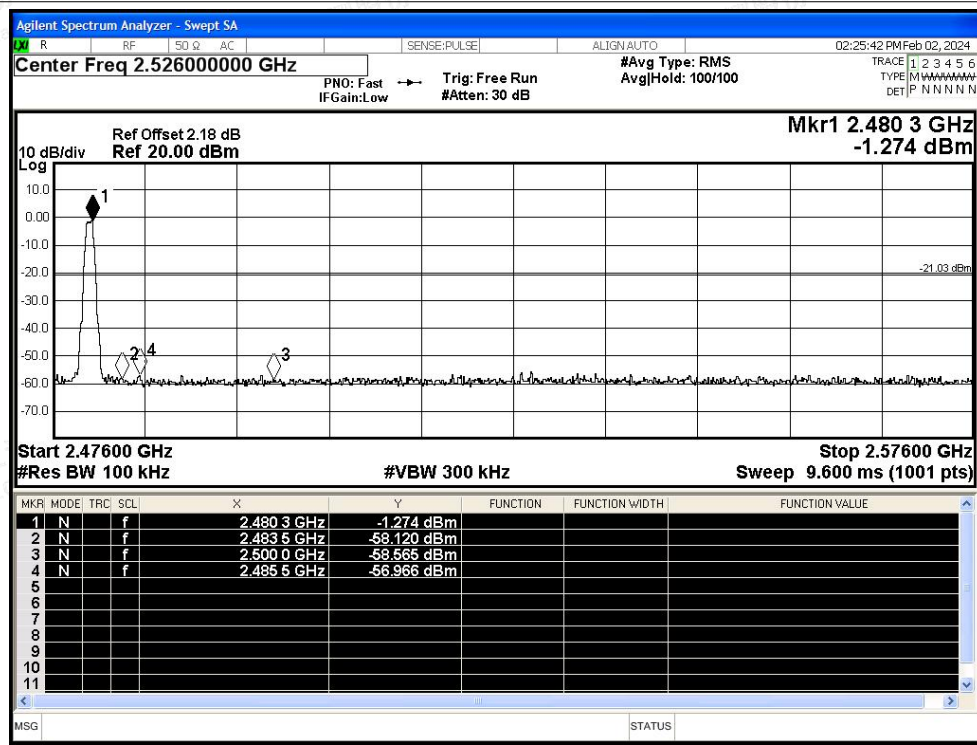

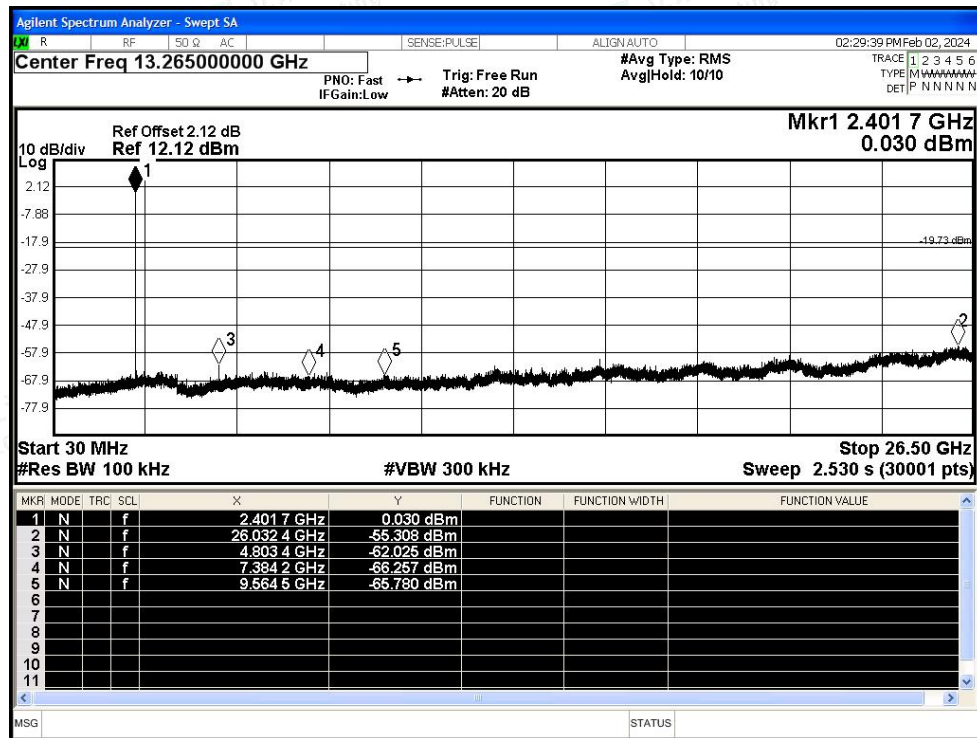

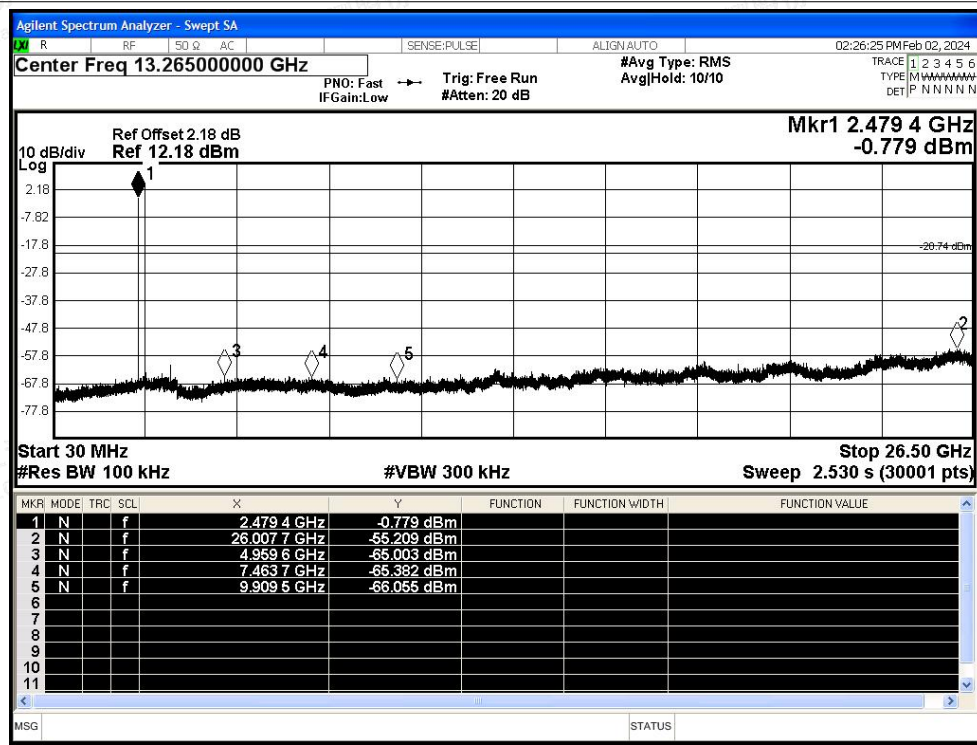

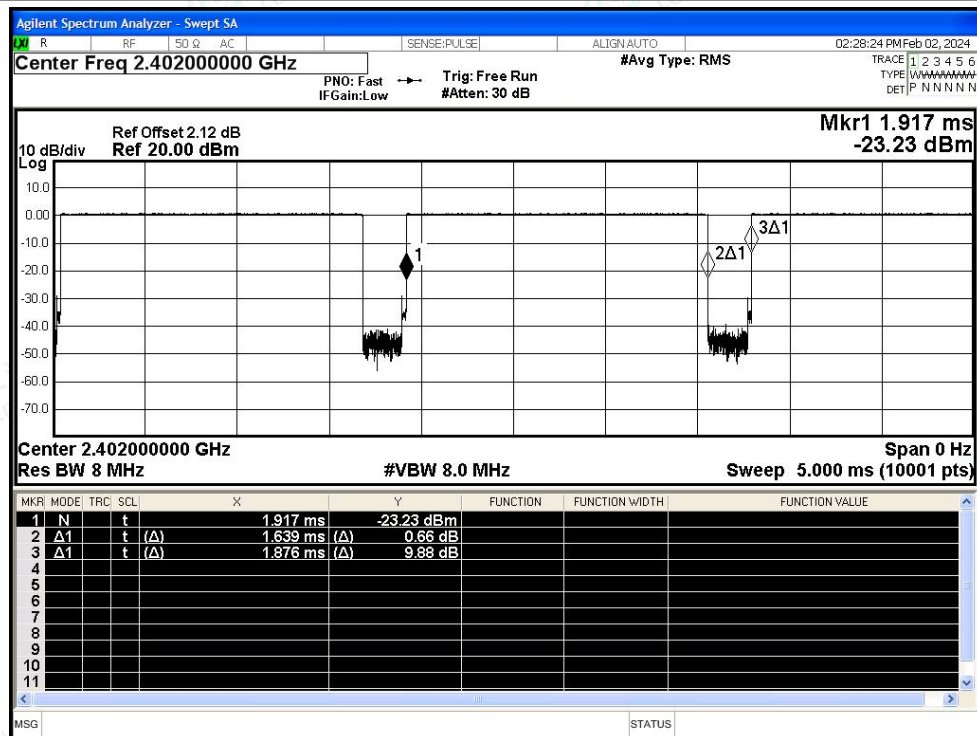

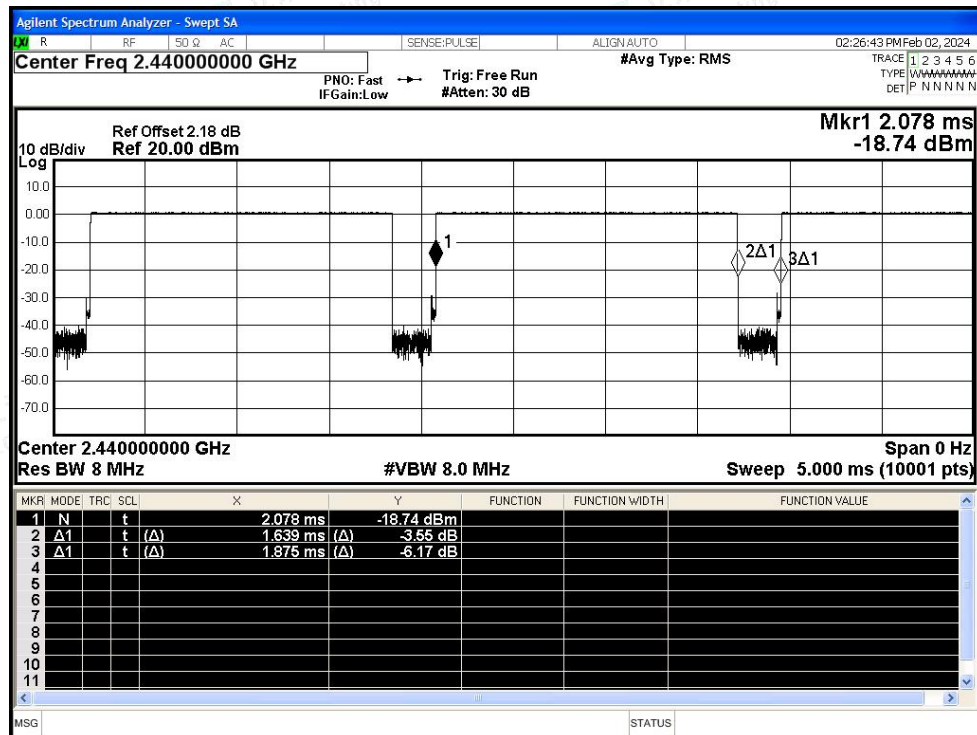

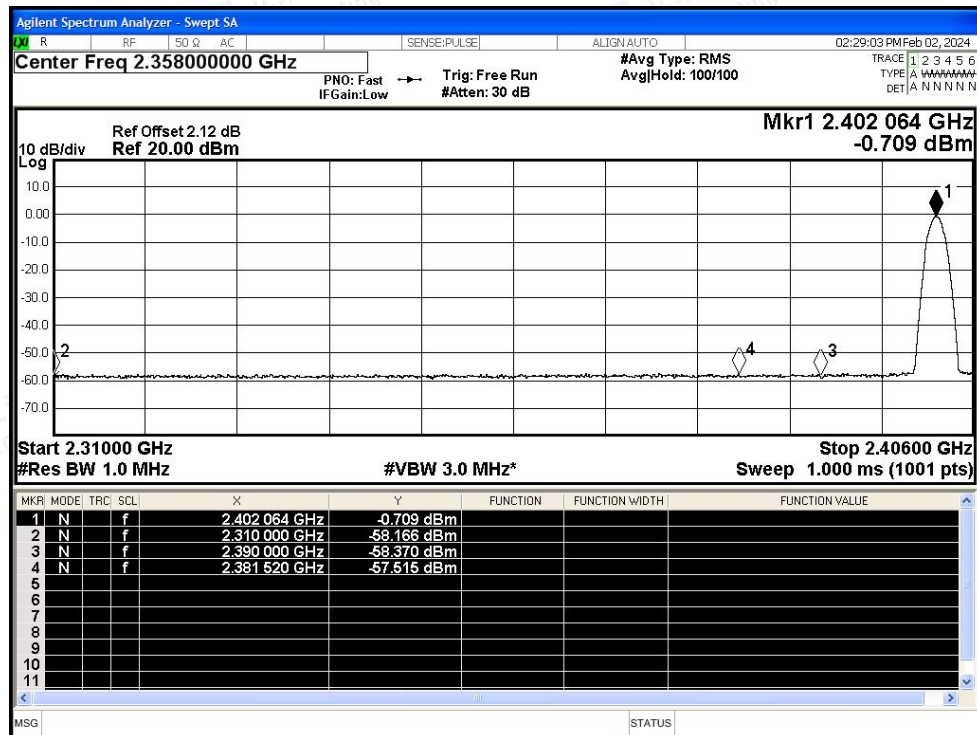

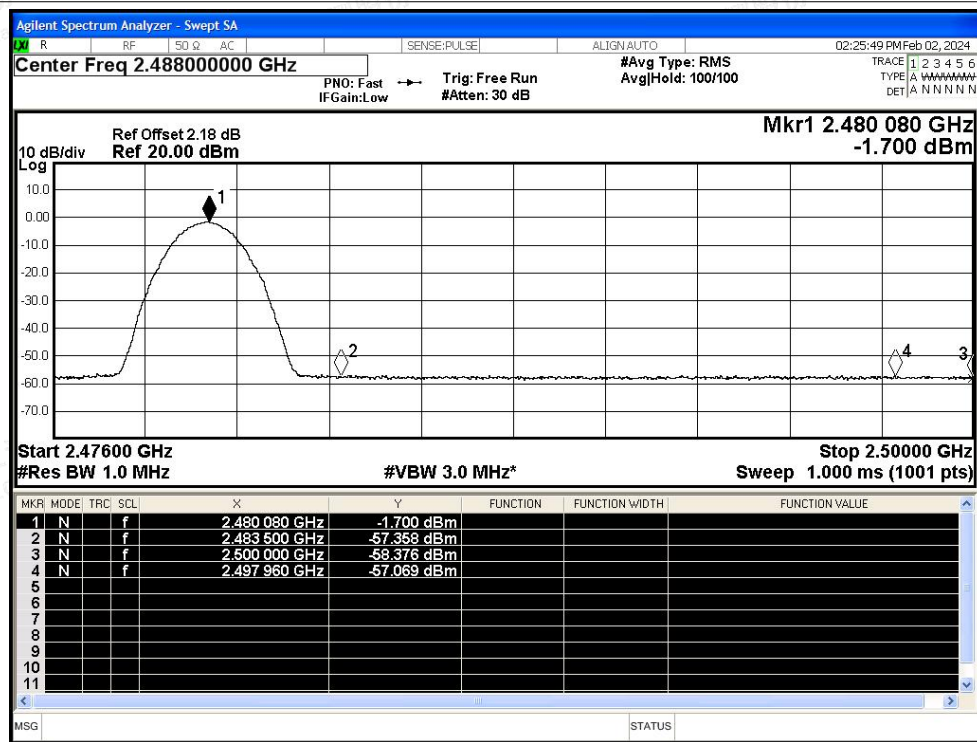
