



3. EMC EMISSION TEST



3.2 TEST PROCEDURE

- a. The EUT is 0.8 m from the horizontal ground plane and 0.4 m from the vertical ground plane with EUT being connected to the power mains through a line impedance stabilization network (LISN). All other support equipments are powered from additional LISN(s). The LISN provides 50 Ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Interconnecting cables that hang closer than 40 cm to the ground plane shall be folded back and forth in the center forming a bundle 30 to 40 cm long.
- c. I/O cables that are not connected to a peripheral shall be bundled in the center. The end of the cable may be terminated, if required, using the correct terminating impedance. The overall length shall not exceed 1 m.
- d LISN is at least 80 cm from the nearest part of EUT chassis.
- e. For the actual test configuration, please refer to the related Item –EUT Test Photos.

3.3 TEST SETUP



Note: 1. Support units were connected to second LISN.

2. Both of LISNs (AMN) are 80 cm from EUT and at least 80 cm from other units and other metal planes support units.

3.4 EUT OPERATING CONDITIONS

The EUT was configured for testing in a typical fashion (as a customer would normally use it). The EUT has been programmed to continuously transmit during test. This operating condition was tested and used to collect the included data.




(A) Radiated Emission Test-Up Frequency Below 30MHz

- j) Compute power by integrating the spectrum across the OBW of the signal using the instrument's band power measurement function with band limits set equal to the OBW band edges. If the instrument does not have a band power function, then sum the spectrum levels (in power units) at intervals equal to the RBW extending across the entire OBW of the spectrum.
- k) Add [10 log (1 / D)], where D is the duty cycle, to the measured power to compute the average p ower during the actual transmission times (because the measurement represents an average over both the ON and OFF times of the transmission). For example, add [10 log (1/0.25)] = 6 dB if the d uty cycle is 25%.
