CARRYING AND HANDLING.

This product contains sensitive components. Do not drop, disassemble, open, crush, bend, deform, puncture, shred, microwave, incinerate, paint, or insert foreign objects. USING CONNECTORS AND PORTS.

Never force a connector into a port. Check for obstructions on the port. If the connector and port don't join with reasonable ease, they probably don't match. Make sure that the connector matches the port and that you have positioned the connector correctly in relation to the port.

KEEPING PRODUCT WITHIN ACCEPTABLE TEMPERATURES.

Avoid dramatic changes in temperature or humidity when using product, as condensation may form on or within product. 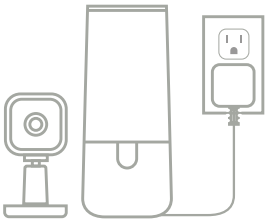

Quick Start Guide

1. Connect power to Aristotle Hub and press Action button for 4 seconds to power up. (Follow prompts during app set up to connect camera.)

Getting to Know Aristotle



1. Smart Light
- Voice activated.
 - Night light, reading light, changing table light.
 - Customize brightness and color from millions of options.
2. Bluetooth Speaker
- 360° omni-directional sound.
 - Tuned for optimal audio comfort and enhanced acoustics.
3. Action Button
- Press  button to stop current action or to wake Aristotle without saying "Aristotle". This button can also be used to power on Aristotle and to turn off the alarm and timer.
4. Brightness Control
- Press  to brighten Smart Light
Press  to dim Smart Light
5. Volume Control
- Press  to make volume louder
Press  to make volume lower
6. Mute
- Press to mute microphone. The Smart Light will turn red to indicate that Aristotle's microphone and speakers are on mute. Press again to un-mute.

Getting Started with Aristotle

THE BEST PLACE TO PUT ARISTOTLE*

Aristotle works best when placed in a central location, at least 8 inches from any wall. You can put Aristotle in a variety of places – on a dresser, counter, night stand or end table.

TALKING TO ARISTOTLE

"Aristotle" is the word you say to get Aristotle's attention. Say, "Aristotle", and then tell her what you want to do.

ARISTOTLE APP

The Aristotle App helps you get the most out of Aristotle and is available free for iOS and Android devices. You can use this app to monitor your baby, manage your settings, track your baby's eating, sleeping and changing habits.

LIGHT STATUS

- Pulsing blue light: Aristotle is starting up.
- Blue light: Aristotle is processing your request.
- Red light: The microphone is muted, preventing Aristotle from listening or responding. Press the  button to un-mute.
