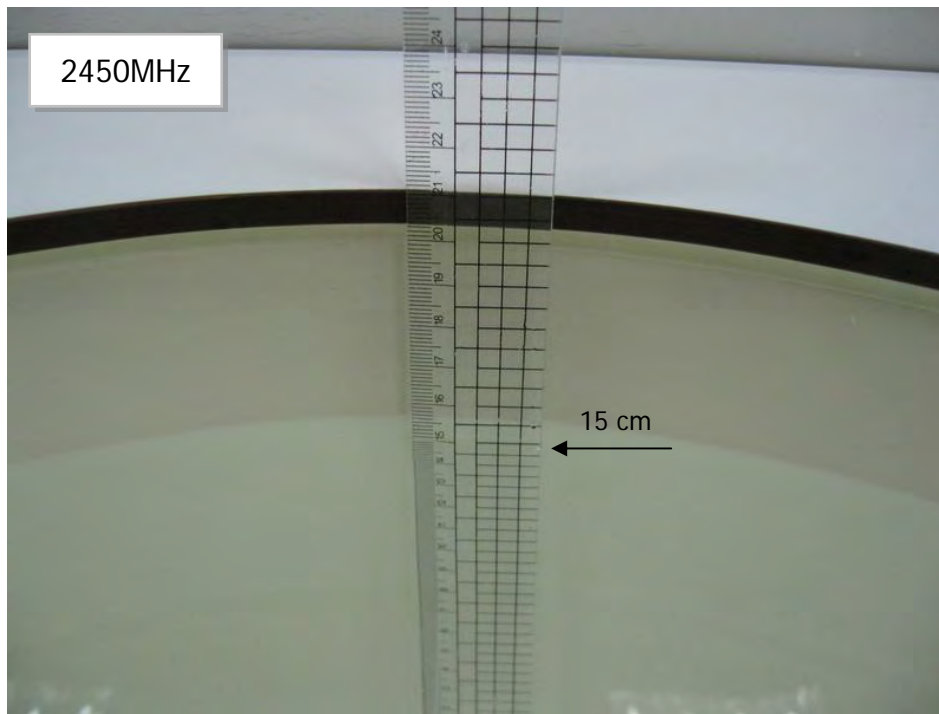

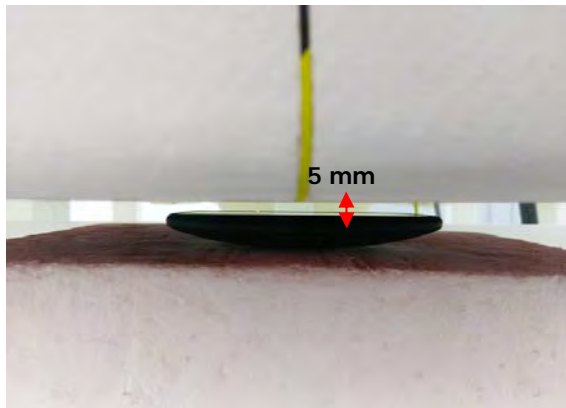


Fig.3 EUT Front side to flat phantom

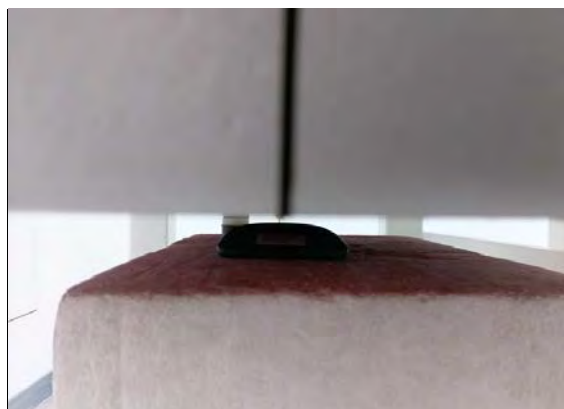
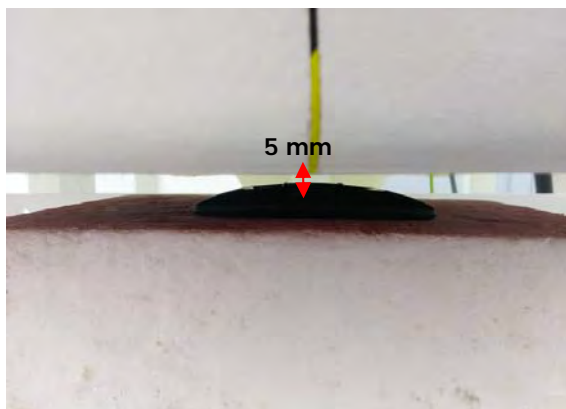


Fig.4 EUT Back side to flat phantom

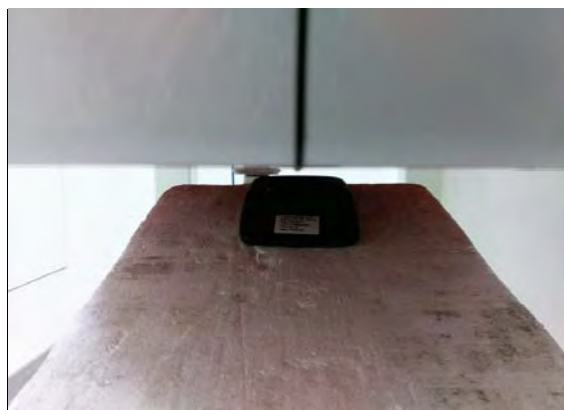
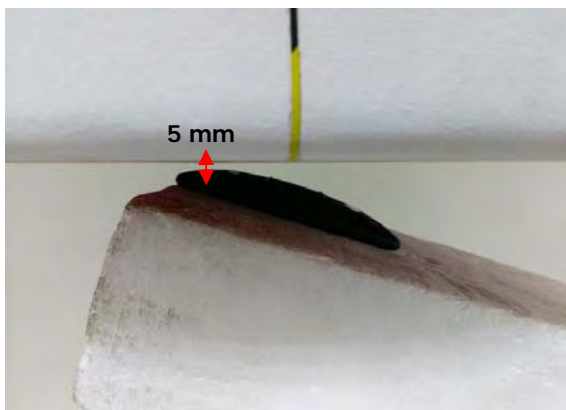


Fig.5 EUT Back side_curve to flat phantom

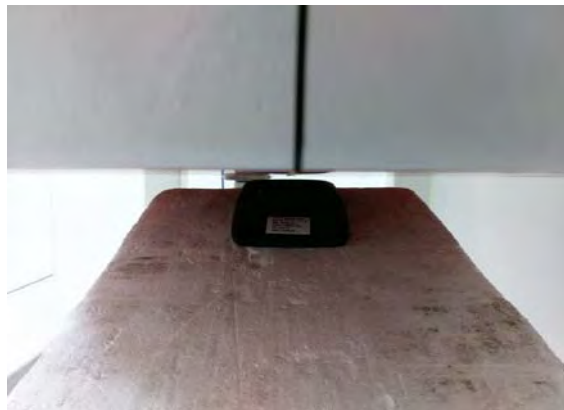
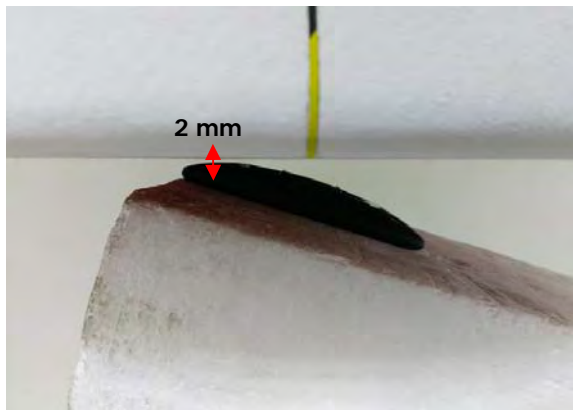


Fig.6 EUT Back side_curve (2mm) to flat phantom

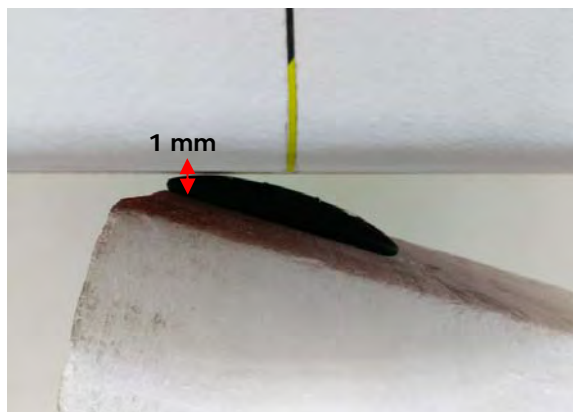


Fig.7 EUT Back side_curve (1mm) to flat phantom

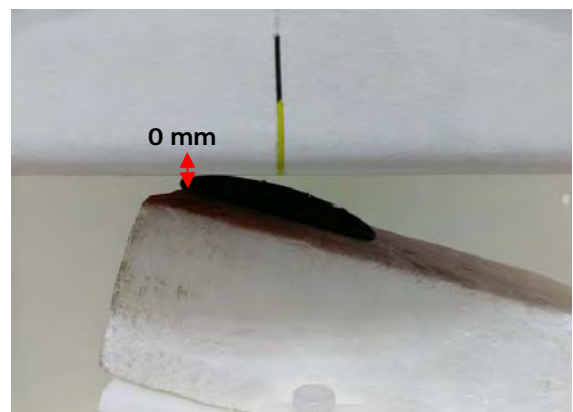


Fig.8 EUT Back side_curve (0mm) to flat phantom

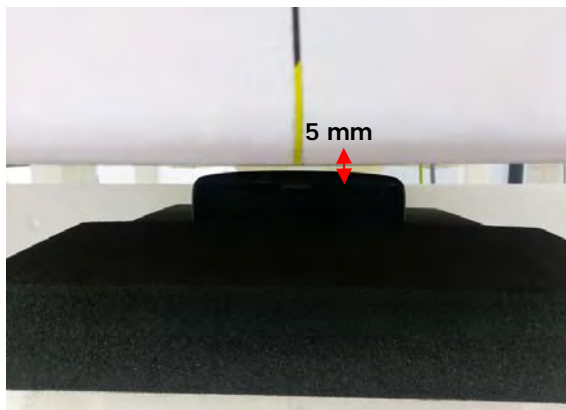


Fig.9 EUT Bottom side to flat phantom

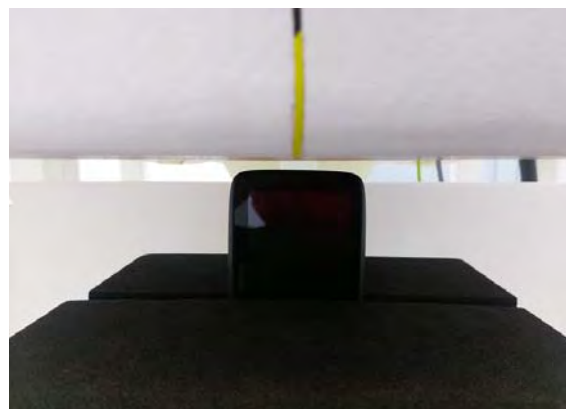
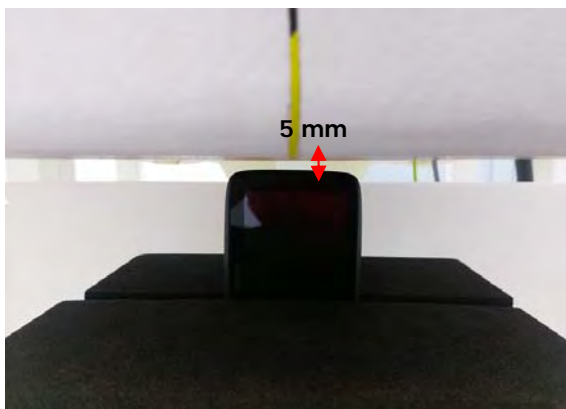


Fig.10 EUT Left side to flat phantom

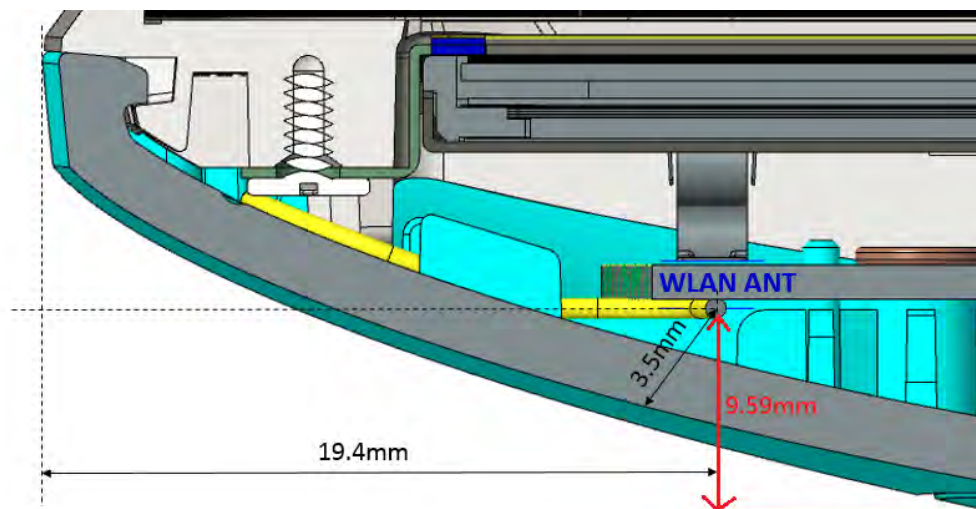


Fig.13 Cross section view

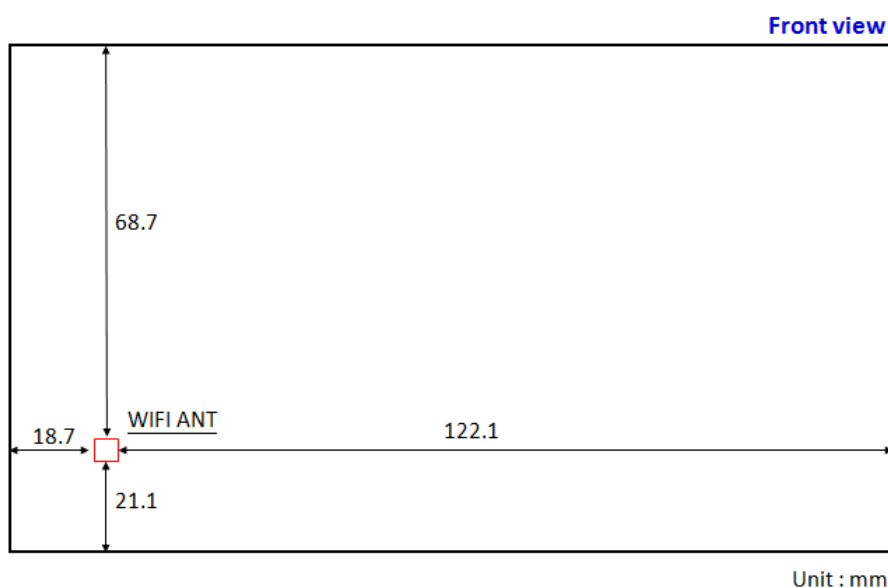


Fig.14 Antenna location (front view)
