8.6.4 Test Procedure

This test is required for any spurious emission that falls in a Restricted Band, as defined in Section 15.205. It must be performed with the highest gain of each type of antenna proposed for use with the EUT. Use the following spectrum analyzer settings:

The EUT was placed on a turn table which is 0.8m above ground plane.

Maximum procedure was performed on the highest emissions to ensure EUT compliance.

Span = wide enough to fully capture the emission being measured

RBW = 1 MHz for $f \ge 1$ GHz(1GHz to 25GHz), 100 kHz for f < 1 GHz(30MHz to 1GHz)



VBW ≥ RBW Sweep = auto Detector function = peak Trace = max hold

Follow the guidelines in ANSI C63.10-2013 with respect to maximizing the emission by rotating the EUT, measuring the emission while the EUT is situated in three orthogonal planes (if appropriate), adjusting the measurement antenna height and polarization, etc. A pre-amp and a high pass filter are required for this test, in order to provide the measuring system with sufficient sensitivity. Allow the trace to stabilize. The peak reading of the emission, after being corrected by the antenna factor, cable loss, pre-amp gain, etc., is the peak field strength, which must comply with the limit specified in Section 15.35(b). Submit this data.

Now set the VBW to 10 Hz, while maintaining all of the other instrument settings. This peak level, once corrected, must comply with the limit specified in Section 15.209. If the dwell time per channel of the hopping signal is less than 100 ms, then the reading obtained with the 10 Hz VBW may be further adjusted by a "duty cycle correction factor", derived from 20log(dwell time/100 ms), in an effort to demonstrate compliance with the 15.209 limit. Submit this data.

Repeat above procedures until all frequency measured was complete.







Test Model Spurious Emission in Restricted Band2310-2390MHz Channel 0: 2402MHz BLE_2M V











Test Model Spurious Emission in Restricted Band 2483.5-2500MHz Channel 39: 2480MHz BLE_2M V





8.8 ANTENNA APPLICATION

8.8.1 Antenna Requirement

Standard Requirement An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be FCC CRF Part15.203 considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. If transmitting antennas of directional gain greater than 6dBi are used, FCC 47 CFR Part 15.247 the power shall be reduced by the amount in dB that the directional gain (b) of the antenna exceeds 6dBi. The applicant for equipment certification shall provide a list of all antenna types that may be used with the transmitter, where applicable (i.e. for transmitters with detachable antenna), indicating the maximum permissible antenna gain (in dBi) and the required impedance for each RSS-Gen Section 6.8 antenna. The test report shall demonstrate the compliance of the transmitter with the limit for maximum equivalent isotropically radiated power (e.i.r.p.) specified in the applicable RSS, when the transmitter is equipped with any antenna type, selected from this list. If the transmitter employs an antenna system that emits multiple directional beams, but does not emit multiple directional beams simultaneously, the total output power conducted to the array or arrays that comprise the device (i.e. the sum of the power supplied to all antennas, antenna elements, staves, etc., and summed across all carriers or frequency channels) shall not exceed the applicable output RSS-247 Section 5.4 power limit.
